Women Economic Security Act (WESA) Complaint Activity Minnesota Department of Labor & Industry

The Division of Labor Standards and Apprenticeship is required under M.S. § 181.9435 to report to the Legislature annually on the type and number of employee complaints received by the Division under M.S. § 181.172 and M.S. § 181.939 through § 181.9436. This report provides the rate of resolution of complaints and the rate of repeat complaints registered against employers. The following represents data from the first 6 months of WESA enforcement, which by state law began July 1, 2014.

- For the period of January 1, 2014 June 30, 2014, under M.S. § 181.941 the Division could have received complaints for parental leave violations. The Division did not receive any parental leave complaints during that time.
- The Division does not have any additional statistics related to complaints under M.S. § 181.942 and § 181.943. These complaints are registered under M.S. § 181.941 related to leave.
