

Biennial Report to the Governor

MINNESOTA BOARD OF TEACHING

July 1, 2012 – June 30, 2014

Per Minnesota Statute §214.07, Subdivision 1, the Board of Teaching is pleased to submit the Biennial Report to the Governor. This report reflects Board of Teaching activities between July 1, 2012 and June 30, 2014.

Clause (a): GENERAL STATEMENT OF BOARD ACTIVITIES

In 1967 the Minnesota Legislature established the Professional Teaching Practices Commission to develop a code of ethics for teachers and “... to provide measures through which the observance of such standards by the members of the profession may be promoted and enforced.”

In 1973 the Legislature changed the name from the Professional Teaching Practices Commission to the Teacher Standards and Certification Commission and the duties of the Commission were expanded to resemble the current work of the Board of Teaching. Responsibilities that, until that time, had fallen under the purview of the State Board of Education were shifted to the Commission, including:

- issuance of teaching certificates
- promulgation of rules regarding qualifications of teachers, renewal requirements
- issuance of certificates to applicants trained in other states
- establish fees for certificates

The 1973 Legislature also expanded the Commission’s authority in disciplinary matters relating to violations of the Code of Ethics.

In 1976 the Legislature changed the Commission’s name to the Board of Teaching, and our identity as the Board of Teaching has remained for the last 38 years. The other significant change made by the 1976 Legislature was a change the state’s language from “certification” to “licensure,” and we continue to use the language of “licensure” today.

The Board of Teaching believes that its primary mission is to assure that Minnesota students are served by licensed teachers who are equipped to deliver effective instruction and meet the instructional needs of all learners. To that end, over the course of the last 40 years, the Board of Teaching has provided leadership in teacher education by establishing and maintaining licensure standards and requirements, approving institutions and licensure programs to prepare Minnesota teachers, and by establishing and enforcing the Code of Ethics for Minnesota teachers. The current authority and responsibilities of the Board of Teaching are delineated primarily in Minnesota Statutes §122A.05 – §122A.09, §122A.18, §214, and Minnesota Rules, Chapters 8700, 8705 and 8710.

The Board of Teaching provides leadership for strengthening teacher preparation to ensure that the state has well-prepared, effective teachers. Among its primary duties, the board establishes the standards and practices that serve as the basis for Minnesota’s teacher preparation institutions and licensure programs, approves institutions and organizations that seek to deliver teacher preparation, approves licensure programs, and oversees the licensure testing program.

The Board consists of 11 members appointed by the Governor; appointments and Board member terms are subject to the parameters set forth in Minnesota Statute §214. In accordance with the Board of Teaching’s by-laws, the Board has the following standing committees:

- Executive Committee – Chair, Vice Chair, and two additional elected members of the Board
- Disciplinary Committee
- Legislative Committee

- Policy Review Committee
- Standards and Rules – Representatives from 12-15 stakeholder organizations

Additionally, working groups are frequently convened to solicit targeted stakeholder input and to assist with specific Board-designated initiatives.

The Board of Teaching believes that its work is critical to ensure that teachers who earn a Minnesota teaching license are well prepared and, once licensed, that teachers uphold the Code of Ethics for Teachers (Minnesota Rule 8700.7500). State law clearly sets forth our mandate in this area:

1. Minnesota Statute §122A.09, Subdivision 1, provides that “The Board of Teaching must develop by rule a code of ethics covering standards of professional teaching practices, including areas of ethical conduct and professional performance and methods of enforcement.”
2. Minnesota Statute §122A.20, Subdivision 1, provides grounds for suspension, revocation, or denial of licenses.

The Board is deeply committed to maintaining the public trust and ensuring that teachers who hold a Minnesota license are safe, trustworthy, and represent no threat of harm in any way to our students. As such, the Board’s disciplinary work is among our most challenging and important responsibilities.

The Minnesota Board of Teaching has authority to take disciplinary action against teaching licenses in cases where teachers are alleged to have violated either the Board’s statute (122A.20) or the Code of Ethics for Minnesota Teachers (Minn. Rule 8700.7500).

Complaints can be filed by school districts, parents, former students, law enforcement agencies, interested citizens, and anyone else who has concerns about the conduct of a particular teacher. Anonymous complaints are not accepted. Once a complaint is filed and it is determined that there is jurisdiction for the Board, in accordance with Minnesota Statutes, and with support from the Office of the Attorney General’s office, the Board conducts further inquiry and an investigation regarding the complaint. The teacher is notified of the allegations and given an opportunity to respond.

All of the obtained information from the inquiry is presented to the Board’s disciplinary committee, which consists of two licensed and practicing teachers who serve on the Board. They review the information available and make a recommendation on what action, if any, should be taken against the teacher’s license. When it is determined that grounds exist to suspend or revoke a teacher’s license to teach, the Board must consider suspending or revoking, or decline to suspend or revoke the teacher’s license. If a suspension or revocation is recommended, the teacher can contest that recommendation and it may result in a hearing before an Administrative Law Judge. Once the entire process is completed, any disciplinary action taken by the full Board becomes public.

MN BOARD OF TEACHING MISSION

The purpose of the MN Board of Teaching, an autonomous body, is to establish and maintain standards for a quality teacher licensing system for MN public schools.

MN BOARD OF TEACHING VISION

The vision of the MN Board of Teaching will be to maintain high licensure standards while providing flexibility in the licensing process to assure that public school students have fully licensed teachers.

According to the provisions of Minnesota Statutes Section 214.04, the Board has, since 1976, entered into an annual agreement for provision of services with the Department of Education. Through this Agreement, the Board has established an efficient, effective, and fiscally responsible procedure to receive necessary services and staff assistance to carry out the statutory duties and responsibilities assigned to the Board.

Additional notes:

1. Because of the nature of our disciplinary process it is difficult to estimate how many cases will result in a contested case hearing through the Office of Administrative Hearings. The cost of these cases can range from \$1,000 to over \$10,000 depending on the duration and location of the hearing as well as other variables such as expert witnesses, transcription, etc. We believe that it is critical to maintain a reserve for these cases, but makes budget planning difficult.
2. The Board of Teaching generates non-dedicated revenue from teacher licensure fees set by the Board. This revenue returns to the General Fund to recover the cost of the operations of the Board of Teaching. It also includes the operations of the Educator Licensing Team of the Department of Education, which issues, as required by statute, all licenses granted under the authority of the Board of Teaching. Both activities receive General Fund appropriations.

- The data provided here includes licenses issued by the Board of School Administrators: Superintendents, Principals, Special Education Directors, and Community Education Directors; it also includes Short-call Substitute teaching licenses issued.**
- For the purpose of the data provided in the table above, "Endorsement" means a license that is added to an existing license. For example, if a licensed Chemistry teacher adds a Physics license, the Physics license would be considered an "endorsement."

Clause H: Administration of Examinations by the Board

Legislation enacted in 1985 required the Minnesota Board of Teaching to adopt examinations for assessing skills in reading, writing, and mathematics for teachers licensed under its authority and to adopt rules for implementation and ongoing administration of the examinations.

In addition, effective September 1, 2001, examinations in content and pedagogy were adopted as requirements for first time applicants for teacher licensure in Minnesota. Minnesota licensed classroom teachers adding a new licensure field must take the specified content test but are not required to take a pedagogy test.

Beginning September 1, 2010, the Board's adopted testing series has been the Minnesota Teacher Licensure Examinations (MTLE). With the exception of the World Language and Culture tests (in French, German, Mandarin Chinese, and Spanish), all MTLE are computer-based tests. When the MTLE program launched there were 8 testing sites across the state and the tests were offered 6-8 days each month. The number of testing sites and dates has grown substantially since September 2010; by the fall of 2012 there were 21 testing sites across the state. Additionally, the testing windows were increased to two weeks per month, and a subsequent change was made in September 2012 whereby computer-based tests are now available by appointment, year round, Monday through Saturday (excluding holidays) at the testing sites. The MTLE are available outside Minnesota at over 200 testing sites across the country and around the world.

Clause I: The number of persons examined by the Board.

A full technical report containing data from 2012-2013 and from 2013-2014, specific to each test field is attached to this report. For each test, the report provides the percent passing by gender, ethnicity, and in total. Cumulative retake data is also provided for each test field. Data is not available specific to age categories or states of residency.

Clause K: The number of persons not licensed or registered by the Board after taking the examinations.

The Board does not have a reliable way to provide this data. Testing requirements represent just one part of the licensing process in Minnesota. Typically applications are not received unless all testing requirements have been met, and there may be other reasons that a license is not issued (e.g., an issue with the background check or a teacher licensed in another state whose licensure is not essentially equivalent to Minnesota's requirements).

Clause L: The number of persons not taking examinations who were licensed by the Board or who were denied licensing with the reason for the licensing or denial thereof.

Under Minnesota Rule 8710.1250, a Temporary Limited License may be issued to an individual on the basis of having at least the equivalent of a minor in the licensure field requested and a statement of need by a Minnesota school district that is unable to find a licensed teacher for the teaching position. Testing is not required for these individuals.

The Temporary Limited License is also available for individuals prepared in a Minnesota teacher preparation program who have not met the testing requirements.

Clause M: Persons previously licensed or registered by the Board whose licenses or registrations were revoked, suspended or otherwise altered in status, with brief statements of the reasons for the revocation, suspension or alteration.

The Board of Teaching has responsibility for ensuring that individuals granted and holding a Minnesota teaching license adhere to a high standard of conduct. The public rightly expects that licensed teachers are appropriately qualified and do not present a threat of any kind to the safety and well-being of our Minnesota students. To that end, both Minnesota statute and rule govern our disciplinary obligations and processes.

PREFACE

Evaluation Systems group of Pearson prepared this document for the Minnesota Board of Teaching (BOT). It provides information about the Minnesota Teacher Licensure ExaminationsSM program (MTLESM).

The first section of the report describes the purpose, structure, and composition of the MTLESM , including a listing of the tests administered during the 2012–2013 program year. It also includes information regarding enhancements that Pearson has implemented in an effort to continually improve the MTLESM .

The second section of the report provides pass rate information on candidates who took one or more MTLESM examination during the 2012–2013 program year.

Section I: Purpose of the Minnesota Teacher Licensure ExaminationsSM

Introduction

Evaluation Systems group of Pearson has developed the Minnesota Teacher Licensure ExaminationsSM (MTLESM) program on behalf of the Minnesota Board of Teaching (BOT). The main purpose of the MTLESM program is to assist the BOT in identifying those candidates who have the basic skills, pedagogical, and content area knowledge needed to obtain an initial Minnesota teaching license. Examinations for licensure are required by Minnesota Rules Chapter 8710, and the MTLESM tests are based on and aligned to the Minnesota Teacher Standards.

The MTLESM program became operational in September 2010 and includes basic skills, pedagogy, and content area tests. Please refer to the following page for a complete list of the tests available for administration during the 2012–2013 program year. Each test in the MTLESM program was developed in accordance with the practices recommended by the *Standards for Educational and Psychological Testing* (AERA, APA, & NCME, 1999), which require a clear definition of content domain and a rationale to support a claim that the knowledge and skills being assessed in a licensure test are required for credential-worthy performance. To verify that the MTLESM reflect the knowledge and skills essential to an entry-level Minnesota educator, Pearson used the Minnesota Teacher Standards to draft test frameworks for each test field. Minnesota educators and educator preparation faculty reviewed test materials to confirm that they reflect the knowledge and skills a Minnesota educator must possess to receive a license in a given field. Minnesota educators also provided recommendations used by the BOT to establish a passing standard for each test.

Composition of the MTLESM Program

Currently, the MTLESM program includes 37 examinations for the fields listed on the following page. The major features of the MTLESM test designs are as follows:

- All examinations are offered on computer.
- Most examinations include two subtests that cover the range of knowledge and skills needed for entry-level teaching in Minnesota.
- The MTLESM Basic Skills and Elementary Education examinations each include three subtests.
- Most of the MTLESM tests consist of selected-response (multiple-choice) items only.
- The MTLESM Basic Skills Writing subtest consists of selected-response (multiple-choice) and two constructed-response items.

- All the World Language Examinations (with the Exception of Chinese (Mandarin)) consist of both selected-response (multiple-choice) and constructed-response items; the Chinese (Mandarin) World Language Examination consists of constructed-response items only.

Program Enhancements

Pearson continually works with the Board of Teaching to evaluate and improve the quality of the MTLESM program. Since the beginning of the program, the following enhancements have been implemented.

Re-development of MTLESM tests. Shortly after the first administrations of the MTLESM tests in September 2010, the Board of Teaching requested the redevelopment of the Vocal and Instrumental Music Subtest 2. Pearson worked with the BOT to create separate subtests for Instrumental Music and Vocal Music. In December 2010, Pearson and the Board of Teaching convened a panel of music educators to provide a final determination on the assignment of items to the two revised item banks. Based on those Minnesota educator recommendations, a separate Vocal Music Subtest 2 test was created along with a separate Instrumental Music Subtest 2. A passing score review meeting was held on June 8, 2011. The first administration of the new Vocal and Instrumental subtest 2 tests took place in September 2011.

In spring 2012 the Board of Teaching requested the redevelopment of the Special Education Core Skills (Birth to Age 21) examination to align the tests with newly developed Minnesota Special Education standards. In December 2012, Pearson and the Board of Teaching convened the Minnesota Bias Review Committee and a Minnesota Special Education Content Advisory Committee to review a draft test framework and draft test items for the re-developed examination. Pearson revised the draft test framework as directed by Minnesota educators and then conducted a Content Validation Survey of the draft test framework with Minnesota teachers and teacher educators in

spring 2013. Pearson revised the draft test items as directed by the Minnesota teachers and conducted a pilot test of the test items in Minnesota during spring and summer 2013. A passing score review meeting was held in Minnesota in fall 2013. The revised Special Education Core Skills (Birth to Age 21) examination became available for administration beginning in January 2014.

Adjusted testing time. Pearson conducted a series of analyses to examine the amount of time used by MTLESM examinees. As a result of this analysis, the testing time for five MTLESM subtests (Basic Skills—Writing, Middle Level Mathematics Subtest 1, Middle Level Mathematics Subtest 2, Physics Subtest 1, and Physics Subtest 2) was increased by 15 minutes, effective September 2012.

Data Support for BOT program accountability system. Pearson, working with the BOT and the Minnesota Department of Education, developed and implemented a system to provide data on an annual basis that will support Minnesota's new teacher preparation program accountability system. This system will allow data to import directly rather than each preparation program manually entering testing data for their program.

Conducted Passing Score Review Meetings. In February 2013, under the direction of the Board of Teaching, Pearson conducted passing score review meetings for six MTLESM examinations (Earth and Space Sciences; Middle Level Mathematics; Physics; World Language and Culture: French; World Language and Culture: German; World Language and Culture: Spanish).

Minnesota teachers and teacher educators participated in a passing score review meeting. A modified Angoff (Angoff, 1971) procedure was used to gather passing score ratings for the items included on each subtest. Teachers and teacher educators provided three rounds of passing score ratings based on their professional judgment, their knowledge of the test field, their understanding of the qualifications of prospective educators, the content of the test items, and candidate performance on the examination.

Pearson calculated a recommended passing score for each subtest included in the examination based on panel member recommendations and provided the recommendations to the Board of Teaching. The Board of Teaching determined the passing score for each subtest.

Implemented Revised Passing Scores. As directed by the Board of Teaching, Pearson implemented the approved passing scores for six MTLESM examinations (Earth and Space Sciences; Middle Level Mathematics; Physics; World Language and Culture: French; World Language and Culture: German; World Language and Culture: Spanish) that were reviewed by Minnesota educators in February 2013. Pearson notified candidates affected by the revised passing scores, provided the Board of Teaching with a list of candidates affected by the implementation of the revised passing scores, and provided each institution with a list of students from their programs affected by the implementation of the revised passing scores.

In December 2013, as directed by the Board of Teaching, Pearson implemented revised passing scores for 54 MTLESM subtests. The BOT directed Pearson to implement the panel-based passing score recommendation from the 2010 Passing Score Review meetings. Pearson provided the Board of Teaching with a list of candidates affected by the implementation of the revised passing scores for these 54 subtests.

Implementing computer-based testing for World Language and Culture subtests. Pearson began administering the World Language and Culture subtests on computer beginning in fall 2013. As a result, increased testing opportunities are available for candidates taking these tests.

Enhancements to Assist Candidates. Pearson continually works with the Board of Teaching to examine program policies and materials and provide additional services and resources for candidates taking MTLESM examinations.

- **Candidate preparation.** Since program implementation, Pearson has added the following candidate preparation resources to the MTLESM program website.
 - **Online tutorials.** Candidates have access to two tutorials. One tutorial allows candidates to preview the on-screen tutorial that is provided at the testing center. It includes information about how to navigate through a test, select answers to a test, and end the test. A downloadable interactive tutorial is also provided. This tutorial allows candidates to review and practice the functionality of the computer-based environment, including typing in an essay box, using an on-screen calculator, and entering special characters.
 - **Test preparation video.** Candidates can view an 8 minute test preparation video that provides an overview of test preparation and test taking strategies. It describes strategies for preparing for the subtests including how to effectively use the test frameworks and other available preparation materials and resources.
 - **Test preparation worksheets.** Candidates can download and complete test preparation worksheets that enable them to evaluate their level of preparedness for the subtests. The worksheets describe how to map the test framework to the curriculum associated with each subtest.
 - **Expanded study guides.** Pearson continues to develop expanded study guides for the MTLESM program. The expanded study guides provide sample multiple-choice questions with explanations of the correct response and other helpful study tools. By fall 2013 expanded study guides were available for virtually all MTLESM test fields¹.

¹ World Language and Culture: Chinese (Mandarin) includes all constructed-response items. An Expanded Study Guide is not available for this examination.

- ***National Evaluation Series expanded study guides and diagnostic practice tests.*** Additional fee-based study materials originally developed for Pearson's National Evaluation Series of tests have also been made available to MTLESM candidates. Pearson conducted a crosswalk of the content of the National Evaluation Series materials to verify that the content was generally aligned with the MTLESM.
- ***Basic Skills Practice Test.*** In March 2013, explanations of correct responses to multiple-choice items and analyses of sample responses to the written assignments were added to the online practice test. Candidates can review the correct response rationales to the multiple-choice items and review analyses of sample responses to the writing assignments that were rated at each score point.
- ***Candidate Registration and Administration.*** Since program implementation, Pearson has implemented the following enhancements to candidate test registration and administration.
 - ***Streamlined registration process.*** In September 2011, Pearson improved the candidate registration experience by providing the ability to register to test and schedule a test appointment at the same time.
 - ***Expanded options for documenting need for Alternative Testing Arrangements.*** Pearson worked with the Board of Teaching to implement additional options for candidates to provide documentation of the need for Alternative Testing Arrangements. These options were available beginning in fall 2013.
 - ***Increased testing locations.*** MTLESM tests are available at Pearson testing locations in Minnesota and world wide. Since the MTLESM became operational in September 2010, Pearson has continued to add test locations in Minnesota. As of August 2013, the MTLESM tests are available at 21 locations throughout the state.
 - ***Increased testing opportunities.*** To provide additional opportunities for candidates to take MTLESM tests, Pearson increased the number and length of the testing windows for the program. Computer-based tests are now available by appointment, year round Monday through Saturday (excluding holidays) at test centers across the state and nationwide for virtually all tests².
 - ***Adjusted retake policy.*** The retake policy refers to the amount of time that candidates who do not pass a subtest must wait before they can retake the subtest. The original retake policy was set at

² World Language and Culture subtests, which include constructed-response components, are available periodically throughout the year.

90 days. Upon the recommendation of the BOT, it has been changed and is now set to 45 days.

- ***Provide preliminary passing status.*** By the end of 2012, candidates began to receive a print out of their preliminary, unofficial passing status after they completed their test. This information is provided for multiple-choice only tests.
- ***Free re-tests.*** In summer 2012, Pearson implemented a system that provides free re-tests to candidates who fail a subtest at least five times. There is no limit on the number of free re-tests that are provided to candidates.
- **Resources for understanding candidate scores on Basic Skills examination.** Pearson worked with the Board of Teaching to expand the information that is included with candidate eReports.
 - ***Expanded descriptions of performance indices.*** The description of performance indices on candidate eReports was expanded to provide additional information concerning the relationship between the candidate's performance and the passing standard.
 - ***Detailed performance analysis.*** Beginning in early 2014, candidates were provided additional information on their eReport regarding their performance on each test objective included on the Basic Skills subtests.

Resources to Assist Faculty. Pearson has worked to provide additional resources and support for faculty at Minnesota educator preparation programs.

- **Increased access to preparation materials.** Faculty are able to receive a free trial of the fee-based, expanded study guides so they can review them prior to purchase to ensure that the product will meet their needs. In addition, educator preparation programs may purchase bulk orders of the fee-based preparation materials at discounted prices.
- **Additional score reports.** Institutions now receive annual information regarding their institution's performance and statewide performance on each test objective included in each subtest (as long as at least 10 candidates take a subtest).
- **ResultsAnalyzer trainings.** Evaluation Systems invited faculty at Minnesota educator preparation programs to participate in a webinar to answer questions about ResultsAnalyzer and provide additional training in the use of the tool. A series of three webinars was initially provided for faculty. Additional trainings were offered as requested by the BOT.

Section II: Findings: September 2012–August 2013

The following reports are provided for the MTLESM program.

- **Percent Passing each Subtest by Gender and Ethnicity.** The report provides information on the number of candidates passing by gender and ethnicity.
- **Cumulative Retake Analysis.** This report provides information on pass rates by test attempts. For each subtest information is provided for all candidates. The information includes the number of candidates who tested and the number passing on their first attempt, their second attempt, and their third or greater attempt.

Interpretive Cautions. The notes below are an integral part of the accompanying tables.

- Pass rate tables include data from September 3, 2012, through August 31, 2013.
- Mean SS=Mean Scaled Score: Scaled scores are from 100-300. An examinee must receive a scaled score of 240 or higher to pass the subtest.
- Examinees whose data are presented in this document may not reflect the same performance as that of examinees who will take these tests in the future.
- Extreme caution should be used in interpreting data for small numbers of examinees. The examinees for whom results are presented in this document may not reflect the same proportion of all the types and capabilities of examinees in the population who will take the tests in the future.
- Caution should be used in interpreting pass rate data by institution. These data are based on examinee self-reported responses to the optional test registration question, “where have you received the majority of your educator preparation training.”
- Pass rate data are based upon candidates’ best attempts.
