
# EAST CENTRAL REGIONAL DEVELOPMENT COMMISSION

# Minnesota Association of Development Organizations (MADO):

ECRDC is working with MADO to develop a strong statewide development strategy called Develop MN. This document will highlight common development opportunities and identify strategies that will accelerate business growth and job creation in rural MN. The group has built consensus around four areas and has been collecting and reviewing statewide data regarding the changes in these areas.



Economic Development Partnerships: The ECRDC partners regularly with the following organizations: Central MN Workforce Investment Board, Central MN Housing Partnership, Minnesota Housing Partnership, Lakes and Pines, GPS 45:93, Minnesota Association of Development Organizations (MADO), and City / County Administrators & Economic Development Professionals. Example of positive results gleaned from these meetings include: regional marketing initiatives, regional housing study and a regional housing website, business development in local communities.







Revolving Loan Fund (RLF): The ECRDC RLF provides gap financing for businesses looking to open, expand or relocate to Mille Lacs, Pine, Isanti, Chisago & Kanabec Counties. The ECRDC employs the RLF as a tool in recruiting new businesses, maintaining and expanding existing ones, creating and retaining good paying jobs and strengthening the economic base of East Central Minnesota. Currently there are 11 active loans to small businesses in the region and approximately \$80,000 is still available to lend. Loan amounts typically range from \$10,000 to \$60,000 with terms up to 7 years. Informational brochures were recently updated and signs promoting the RLF program are often placed at benefitting businesses. # St. Croix Scenic Byway

The 124 mile St. Croix Scenic Byway route passes through three Minnesota counties: Washington, Chisago and Pine. Today, the cities along the route offer visitors unbeatable scenery, a range of activities and a variety of businesses to explore.

Robert Voss, Executive Director and Jennifer Russell, Economic Development Director reviewed and assessed the St. Croix Scenic Byway plan and developed a taskforce of local government officials and regional stakeholders.

A series of meetings located along the byway were conducted to obtain input on potential projects, discussion of the Transportation Alternative Program (TAP) its purpose and intent, and characteristics of the byway. The taskforce determined that there was an abundance of potential projects that could be executed to emphasize the amenities along the St. Croix Scenic Byway. The projects that were selected showed the most interest from the taskforce and were to increase recognition and awareness of the St. Croix Scenic Byway. Project ideas consisted of a round-a-bout at the intersection of State Highway 95 and Highway 8 near

the Franconia Sculpture Park, improvement on a current scenic overlook and the trail connection between Taylors Falls CBD and Interstate Park.





GPS 45:93 Collaboration: The ECRDC continues its economic development partnership with the GPS 45:93 in attracting high technology firms to Region 7E. GPS 45:93 is a regional economic de-

velopment consortium strategically located along Interstate 35 between Minneapolis/St. Paul and Duluth. This makes it an ideal location for those companies serving the Twin Cities and Duluth area.

The mission of GPS 45:93 is to better position the region to attract high wage, technology based jobs, collaborate on business retention and expansion and encourage entrepreneurial activity.

The virtual business incubator was opened in 2014 is located at Pine Technical College in Pine City. The purpose is to connect local entrepreneurs with the kind of services they need to grow their businesses. GPS 45:93 is working with Chamber of Commerce, banks and other local partners to support businesses in the region

**SCORE:** The ECRDC continues to market their satellite office of the St. Cloud chapter of SCORE. SCORE provides one-on-one counseling to entrepreneurs and those wanting to start a business on a variety of topics free-of-charge. SCORE also facilitates business related

educational classes to assist entrepreneurs with sharpening their business skills.

# RMAP Rural Microenterprise Assistance Program

Micro Loan Fund: The ECRDC continues its partnership with the Region Five Development Commission based in Staples, MN, in creating and microlending program to serve the ten counties served by our two Regional Development Commissions. This micro-loan fund was created by the USDA Rural Development's Rural Microentrepreneur Assistance Program (RMAP). This micro-loan fund nicely complements our EDA Revolving Loan Fund, Currently, there have been three loans approved and closed on from this fund in Region 7E.



Comprehensive Economic Development Strategy (CEDS): The ECRDC is in the final year of implementing the 2011-2016 CEDS. The CEDS tracks the region's demographic trends and economic conditions, identifies weaknesses and threats, and identifies strategies that have the potential to help mitigate roadblocks to the region's prosperity. A valuable planning process for regional economic development takes place in the development of a CEDS. An approved CEDS is required to maintain East Central Minnesota's designation as a federal Economic Development District.

Economic Development Districts (EDDs) are eligible to apply for various funding opportunities available through U.S. Economic Development Administration (EDA). For example, the ECRDC accesses the Partnership Planning grant to develop and implement the regional CEDS. More importantly, our local units of government may include regionally significant projects in the CEDS. Eligible projects may apply for

federal funding through EDA's Public Works grant program on a competitive basis. The Public Works program seeks to empower distressed communities to revitalize, expand, and upgrade their physical infrastructure to attract new industry, encourage business expansion, diversify local economies, and generate or retain long-term, private sector jobs and investment.

The ECRDC begins the development of the 2017-2022 CEDS during our next fiscal year and it must be completed by December 2016. Over the next several

months, the ECRDC will seek input from our regional stake-holders and local units of government to ensure the new CEDS reflects the economic development needs in East Central Minnesota. The current CEDS can be found on our website at www.ecrdc.org.

The East Central Resource Center (ESCRC) completed its final year of operation on December 31, 2014. The mission of the ESCRC was to "Foster development of and access to resources for older adults in East Central Minnesota". The ESCRC served thousands of older adults, their families, the communities where they reside, and the providers of the services and programs they access for over a decade.

The ESCRC accomplished this by implementing three major program areas – Caregiver Consulting, Information Referral & Assistance, and Program Development & Coordination. The Commission was able to make these programs possible, in part, through a contract with the Central MN Council on Aging who is responsible for administering funding from the federal Older American's Act.

Caregiver program helped caregivers manage and live their life while caring for another person by offering expert advice, assisting with the development of unique personal action plans, and connecting caregivers to community resources. Each year approximately 300 caregivers were served and over 2,000 hours of direct client time was provided.

Program Development & Coordination (PD&C) program worked through various senior service provider networks in each county as a venue to discuss possible partnerships and communicate about ways to develop new services to better serve the older adult population. The PD&C program also was instrumental in providing agencies and businesses access to possible funding for these initiatives through the State of Minnesota's Community Services/Service Development (CS/SD) program which is administered through the State's Department of Human Services.

Information, Referral, & Assistance program was delivered through a statewide network known as the Senior LinkAge Line®. The Senior LinkAge Line® is a telephone based information and assistance service. Staff provided one-on-one assistance with accessing prescription drug programs (including Medicare Part D), understanding medical bills, insurance claims, and Medicare coverage. Annually, this program responded to approximately 1,200 face-to-face clients and over 8,500 phone clients.



Fortunately, CMCOA has found a way to continue the delivery of these valuable services in East Central Minnesota on their own or through contract arrangements with other non-profit organizations utilizing former ESCRC staff. Commission wishes to thank our many ESCRC volunteers; Caregiver Consultants Jayne Mund, Lynda Hayek, and Anita Sparks; Senior Resource Specialists Amy Tvedt and Frances Nelson; and Director Penny Simonsen for their many years of outstanding and dedicated service to the ESCRC programs!

## **Key Findings for Minnesota**

- The number of Minnesotans turning 65 in this decade (about 285,000) will be greater than the past four decades combined.
- Around 2020, Minnesota's 65+ population is expected to eclipse the 5-17 "K-12" population, for the first time in history.
- The total number of older adults (65+) is anticipated to double between 2010 and 2030, according to our projections. By then, more than 1 in 5 Minnesotans will be an older adult, including all the Baby Boomers.

# COMMUNITY DEVELOPMENT

## **Safe Routes to School**

Safe Routes Minnesota provides funding to community and school groups to make improvements to the routes your children use to walk and bike to school and get the exercise they need.



In order to increase opportunities for children to walk and bicycle to school safely, the 2005 federal transportation bill, SAFETEA-LU, provided funding for Safe Routes to School in all 50 states. The federal Legislature created SRTS, in part, to help reverse the alarming nationwide increase in childhood obesity and inactivity. The program has numerous benefits to local communities including reducing traffic congestion, improving air quality and helping kids arrive to school focused and ready to learn.

Safe Routes to School (SRTS) Planning took place in both Hinckley and Kanabec County Schools (Ogilvie and Mora) included parent surveys, community walk and bike audits and subsequent data collection into the national database. The planning processes ask for several meetings, with specific agendas and deliverables which support communities

and school districts embracing safety and health benefits for those who walk or bike.

In addition to the SRTS planning activities, Mini Grants were awarded to Kanabec County Schools (\$4,000) and North Branch Schools (\$504) to secure items supporting their SRTS initiatives.





## **Hazard Mitigation**

Mitigation significantly reduces or permanently eliminates future risk to lives and property from natural hazards, by community planning and implementing projects. The purpose of hazard mitigation assistance is to reduce the impact of

life and property due to natural disasters and develop resilient communities by planning and projects. Per the Stafford Act, states must have an approved plan to be eligible for public assistance and hazard mitigation assistance. The Minnesota All-Hazard Mitigation Plan requires local mitigation plans, approved by FEMA, from counties, cities, other government units and private non-profits to be eligible for hazard mitigation assistance funding.

Hazard mitigation planning processes includes: 1) organizing resources; 2) hazard identification; 3) risk assessment; 4) structural vulnerability; 5) capability assessment; 6) mitigation actions; and 7) plan maintenance.

Isanti County completed their All-Hazard Mitigation planning process, and now have a FEMA approved plan. The ECRDC provided the planning function for the development of the plan.

Kanabec and Mille Lacs County contracted with the ECRDC to provide the planning function for the development of their plans to be completed in 2016.

# **Blandin Broadband Initiative**

The Blandin Foundation's Broadband Community Initiative, an opportunity to come together to promote and encourage expansion of internet services in the "Central Woodlands" area (northern reaches of Mille Lacs, Kanabec and Pine counties plus southern Aitkin county). By receiving the designation as a Blandin Broadband Community allows opportunities for funding specific to internet needs. The ECRDC received \$1,000 from Blandin to start the process, through kick-off events - one in Isle and one in Sandstone. Good representation and good project ideas came from the gatherings in late February/early March. This work lead to the ECRDC making application for a Blandin Broadband project, which we received \$10,000.

The ECRDC did apply to Blandin to conduct an inventory and offer an assessment of existing broadband services in the Central Woodlands area. We were selected, and that work has begun by Simonsen. Other applicants for funding include Depot Studios in Isle, Audubon Center of the North-

woods, Aitkin County and Mille Lacs County Economic Development office, and Isle Public Schools. A steering committee led by the ECRDC reviewed the project ideas and recommended to Blandin several projects for future funding.



# **TRANSPORTATION**



# Transportation Funds/ATP Process

The ECRDC assists the Minnesota Department of Transportation (MnDOT) in implementing the Federal

Transportation Bill in Region 7E. The ECRDC conducts a two-year solicitation. We successfully conducted a local project solicitation last year, so this fiscal year we implemented the recommendations approved by the ECRDC. Projects brought forward for the State Transportation Improvement Program (STIP) included transit replacement vehicles in Chisago, Isanti, Kanabec and Mille Lacs Counties as well as road projects in Kanabec and Mille Lacs counties.

We are pleased to also report that improvements to State Hwy 70 in Pine County became a reality this year. State Hwy 70 is a critical river crossing between Minnesota and Wisconsin.

#### **NLX Development**

ECRDC continued to support efforts and participated in meetings related to Northern Lights Express passenger rail linking the Twin Cities to Duluth.





# Scenic Byways Planning

This past year two Scenic Byways projects were implemented in Re-

gion 7E. Staff facilitated planning projects for the Veterans Evergreen Memorial Scenic Byway in Pine County and St. Croix Scenic Byway in Chisago and other counties. The project served to make local communities aware of potential funds to improve their Byways.

### **Statewide Projects**

Working with MnDOT, Transportation Staff successfully conducted a functional classification review and submitted recommended changes to DOT. Several adjustments were made. The Functional classification of roads establishes a hierarchy of roads and is used in determining eligibility for federal funding.

ECRDC staff also is participating on a Traveler Safety committee related to the Statewide Multimodal Transportation Plan.



# Transportation Advisory Committee (TAC)

Region 7E is fortunate to have an excellent Transportation Advisory Committee which provides recommendations to the full ECRDC regarding transportation issues as well as funding for projects.

The TAC is comprised of county engineers, state-aid cities, township, local transit, and MN/DOT representatives. The TAC also provides a forum for regional transportation issues.

# ISANTI COUNTY TOWARD ZERO DEATHS



Traffic Safety in Region 7E

The ECRDC implemented traffic safety measures in two counties during the past year. The Isanti County Toward Zero Deaths Program was established more than 10 years

ago while the Kanabec Safe Roads Program has been operating for the past five years. This past year mock crashes were conducted in each county with the cooperation of the local high schools. These programs were well done and provided a vital message to not drink or text while driving. Hundreds of students in each area participated in the event.

The Isanti County Safe Cab continued to operate successfully. Two service providers make available the rides for local liquor serving businesses. To date the program has given more than 700 rides to well over 13,000 persons. This program has also likely contributed to the reduced DWI arrest rate in Isanti County.

Traffic safety applications for TZD funds were submitted to Dept of Public Safety for three counties in Region 7E. We are pleased to report that in additional to Isanti and Kanabec Counties, ECRDC will coordinate a safe roads program in Mille Lacs starting October 1, 2015.



### **Isanti County TZD**

The ECRDC has coordinated the Isanti County TZD program for more than ten years. One of the significant programs developed during this time was the estab-

lishment of a viable Safe Cab service for the community. Safe Cab was begun in 2005 with few rides given. But now has become a significant part of the reduction of DUI arrests in Isanti County. In fact, the Isanti County Safe Cab program has become a model for other rural counties. Isanti TZD has now helped to develop similar programs in neighboring counties such as Wright, Pine, Kanabec, and Sherburne. Minnesota Safe Ride, Inc. now administers Safe Cab. To date, Isanti County Safe Cabs have provided more than 7,000 rides to over 13,000 persons.

# **Kanabec County TZD/Safe Roads**

This year, as in all grant years, our major focus was the coordination of a coalition of the "4Es, (Enforcement, Engineering, Emergency Services, and Education), to analyze and respond to local concerns in traffic safety. This has been done by: providing educational materials to the public via the newspaper, radio interviews, and assorted educational resources; assisting Ogilvie High School with parent education for the Driver's Education class; having two "I Got Caught" seat belt events, and providing a Mock Crash for all high school students in the county, followed by an impact presentation by a father whose daughter was in a fatal crash while texting.



Matt Logan, a parent of a teenage girl who died as a result of distracted driving, encouraged the students to make wise choices while driving.


Matt lost his daughter in 2012 when her car ran into the back of a stopped school bus just after texting a message.




