Mr. President and Members of the Minnesota State Dental
Examining Association:

During the interim of the Board's last report which was in
February, 1927, the new State Dental Law passed by the legis-
lature became effective January 1, 1928, reducing the personnel
of the board from six to five members; the reduction being made
by the expiration of the term of Dr. J. B. Kohagen of Duluth

January 1, 1928.

Three meetings have been held for the examinations of ap-
plicants for licenses and the transaction of such other business
as might regularly come before the board.

The election of officers was held in December, 1927 at which
time Dr. C. E. Gerretson of Willmar was elected President and
Dr. F. E. Cobb of Minneapolis as Secretary for the year of 1928.
No complaints warranting court action having been filed with
the Secretary during this time for violation of the law regulating
the practice of dentistry in this state, no prosecutions have been
necessary.
