During the interim of the last report of the Board which was made March 1, 1929, three meetings have been held for the examination of applicants for license and the transaction of such other business as might regularly come before the Board.

Three complaints warranting court action for violation of the law regulating the practice of dentistry in this state were tried in the Courts of Minneapolis and were successfully prosecuted.
