All funds are deposited with the State Treasurer, deposit slips are made out in triplicate and have the Doctors and Hygienists name, the date or check number, bank number and the same applies to Postal and Express Money order numbers.

A letter is sent each month to the State Auditor giving the amount of income received, this account is reconciled with the deposits and a receipt is sent to the Secretary of the Board by the State Treasurer.

All checks received require from 10 to 15 days to clear the State Treasurer, therefore a delay of that length of time before the Annual Registration Certificates are mailed.

At the regular meeting of Jume22nd 1933 Dr W.H. Smith resigned as Secretary of the Board and Dr.H.D. Aldrich was elected to succeed Dr Smith, to take effect July 1st 1933.
