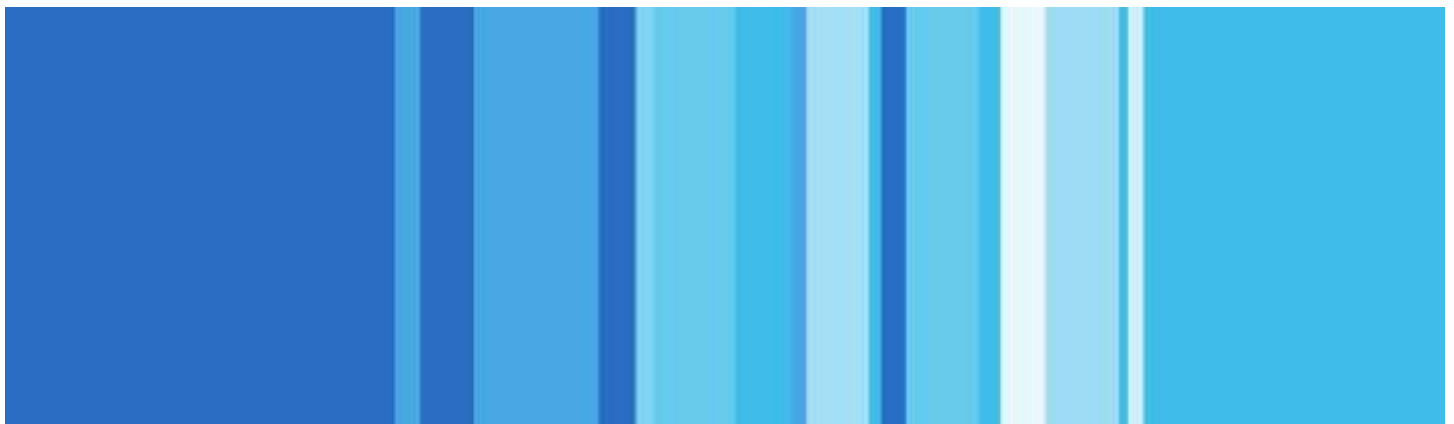

# Introduction

---

This report presents the first year results of the two year Part-Time Pilot study analyzing the Minnesota State Grant program eligibility/award formula change for undergraduates enrolled part time at Minnesota State Colleges and Universities (MnSCU). The policy change centered on the determination of a family's ability to pay, or Assigned Family Responsibility (AFR), used to calculate an individual student's Minnesota State Grant award for part-time undergraduates as opposed to those enrolled full time.

In 1993 Minnesota law defined for purposes of state financial aid programs, full-time undergraduates as those enrolled in 15 semester credits or the equivalent. Federal financial aid eligibility defines 12 credits as full time for undergraduates. Enrollment in 15 semester credits per term allows a student to complete a bachelor's degree in four academic years or an associate degree in two years.

Minnesota State Grants are awarded using the family's AFR, calculated from the federal need analysis income and asset information reported on the Free Application for Federal Student Aid (FAFSA), subject to modifications specified in Minnesota statutes. Current law does not modify the AFR, or ability-to-pay of the family, based on the enrollment level (number of enrolled credits) of the student. For example, the family of a student enrolled for 15 semester credits per term with estimated educational expenses of \$20,000 per year may be expected to pay \$1,000 based on their income and assets. Alternatively, a family of a student enrolled for three semester credits per term with estimated educational expenses of \$4,000 with the same income and assets is also expected to pay \$1,000. The State Grant Award formula is described in Appendix A. Calculation of the Assigned Family Responsibility is found in Appendix B.

During the 2013 legislative session, two student organizations, the Minnesota State University Student Association (MSUSA) and the Minnesota State College Student Association (MSCSA) posited the failure to modify the AFR based on a student's enrollment level created a financial barrier for students enrolled at less than full-time (15 credits per term). These student organizations proposed the law be changed to reduce the AFR based on the student's enrollment level. For example, this would enable the family of a student enrolled for three semester credits per term with estimated educational expenses of \$4,000, currently paying an AFR of \$1,000, to lower their AFR to 3/15 of that amount or \$200. A lower AFR would result in a higher state grant award.

Supporters of modifying the AFR based on enrollment level argue that increased grants per term allows students to "right-size" their enrollment based on their personal circumstances enabling more students to persist and complete their academic studies. The counter argument; however, is that increasing grants to part-time students encourages students to reduce their enrollment level leading to less likely persistence and completion.

In order to answer this policy question, the Legislature included changing the AFR based on enrollment as a pilot program specific to MnSCU institutions in the Higher Education Omnibus bill. The Part-Time Pilot is in effect for two years (academic years 2013-2014 and 2014-2015). The Senate Higher Education Committee indicated that the pilot program be evaluated by the Minnesota Office of Higher Education (the Office). It is expected that the pilot inform broader policy discussions of how the Minnesota State Grant program design be used to target specific populations, or to influence student behavior.

# Evaluation Questions

---

This report contains data on the number and dollar amounts of Minnesota State Grants specific to the change in Assigned Family Responsibility for Minnesota undergraduate students enrolled for fewer than 15 credits (referred to as the *Part-Time Pilot*) at Minnesota State Colleges and Universities (MnSCU) for Fiscal Year 2014 (July 1, 2013 to June 30, 2014).

## Evaluation Components Year 1

- Where funds were spent? How many and which students were impacted?
  - By college, credit level, income, family type
- Did more or fewer students enroll part-time?
- Did students who enrolled in both years and received a higher state grant enroll in more or fewer credits?

Minnesota State Grants are coordinated with federal Pell Grants, therefore the tables and graphs include combined federal Pell and State Grant awards where appropriate. Data are reported by the family adjusted gross income. All tables and charts in this report show family adjusted gross income of Minnesota State Grant recipients as reported on the FAFSA. For dependent students, the parents' adjusted gross income was used; for independent students, the students' and spouses', if married, adjusted gross incomes were used.

The data in this report are based on State Grant research data as of December 15, 2014. The totals may differ slightly from other documents published by the Minnesota Office of Higher Education as a result of adjustments made before or after this date.

## Other Changes to the State Grant

Four other changes also impacted the state grant award formula during the Part-Time Pilot beginning July 1, 2013. The changes listed below impacted the total funds received by an individual student in addition to any changes as a result of awards due to the Part-Time Pilot. This report can only evaluate how the Part-Time Pilot affected student awards and behavior.

The other changes to the State Grant not analyzed include:

- Increase in the Assigned Student Responsibility (ASR) from 46 percent to 50 percent
- Increase in the Living and Miscellaneous Expense allowance from \$7,000 to \$7,900
- Increase in the Tuition and Fee cap for four-year programs from \$10,488 to \$13,000
- Reduction in the AFR for independent students without children
- Increase in the maximum federal Pell Grant

# Fiscal Year 2014 Applicants

## ***Who was eligible for an increase in their grant due to this change?***

There were three main criteria that determined if a student was eligible for an increase in their state grant for the Part-Time Pilot. In addition to being eligible for a Minnesota State Grant, a student must also have:

- Been enrolled in 3 to 14 credits in a given term
- Been enrolled at MnSCU
- Had an AFR greater than \$0

### **Credit Level**

The Part-Time Pilot was targeted to students enrolled *part-time* (3 to 14 credits in a given term). In fall 2013, approximately 56 percent of the 142,438 state grant applicants were enrolled in 3-14 credits.

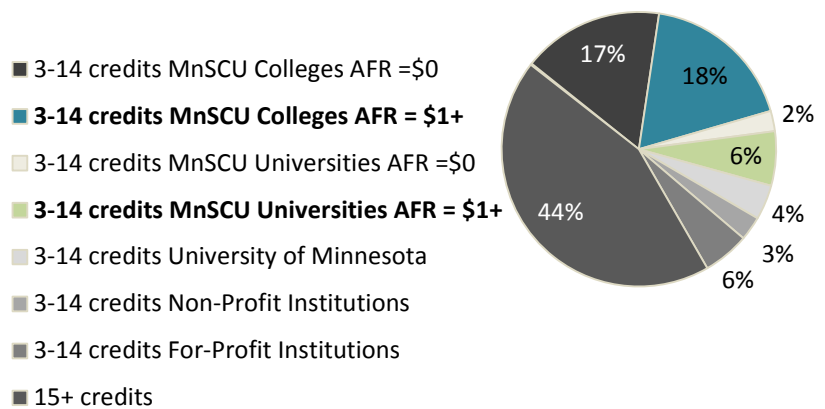
### **Sector**

In addition to requiring part-time enrollment, the Part-Time Pilot, unlike other state financial aid programs, was limited to students enrolled at MnSCU. Thirty-five percent of the 142,438 fall 2013 state grant applicants were enrolled in 3 to 14 credits at a State College and an additional 9 percent were enrolled at a State University for a total of 44 percent.

### **Family Type**

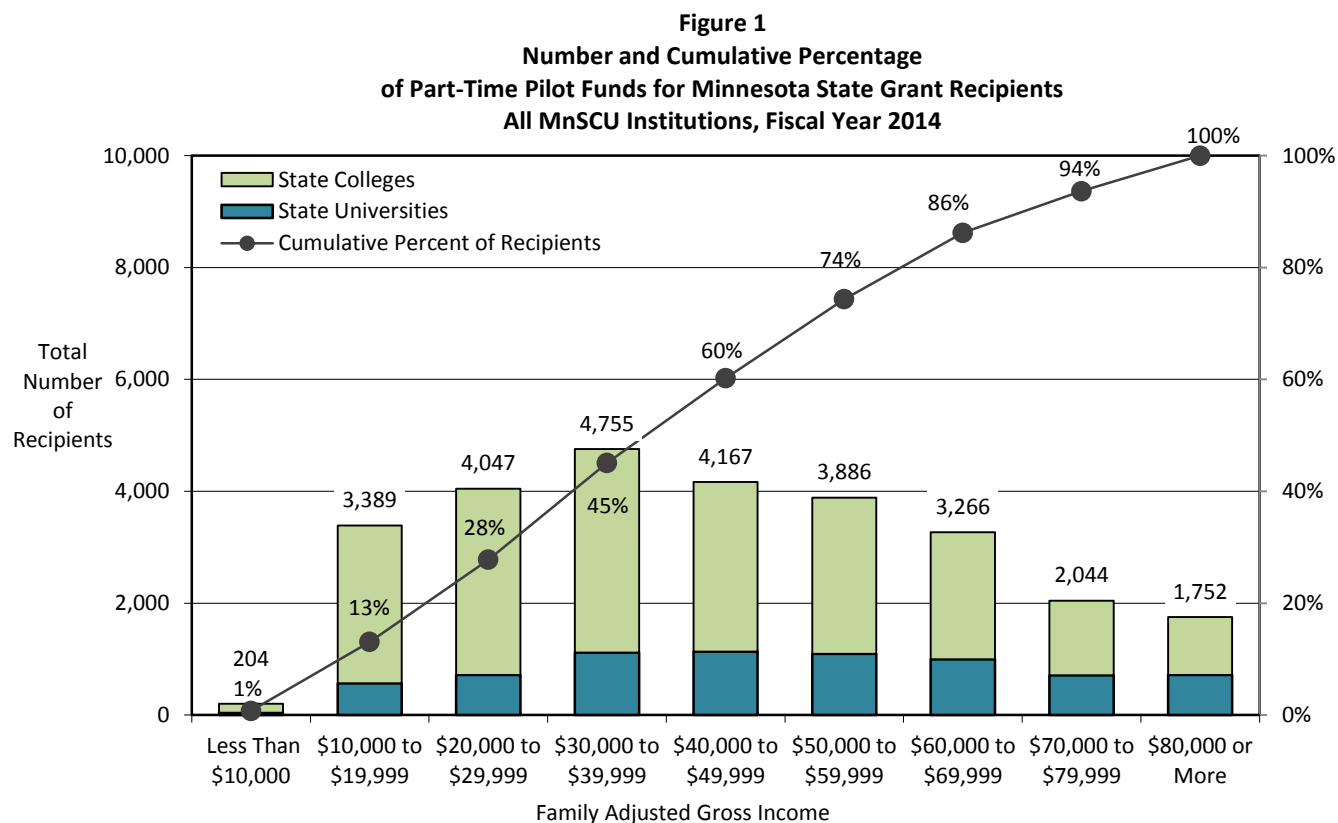
In addition to requiring part-time enrollment and enrollment at MnSCU, the Part-Time Pilot was based on the student's AFR. The Part-Time Pilot required the Office to reduce the student's AFR proportional to the student's enrollment level. Students with an AFR of \$0 would not receive Part-Time Pilot funds as it is not possible to reduce an AFR of \$0. This limitation resulted in only 24 percent of the 142,438 fall 2013 state grant applicants were eligible for a possible AFR reduction (18 percent at a State College and an additional 6 percent at a State University) or 34,185 applicants.

# Fiscal Year 2014 Recipients

*Where were funds spent? How many and which students were impacted?*

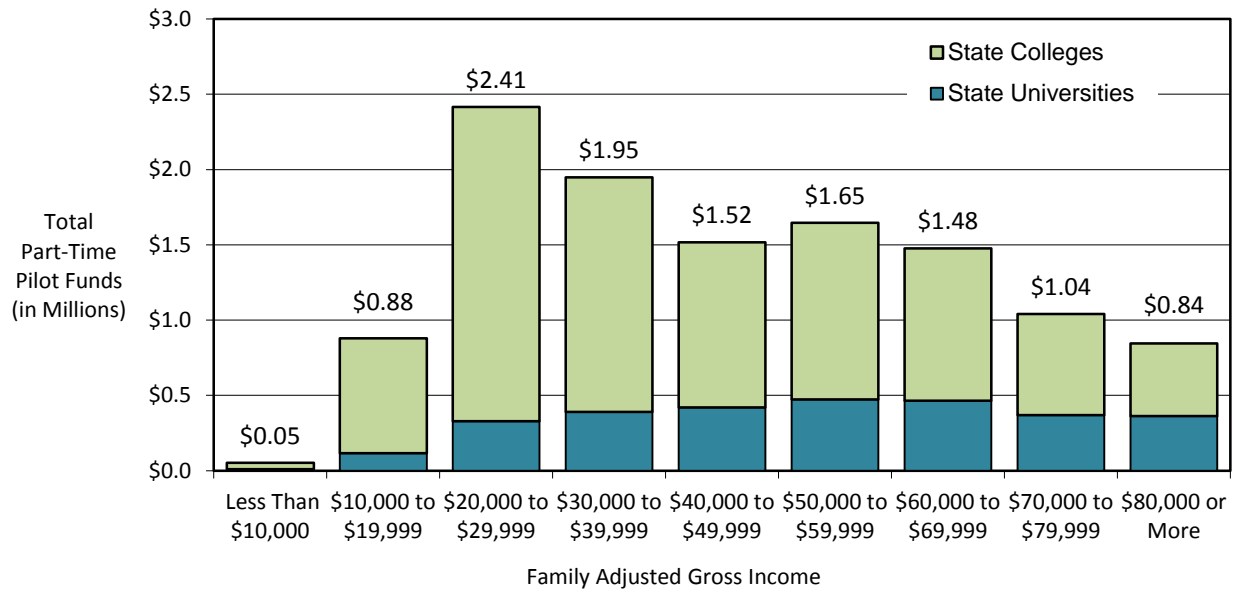


Of the 64,684 state grant recipients attending MnSCU institutions, 43 percent received an increase from the Part-Time Pilot. A total of 27,510 MnSCU students received \$11.8 million in funds as a result of the Part-Time Pilot during Fiscal Year 2014 (20,419 recipients at State Colleges, \$8.9 million; 7,091 recipients at State Universities, \$2.9 million).

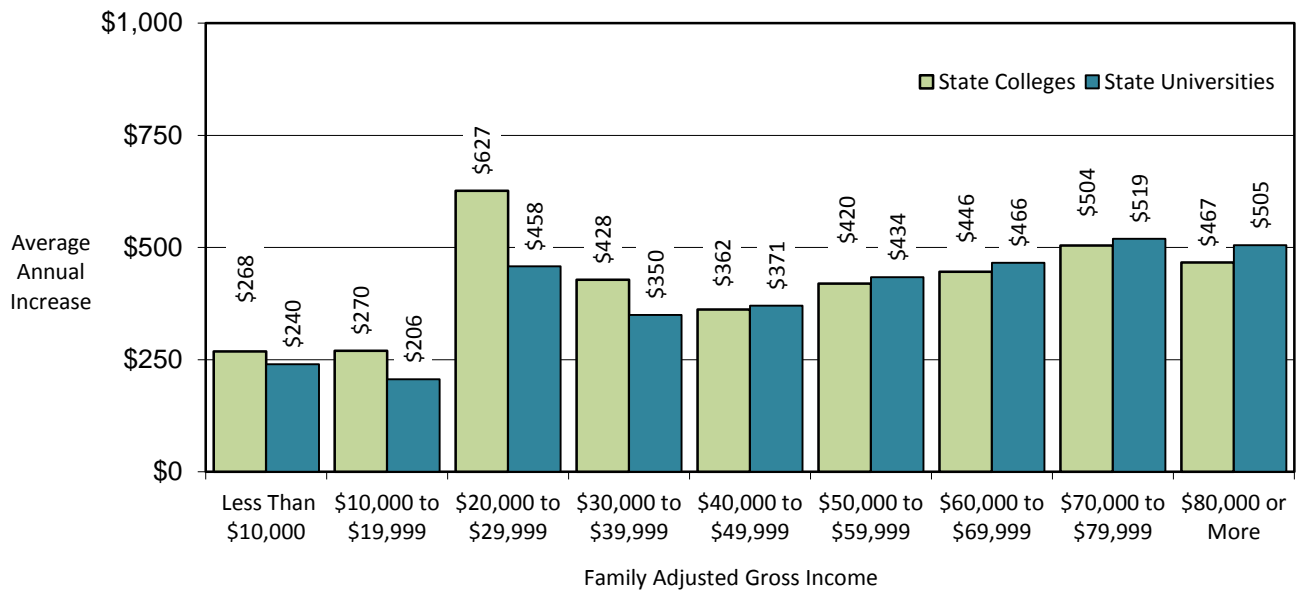
As shown in Figure 1, 60 percent of Part-Time Pilot funds recipients reported annual family adjusted gross incomes less than \$50,000 (64 percent at State Colleges; 50 percent at State Universities). Less than one percent of Part-Time Pilot recipients have incomes less than \$10,000 as many of these students having an AFR of \$0. Of the \$11.8 million awarded in 2013-2014, \$6.8 million (58 percent) went to students from families with incomes less than \$50,000 as shown in Figure 2. After controlling for enrollment level and tuition and fees charged, students at higher income levels would have received more Part-Time Pilot funds. The average Part-Time Pilot award by system and family type are shown in Figure 3.

Appendix C provides Part-Time Pilot awards by institution. Fifty-one percent (14,059 students) of Part-Time Pilot recipients attended institutions outside the seven-county metropolitan area and received \$5.4 million in funds (46 percent) during Fiscal Year 2014. In comparison, 13,451 students attended MnSCU institutions in the seven-county metro and received \$6.4 million in Part-Time Pilot funds.

## Key Findings by Family Type, Income, and Enrollment Level

Part-Time Pilot funds varied by the tuition charged to the student, AFR, family type and enrollment level. Appendices D-G details the spending by term by sector, family type, income and enrollment level.

Several trends emerged from the data.

- Part-Time Pilot funds benefitted a sizeable percentage of students enrolled for 12 to 14 credits in fall and spring terms (49 percent fall term; 46 percent spring term).
- Average annual increases ranged from \$373 for independent students with children to \$539 for independent students without children.

Dependent students received the largest percentage of Part-Time Pilot funds (46 percent) as compared to independent students with children (12 percent) and independent students without children (42 percent).

- Among dependent students, pilot funds increased as income increased, maxing out for students from families with incomes of \$70,000 to \$79,999.

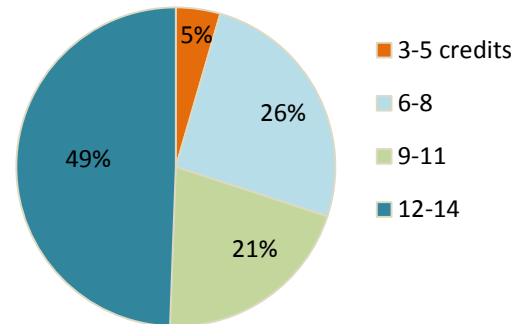
Few independent students with children received Part-Time Pilot funds, largely due to the fact that few independent students with children were enrolled.

- Independent students with children receiving funds were more likely to be enrolled for 6 to 8 credits in all terms than the other groups.
- Part-Time Pilot funds reached into higher income levels for independent students with children as compared to independent students without children, or dependent students.

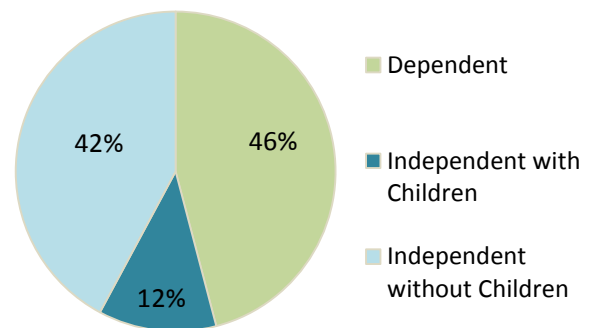
Independent students without children received larger average amounts from Part-Time Pilot funds; this is because independent students without children have higher AFRs than the other two groups when compared by income.

- Among independent students without children, the largest percent of recipients were enrolled for 6 to 8 credits (36 percent) or 12 to 14 credits (35 percent).
- Part-Time Pilot funds were awarded to students concentrated at lower income levels (\$10,000 to \$29,999) as compared to dependent students (\$40,000 to \$59,999) and independent students with children (\$50,000 to -\$69,999).

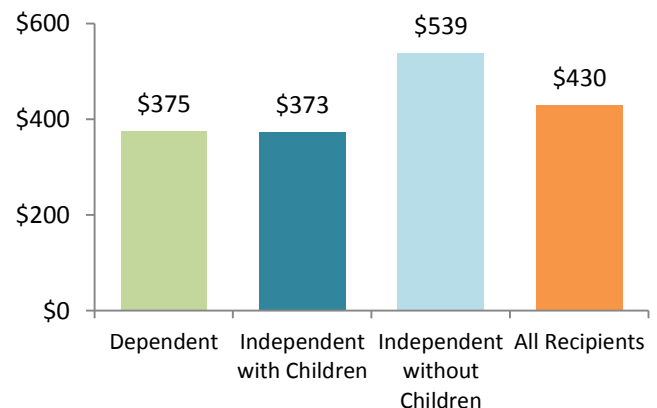

### *Dependent Students*

#### Dependent students at MnSCU State Colleges

- Received Part-Time Pilot funds totaling of \$1.6 million in fall term; \$1.5 million in spring term.
- Fall term Part-Time Pilot fund averages ranged from \$59 (\$20,000 to \$29,999; 12 to 14 credits) to \$402 (\$70,000 to \$79,999; 9 to 11 credits); similar patterns were found for spring and summer terms.
- The largest number of recipients at State Colleges were enrolled for 12 to 14 credits (54 percent). They also received the largest proportion of funds to students (41 percent).
- By income, the largest number of recipients had family adjusted gross incomes of \$40,000 to \$49,999 (22 percent) but students with incomes of \$50,000 to \$59,999 received a slightly larger percent of funds (23 percent).

#### Dependent students at MnSCU State Universities

- Received Part-Time Pilot funds totaling \$0.7 million in fall term; \$0.7 million in spring term; \$0.4 million in summer term.
- Fall term Part-Time Pilot fund averages ranged from \$71 (\$20,000 to \$29,999; 12 to 14 credits) to \$568 (\$70,000 to \$79,999; 9 to 11 credits); similar patterns were found for spring and summer terms.
- The largest number of recipients at State Universities enrolled for 12 to 14 credits (89 percent). They also received the largest proportion of funds (81 percent).
- By income, the largest number of recipients had family adjusted gross incomes of \$50,000 to \$59,999 (18 percent) but students with incomes of \$60,000 to \$69,999 received a slightly larger percent of funds (21 percent).

### *Independent Students with Children*

#### Independent students with children at MnSCU State Colleges

- Received Part-Time Pilot funds totaling \$0.5 million in fall term; \$0.5 million in spring term; \$0.2 million in summer term.
- Fall term Part-Time Pilot fund averages ranged from \$71 (\$20,000 to \$29,999; 9 to 11 credits) to \$366 (\$80,000 and above; 9 to 11 credits); similar patterns were found for spring and summer terms.
- The largest number of recipients at State Colleges enrolled for 6 to 8 credits (44 percent). They also received the largest proportion of funds (49 percent).
- By income, the largest number of recipients had family adjusted gross incomes of \$50,000 to \$59,999 (23 percent) but students with incomes of \$60,000 to \$69,999 received a slightly larger percent of funds (25 percent).

#### Independent students with children at MnSCU State Universities

- Received Part-Time Pilot funds totaling \$0.1 million in fall term; \$0.1 million in spring term; \$0.05 million in summer term.
- Few independent students with children enrolled at State Universities received Part-Time Pilot funds (373 students).
- Fall term Part-Time Pilot fund averages ranged from \$68 (\$40,000 to \$49,999; 12 to 14 credits) to \$630 (\$70,000 to \$79,999; 9 to 11 credits); similar patterns were found for spring and summer terms.

- The largest number of recipients at State Universities enrolled for 6 to 8 credits (44 percent). They also received the largest proportion of funds (52 percent).
- By income, the largest number of recipients had family adjusted gross incomes of \$40,000 to \$49,999 (21 percent) but students with incomes of \$70,000 to \$79,999 received a slightly larger percent of funds (23 percent).

### *Independent Students with No Children*

#### Independent students without children at MnSCU State Colleges

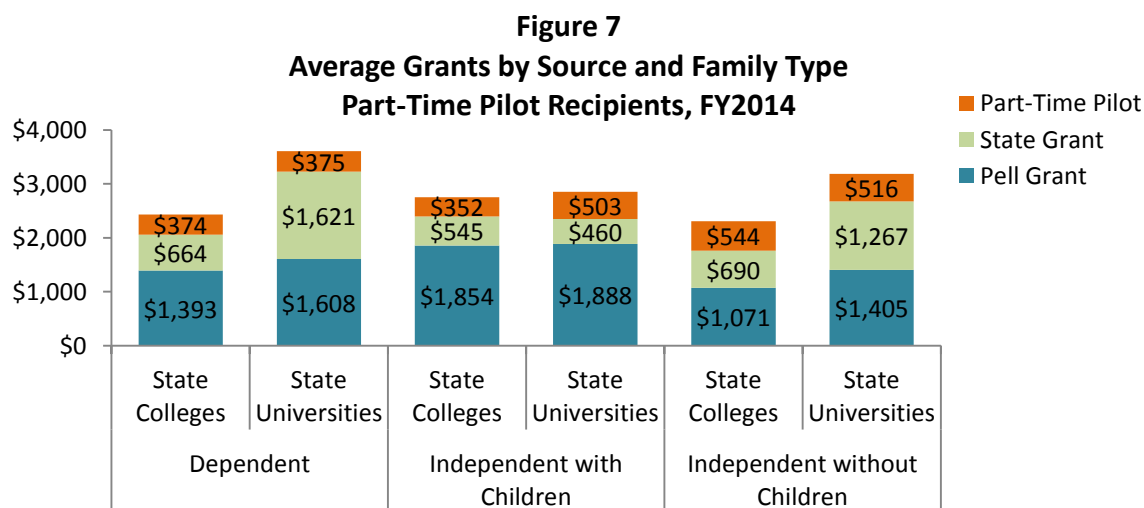
- Received Part-Time Pilot funds totaling \$1.8 million in fall term; \$1.8 million in spring term; \$0.6 million in summer term.
- Fall term Part-Time Pilot fund averages ranged from \$72 (\$10,000 to \$19,999; 12 to 14 credits) to \$564 (\$30,000 to \$39,999; 9 to 11 credits); similar patterns were found for spring and summer terms.
- The largest number of recipients at State Colleges enrolled for 6 to 8 credits (37 percent). They also received the largest proportion of funds (52 percent).
- By income, the largest number of recipients had family adjusted gross incomes of \$10,000 to \$19,999 (36 percent), but students with incomes of \$20,000 to \$29,999 received a slightly larger percent of funds (47 percent).

#### Independent students without children at MnSCU State Universities

- Received Part-Time Pilot funds totaling \$0.3 million in fall term; \$0.3 million in spring term; \$0.2 million in summer term.
- Fall term Part-Time Pilot fund averages ranged from \$26 (\$0 to \$9,999; 9 to 11 credits) to \$596 (\$70,000 to \$79,999; 9 to 11 credits); similar patterns were found for spring and summer terms.
- The largest number of recipients at State Universities enrolled for 12 to 14 credits (52 percent) but students enrolled for 6 to 8 credits received the largest proportion of funds (46 percent).
- By income, the largest number of recipients had family adjusted gross incomes of \$10,000 to \$19,999 (37 percent) but students with incomes of \$20,000 to \$29,999 received a slightly larger percent of funds (38 percent).

### ***How did overall total grant levels change with the Part-Time Pilot?***

Average grants by source, family type and institution type are displayed in Figure 7. Grants from all three sources shown vary based on income and enrollment level.



## Characteristics of Recipients

### Age

More than half of Part-Time Pilot recipients were 18 to 24 years old; the remaining students were 25 to 34 years in age (30 percent) or 35 or older (13 percent).

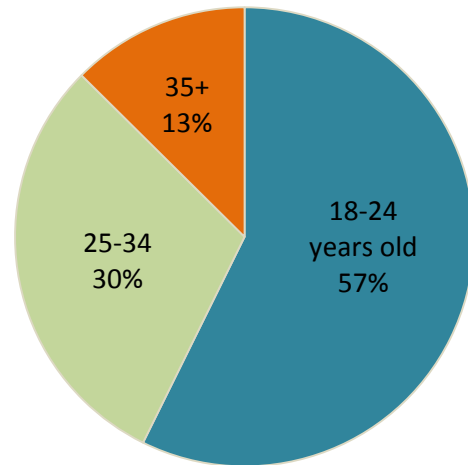
### Gender

Half of Part-Time Pilot recipients were female; the remaining students reported their gender as male (38 percent) or did not report a gender (12 percent).

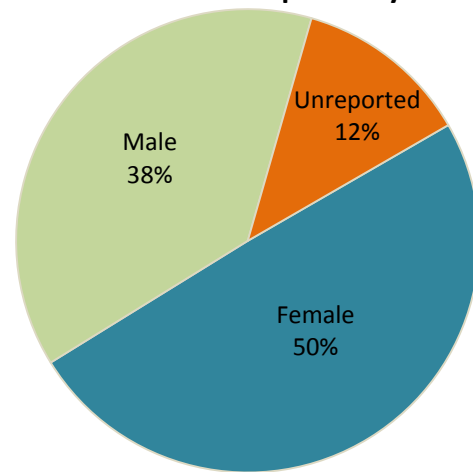
### Race/Ethnicity

The majority of Part-Time Pilot recipients were White (65 percent). Twenty-two percent of recipients were students of color (Black 8 percent, Asian 5 percent, Hispanic 5 percent, two or more races 4 percent, American Indian 0.6 percent, or Native Hawaiian or other Pacific Islander 0.1 percent). The remaining 13 percent did not have a race/ethnicity reported.

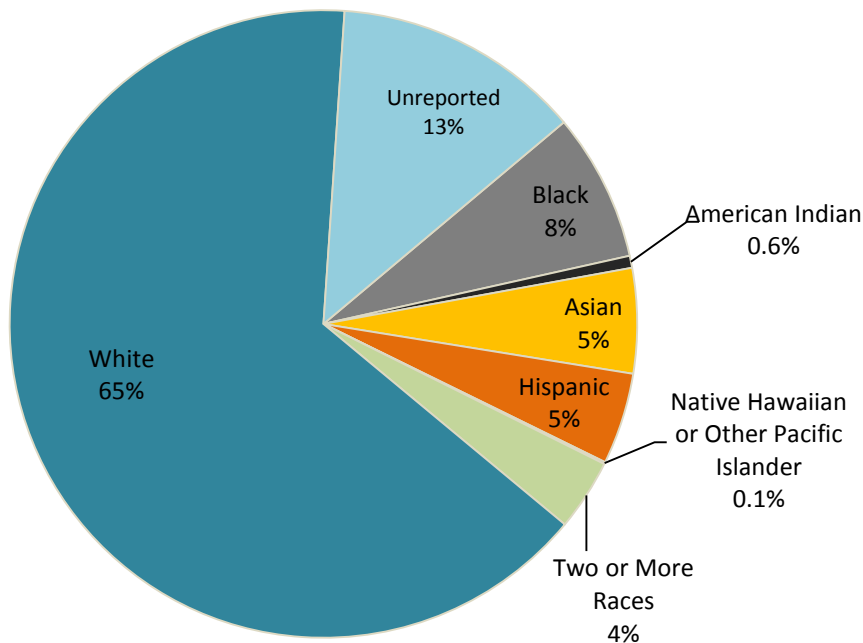

### ***Did the funds go to the intended recipients?***

During Legislative hearings, supporters indicated that more State Grant support was needed for two key groups – low-wage working adults and dependent students without family financial support. Both of these groups were said to be enrolled part time in response to a need to work to cover living expenses for themselves, their children or their immediate family. Paying for college presented additional financial burdens and current levels of State Grant and Pell Grant aid were inadequate. Since state lawmakers are unable to change levels of Pell Grant aid, attention was focused on making the State Grant more responsive to this population of students.

#### **Low-wage working adults**

Of the total \$11.8 million in funds, \$6.4 million (54 percent) went to independent students.

Among independent students, \$1.4 million of the total \$11.8 million (12 percent) went to independent students with children. The recipients among independent students with children were concentrated among those with incomes above \$50,000 who received \$1.2 million. Only 29 percent of independent students with children applying for a state grant were from incomes below \$50,000.

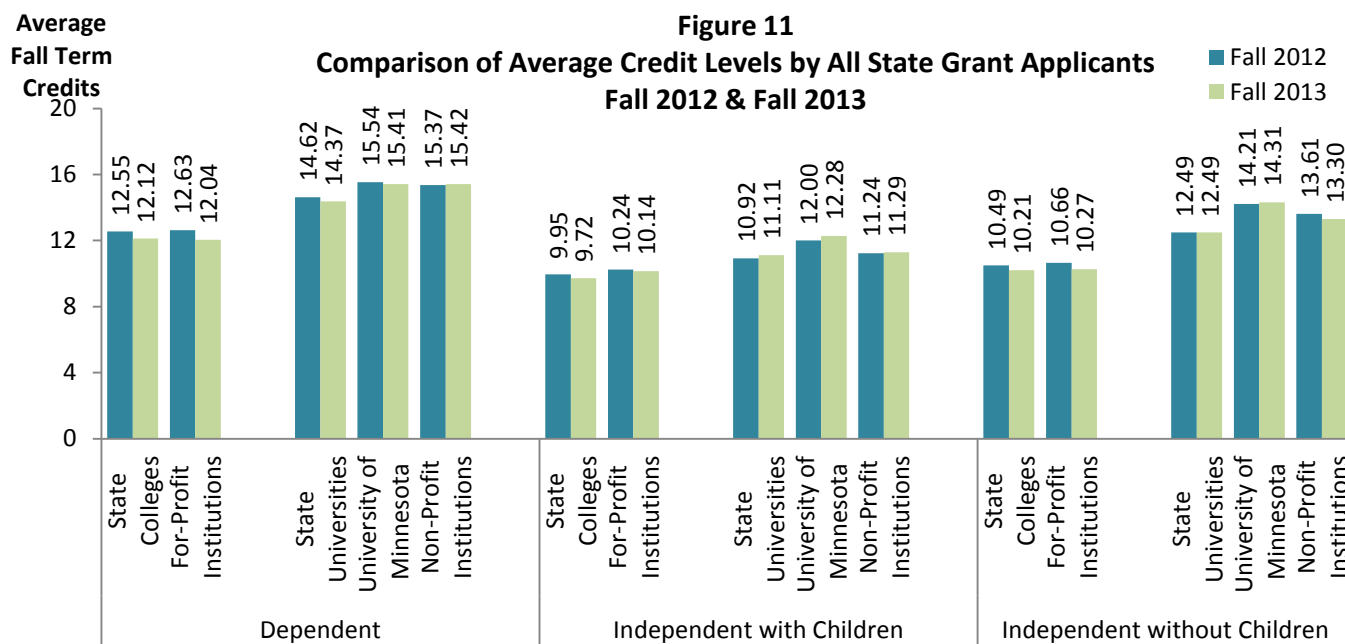
Approximately \$5.0 million of the total \$11.8 million (42 percent) went to independent students without children. The recipients among independent students without children were concentrated among those with incomes below \$50,000 who received \$4.5 million. The vast majority (93 percent) of independent students without children applying for a state grant were from incomes below \$50,000.

#### **Dependent students without family financial support**

The remaining \$5.4 million of the total \$11.8 million (46 percent) went to dependent students. The recipients among dependent students were concentrated among those with family incomes above \$50,000 who received \$3.6 million. Approximately 56 percent of dependent students applying for a state grant were from families with incomes above \$50,000.

There are many cases where students worked to supplement low wages earned by a parent in addition to paying for college. However, the Minnesota State Grant ignores student income and only considers the parents' income in determining the state grant award. If the parents' income was less than \$40,000, it was likely that the student would have a \$0 AFR and would not have benefitted from the Part-Time Pilot. In addition, the Minnesota State Grant would have increased by \$1 for each dollar decrease in the student's Pell Grant.

## Did more or fewer students enroll part-time?



One outstanding question of the Part-Time Pilot is whether the change would incentivize students to decrease their enrollment levels. To answer this question, the Office analyzed enrollments of state grant applicants from fall 2012 (FY2013) and fall 2013 (FY2014) by sector and family type to compare change in average fall term credits.

Enrollment levels for all state grant applicants and applicants enrolled in both fall terms were compared across fall terms as part of two analyses:

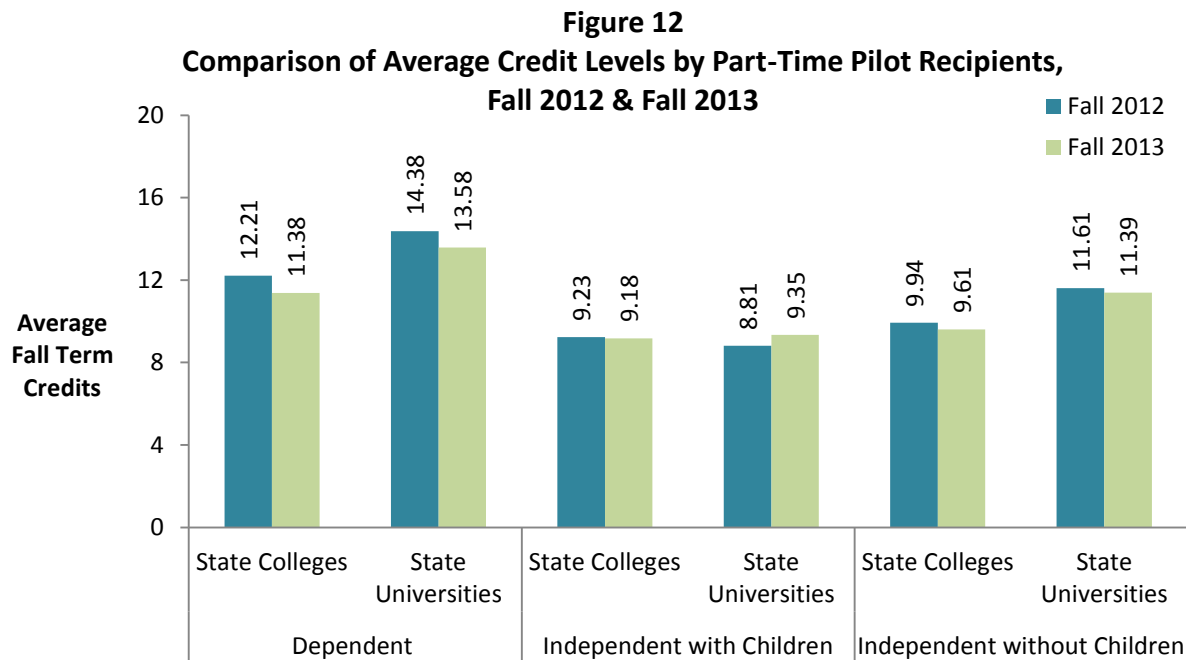
- Comparison of fall term enrollments for state grant applicants (independent samples t-test), and
- comparison of fall term enrollment of continuing state grant applicants (paired samples t-test).

First, mean enrollment by family type for all state grant applicants was compared. Enrollment levels decreased slightly for all family types. Average fall term credits declined by 0.03 credits for dependent students (-0.16 independent with children, -0.23 independent without children). While the results are statistically significant, they are not meaningful decreases. These results provide comparison information for interpreting enrollment changes for state grant applicants and Part-Time Pilot recipients. Results for this analysis are shown in Appendix H Table H1.

The second group analyzed was state grant applicants enrolled in both fall 2012 and fall 2013 as shown in Figure 11 and Appendix H Table H2. The results of this analysis show that dependent state grant applicants in each year enrolled in fewer credits across all sectors, except non-profit institutions. For independent students with and without children, comparison of enrollments of continuing students showed only statistically significant declines for students at State Colleges (-0.24 independent with children, -0.28 independent without children). The decreases while significant may not be meaningful from a policy perspective.

While comparison of initial descriptive statistics among the groups of interest provides initial baseline information, a more refined analysis using defined treatment and control groups would provide more reliable comparisons to answer this question.

***Did students who enrolled in both years and received Part-Time Pilot funds enroll in more or fewer credits?***



An additional comparison was completed to determine if students receiving Part-Time Pilot funds changed their enrollment level. Comparing applicant data for fall 2012 and fall 2013 allowed the Office to compare average fall term credits for students who enrolled in both terms and received Part-Time Pilot funds. Of the 27,510 Part-Time Pilot recipients, 41 percent of recipients were enrolled for both fall terms (11,210 students). Results for this analysis are shown in Figure 12 and Appendix H Table H3.

The results for Part-Time Pilot recipients varied by family type and sector. Among dependent students, Part-Time Pilot recipients at State Colleges and State Universities displayed a decline in average fall term enrollment for Fall 2013 as compared to Fall 2012 (-0.83 State Colleges; -0.81 State Universities). The decrease in enrollment is statistically significant. As discussed previously, average fall term enrollment for continuing state grant applicants displayed a decline in enrollment. Given the decline across continuing students across all sectors, this decline for continuing Part-Time Pilot recipients cannot necessarily be attributed to the Part-Time Pilot but could be reflecting larger macroeconomic changes (e.g. decline in unemployment, increases in wages).

Among independent students with children, Part-Time Pilot recipients at State Universities increased fall term enrollment by 0.54 credits. This increase is statistically significant at the lowest level (0.10). Analysis of fall term enrollment of independent students with children at State Colleges displayed no change in average enrollment. Among independent students without children, Part-Time Pilot recipients at State Colleges decreased fall term enrollment by 0.33 credits. This decrease in average fall term enrollment is statistically significant. Analysis of fall term enrollment of independent students without children at State Universities displayed no change in average enrollment. The mixed results for independent students with and without children make drawing conclusions from these findings difficult.

# Conclusion

---

This report presents year one results for the two-year Part-Time Pilot. The Part-Time Pilot is a specific eligibility/award formula change within the Minnesota State Grant program for students enrolled part-time at Minnesota State Colleges and Universities (MnSCU). Only an estimated 24 percent of all state grant applicants were eligible for a possible AFR reduction based on part-time enrollment and MnSCU attendance. Of the 64,684 state grant recipients attending MnSCU institutions, 43 percent, or 27,510 students, received an increase in aid totaling \$11.8 million as a result of the Part-Time Pilot during Fiscal Year 2014.

Several trends emerged from the data. Part-Time Pilot funds benefitted a sizeable percentage of students enrolled for 12 to 14 credits in fall and spring terms (49 percent fall term; 46 percent spring term). Dependent students received the largest percentage of Part-Time Pilot funds (46 percent) as compared to independent students with children (12 percent) and independent students without children (42 percent).

## Improved Targeting of Funds

Analysis of spending for the two student populations targeted, low-wage working adults and dependent students without family financial support, indicates that the broad changes made by the Part-Time Pilot could have been better targeted. Only a small percentage (43 percent) of funds went to independent students with incomes under \$50,000 in income, though that percentage includes a sizeable group of students enrolled for 12 to 14 credits. Dependent students from lower incomes families were largely not eligible for Part-Time Pilot funds as only parental income is included in state grant award calculations.

Given the total funding level of \$11.8 million for FY2014, these funds could be better targeted towards the intended student populations, low-wage working adults and dependent students without family financial support. Two options for targeting include reducing the AFR for independent students and increasing the basic maintenance parameters of the state grant program (living and miscellaneous expense allowance, and tuition and fee maximums).

Reducing the AFR for independent students will help low-wage working adults (age 24 or older) receive assistance in paying for additional education and training. Students age 24 or older do not have the same financial obligations as teenagers straight out of high school. Under current federal law, for every dollar these students earn, federal policy expects them to designate one-quarter to one-half for college costs. By lowering the AFR of independent students, state grants will increase for low-wage working adults.

Ensuring that the basic parameters of the state grant program remain current ensures that students do not face unreasonable educational costs. For example, the inability of a student to cover expenses beyond tuition (rent, transportation, books, and food) can derail enrollment. State law continues to expect that students can live on \$7,900 for a nine-month period—almost \$1,000 lower than the federal poverty level. The result is that students work more hours while enrolled in order to afford basic living needs, which limits their study and classroom time and negatively impacts their probability of college completion.

The result of better targeted funding within the Minnesota State Grant program provides for economic equity and fairness while maximizing State Grant effectiveness.

## Continued Evaluation

The question of whether the Part-Time Pilot would incentivize students to increase or decrease their enrollment levels remains unanswered. The mixed findings from analysis of fall term enrollments are likely the result of multiple factors including overall changes to the state grant award, the Part-Time Pilot and larger macroeconomic changes. While these findings provide a solid basis moving forward, a



more comprehensive evaluation of the Part-Time Pilot is required. A review of existing state program evaluations reveals a gap in utilization of strong statistical methodology for evaluating financial aid programs. Many program evaluations rely on descriptive statistics (participation rate), basic comparisons (difference in means), or qualitative/survey data and fail to utilize rigorous methodology. Given that the 2013 Legislature increased overall program funding allowing for broad-based changes in State Grant eligibility and award amounts isolating the impact of the Part-Time Pilot change on student behavior, more sophisticated statistical methodologies should be used.

# Appendix A: Minnesota State Grants Award Formula

---

## M.S.136A.095 GRANTS-IN-AID; PURPOSE.

*The legislature finds and declares that the identification of men and women of the state who are economically disadvantaged and the encouragement of their educational development in eligible institutions of their choosing are in the best interests of the state and of the students.*

The current state grant policy is based on the Design for Shared Responsibility. Students, whether full-time or part-time, determine the price of investing in their post-secondary education by the choices they make, such as decisions of where to attend and the number of credits enrolled (registration load).

Minnesota residents are eligible for a Minnesota State Grant if they register for three or more credits in any term and meet all of the other eligibility criteria. Full-time enrollment, for purposes of calculating grant awards for a term is set at 15 credits.

The Design for Shared Responsibility, as applied to the Minnesota State Grant program, distributes the recognized price of post-secondary education based on families' ability to pay and student attendance choices among students, families, and, if necessary, taxpayers. In determining Minnesota State Grant awards, the state expects students to make a significant personal investment in their own postsecondary education up front, called Assigned Student Responsibilities. The state also expects families to make an investment in their student's post-secondary education based on their ability to pay, called Assigned Family Responsibilities. Finally, the state leverages taxpayers' federal tax dollars (Federal Pell Grant) to work with state tax dollars to meet the state policy goals of covering the Recognized Price of Attendance for families whose ability to pay (Assigned Family Responsibility) does not provide full coverage of their Assigned Family-Taxpayer Responsibility.

The following formula is used to calculate the 2013-2014 annual State Grant award:

Tuition and mandatory general fees (30 semester/45 quarter credits)\*  
+ Living and miscellaneous expense allowance  
= **Award calculation budget**  
x Enrollment ratio (number of credits enrolled ÷ 15; ratio cannot exceed 1.0)  
= **Prorated Award calculation budget**  
- 50.0% Assigned student responsibility  
- Assigned family responsibility\*\*  
- Annual 9-month\*\*\* Pell Grant  
= **State Grant award (\$100 annual minimum, \$50 semester, \$33 quarter)**

\*Subject to tuition and fee maximums in law.

\*\*Assigned family responsibility equals:

If dependent student, 96% of annual 9-month FM parent contribution or

If independent student without dependents, 50% of annual 9-month Federal Methodology (FM) Expected Family Contribution (EFC) or

If independent student with dependents, 86% of annual 9-month FM EFC.

\*\*\*Annual 9-month refers to the 9-month academic year for financial aid; typically fall plus spring semester.

**Legislative Change:**

**Minnesota Laws 2013 Chapter 99, Article 3, Sec. 4.**

**STATE GRANT AWARD CALCULATION; MNSCU PART-TIME STUDENTS.**

*(a) State grant awards under Minnesota Statutes, section 136A.121, for the biennium ending June 30, 2015, made from appropriations for that biennium for part-time students attending a Minnesota state college and university system institution shall be modified as provided by this section. All other provisions of law and rule applying to state grant awards not inconsistent with this section shall apply to awards to those part-time students. (b) For a student registering for less than full-time, the assigned family responsibility is the amount determined for a full-time student under Minnesota Statutes, section 136A.101, subdivision 5a, prorated by the percent of full-time for which a student is enrolled.*

For Fiscal Years 2014 and 2015 only, the assigned family responsibility is also multiplied by the enrollment ratio or number of credits enrolled  $\div$  15 (ratio cannot exceed 1.0) if the student is enrolled at a MnSCU institution.

## Appendix B: How is the Assigned Family Responsibility Determined?

---

Assigned Family Responsibilities are determined through the assessment of family income and net worth, with adjustments to income and for family size. Families first report income and net worth to the federal government on the FAFSA. The federal government uses an assessment tool called the Federal Methodology Need Analysis to determine an amount a family is expected to pay for postsecondary education also known as the Expected Family Contribution or EFC.

The EFC is the amount of money that a family is expected to contribute toward the price of the student's education from its income and assets. A family's EFC remains the same even when the price of the school increases or the student's enrollment level changes. There is a different federal need analysis formula for each of three student groups:

- Dependent students
- Independent students with no dependents (children)
- Independent students with dependents (children)

The EFC consists of two parts: the parent contribution (PC) and the student contribution (SC). For independent students, there is no parent contribution.

### *Available Assets*

Assets usually are excluded from the EFC calculation for those with an adjusted gross income below \$50,000. When assets are taken into account, the EFC formula provides an *asset protection allowance* according to age and marital status. The typical family receives an asset protection allowance of \$30,000. This amount is subtracted from the parents' total net worth of assets and of the remainder, only 12 percent is considered available assets for education expenses. Independent students with children receive the asset protection allowance, but the assessment rate is seven percent.

In comparison, dependent students and independent students with no dependents are expected to contribute 20 percent of their total assets, since it is assumed that these students have saved their money for the purpose of paying for their education.

Assets used to calculate the EFC include real estate other than the family residence, investments, family-owned business with more than 100 employees, a farm that the family does not live on, current cash, savings, and checking accounts, and education IRA or higher education savings plans and investments.

Assets not used in the EFC calculation include the value of IRAs and other retirement investments, home equity (the difference between home value and home debt), farm equity for a farm on which the family lives (the difference between the value of the farm and the debt against the farm), family-owned business with fewer than 100 employees, and cash value of life insurance policies.

### *Available Income*

To determine the amount of income available for educational purposes, both parents and students are given "offsets" against income. Offsets include taxes (federal, state, local, FICA), employment expenses,

A student is classified as an independent student if he or she is:

- 24 years of age or older
- A graduate or professional student
- Married
- A student with legal dependents other than a spouse
- A veteran of U.S. Armed Forces
- An active duty member of the U.S. armed forces (not for training purposes)
- An orphan, ward of court or in foster care at any time age 13 or older
- In legal guardianship or emancipated minor status
- Determined to be an unaccompanied homeless youth anytime within the past year, or
- Classified by a financial aid administrator as independent because of unusual circumstances.

and an income protection allowance. For parents and independent students with dependents, the income protection allowance can range from approximately \$17,000 to \$53,000, based on family size and number of family members enrolled in college.

After subtracting the offsets from total income, the remaining income is called *available income*. For parents and independent students with dependents, the available assets are added to the available income to arrive at the adjusted available income (AAI). A portion of this amount is multiplied by 22 to 47 percent (plus an additional predetermined assessment) to arrive at the total contribution. The higher the income, the higher the percentage used. If more than one child attends college, the total contribution is divided by the number in college.

Dependent students and independent students without dependents are expected to contribute 50 percent of their available income and receive a more limited income protection allowance:

- \$6,310 for dependent students
- \$9,810 for single independent students
- \$9,810 for married independent students with both enrolled
- \$15,720 for married independent students with one enrolled

Income used to calculate the EFC includes adjusted gross income, if tax filers, or total wages, non-taxable income, contributions to tax-deferred pension and savings plans, IRA deductions, child support received, untaxed portions of retirement distributions and other items.

Income not included in the calculation of the EFC includes TANF, untaxed Social Security benefits or earned income credits, food stamps or subsidized housing, student financial aid awards, including need-based work study earnings, federal education tax credits, and child support paid to another household.

### Minnesota Modifications to the EFC, PC and SC

Minnesota uses the definitions and rates in the federal need analysis, but modifies the dollar amount results. For Fiscal Years 2014-2015, Minnesota enacted the following reductions:

- For dependent students, the AFR is the PC x 0.96
- For independent students with dependents other than a spouse, the AFR is the SC x 0.86
- For independent students without dependents other than a spouse, the AFR is the SC x 0.50

The Minnesota Legislature established these lower percentages as the EFC for families came to be viewed as too high. Comparisons of the federal PC and SC to the Minnesota AFR for Fiscal Year 2014 State Grant applicants is provided in the following table.
