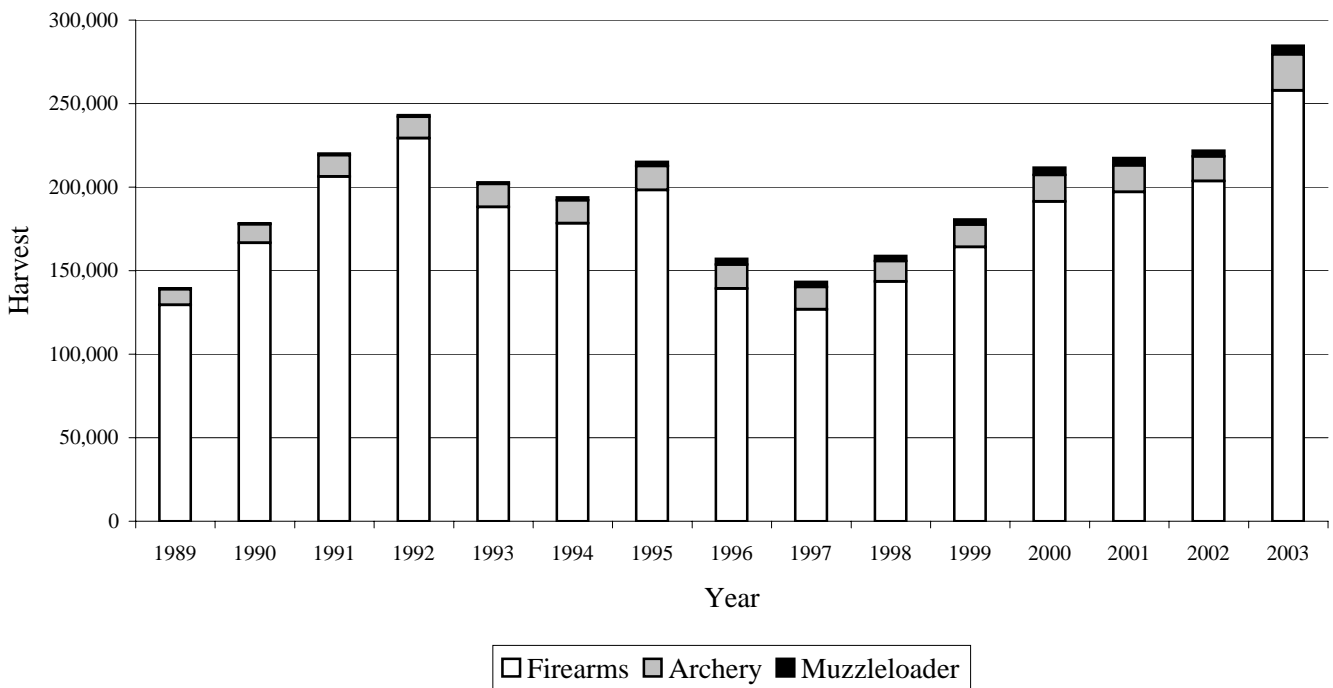

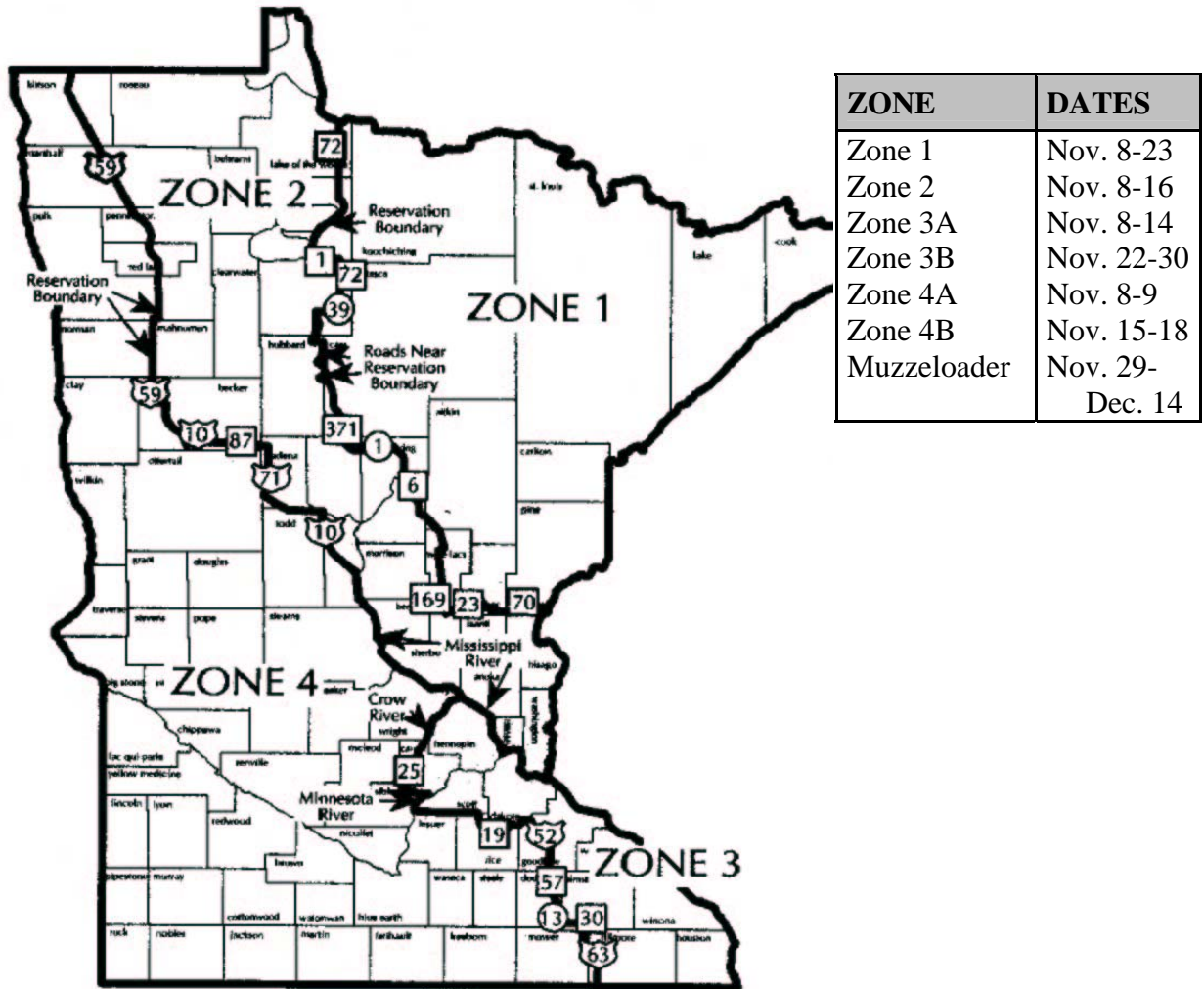

Figure 2. 2003 Deer Permit Areas

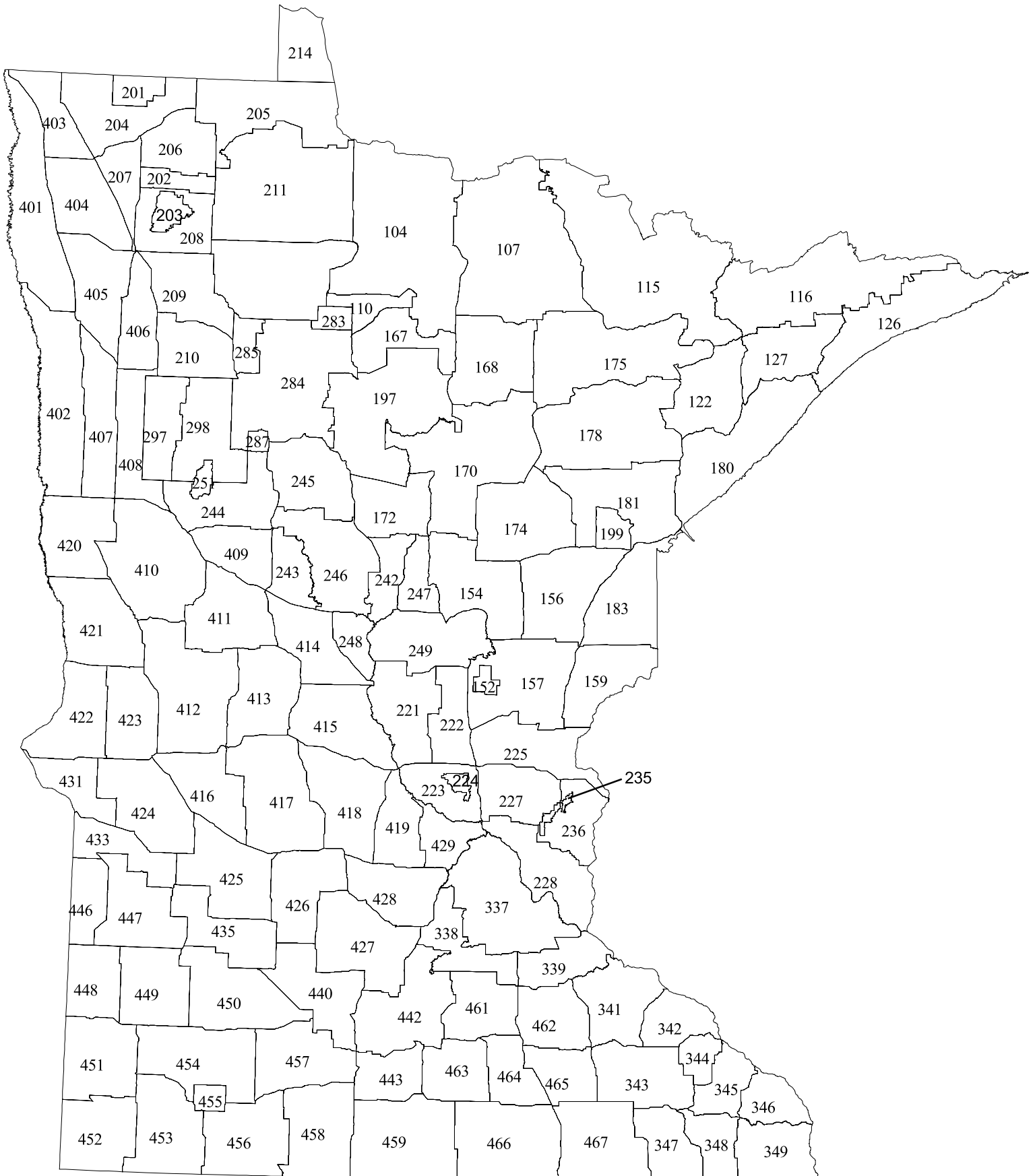
