#### **REPORT ON FISCAL YEAR 2015**

The goals and objectives included in our biennial plan have been addressed during fiscal year 2014 and fiscal year 2015. See the attached "FY2015 Highlights" and "Final Report Summaries for SMAC Grants Awarded in FY15" for further detail and additional examples of how we have met our goals and objectives. Also attached is a report showing all 2015 grantees, including project descriptions and funding sources.

#### **Goals and Objectives**

**<u>GOAL I:</u>** Increase the awareness of and access to the arts in our region.

1. Provide effective and efficient grant programs for the production or sponsorship of art for individual artists, organizations, communities, schools, and youth through regular appropriations, McKnight funds, Arts & Cultural Heritage funds, and memberships, contributions and donations.

SMAC announced the guidelines for grant categories at least six weeks in advance of the deadline. Grants were posted on our website, announcements sent out via press releases, email, notices on our website and Facebook page. Grant workshops were held at the SMAC offices and throughout the region prior to each grant deadline. SMAC staff provided one-on-one assistance over the phone, via email and in-person. SMAC maintained a toll-free phone number and easy access via email through our website. Grant programs are also advertised in our newsletter which is sent via US mail and email. All grant programs except the Operating Support, Cultural Bank Insurance, Prairie Disciple Award and Board Initiated Grants were conducted on-line during fiscal year 2015. Constituents needing help with the online application process were assisted by SMAC staff, SMAC board members and local arts organization staff and volunteers.

We have continued our outreach efforts to the Native American communities in our region. Continued work with Dakota Wicohan (Lower Sioux Reservation) in Morton has resulted in new contacts in the Dakota community and a grant award to Dakota Wicohan for "Tawokoga Dakota Art Classes." We continue to work at making new connections with minority populations in our region as well as working with our existing contacts.

Our work with communities and local government agencies to encourage arts activities has resulted in several new art projects. Grants were awarded to the City of Cottonwood for music performances at their local farmer's market, to the City of Spicer's Beautification Committee for summer musical performances on the deck overlooking Green Lake in the Spicer City Park, to the City of Rushmore for summer art classes for youth, to the City of Montevideo for a mural in the Jose Artigas Plaza in downtown Montevideo, to the City of Canby for performing arts sound and light systems in the Canby Theatre, Redwood County for a mural in the county court house. The SMAC executive director work with the University of Minnesota Sustainable Development Partnerships: Tourism & Resilient Communities group, SW x SW, in the southern part of our region to encourage them to incorporate the arts in their project planning. They held two events in FY2015, one in Windom featuring artist David Strom who opened his studio to the community and talked about his art along with a local foods event that included a performance by local musician Jim Austerman, and another event in Lamberton that focused on innovative agricultural adaption strategies that included an art exhibit and performances by local musicians. Both events brought the arts to new audiences.

See attached list of grants awarded. In Fiscal Year 2015 we awarded a total of \$502,597 in grants to 146 area organizations and artists under 14 separate programs.

## 2. Allocate approximately 30% of SMAC staff time to collectively and individually develop artists' and arts providers' capacity to succeed.

SMAC conducted workshops on Evaluating Arts Projects and Programs led by Leah Goldstein Moses of the Improve Group in Worthington, Marshall and Hutchinson attended by 52 people. We also conducted a two day workshop on Public Art in partnership with Forecast Public Art in Granite Falls, attended by 45 people. We provided lunch, mileage reimbursement and a stipend for those who had to take time off work to attend the workshops.

SMAC Administrative Assistant conducted individualized workshops to assist organizations participation in the Cultural Data Project in Marshall, Dawson and Lake Benton in June 2015. Additional workshops were conducted in July and August of 2015.

Networking opportunities occur at these conferences and workshops as well as at our grant writing workshops. Constituents were encouraged via email, our newsletter and our website to use the Public Art Toolkit developed by Forecast Public Art and available on line. Constituents are also encouraged to take advantage of other resources available via the web, including the MN Council for Nonprofits, Springboard for the Arts, Forecast Public Art, and other state and national resources.

SMAC actively promoted attendance at the Rural Arts & Culture Summit and provided scholarships to twenty-seven participants to offset the costs to attend the Summit. Fifty-nine people from the SMAC region attended the Summit.

SMAC held an Artist Retreat for individual artists that included workshops and networking opportunities. See attached fiscal year 2015 highlights for more information. 62 artists attended the retreat.

SMAC exhibited the work of six regional artists in fiscal year 2015 at our art gallery. Exhibits were publicized via postcards, email, our newsletter and website. Artist receptions were held for each exhibit. Eleven regional musicians were showcased at the artist receptions.

#### 3. Promote and celebrate arts creators, providers and appreciators in southwest Minnesota

SMAC publicizes regional arts activities via our newsletter, website and email, as well as with posters in our offices. SMAC staff and board members attend events throughout the region and advocate for the arts in communities and schools. SMAC encourages board, staff and constituents to attend Arts Advocacy Day to communicate with their legislators about the importance of the arts in their districts.

SMAC held our annual art celebration in Marshall, MN. The event included local artists' booths, performances by opera singer Emily Lodine of Magnolia accompanied by Janine Papik of Luverne on piano and a performance by the Great Plains String Quartet featuring cellist Aimon Dwan of Worthington. FY2014 Prairie Disciple John Voit of Ghent and 2014 Prairie Star Emily Lodine of Magnolia were honored at this event.

#### 4. Actively and effectively connect with constituents

We have increased the use of Facebook and email communications through Constant Contact to disseminate information regarding grant deadline, events, workshops and other opportunities. Press releases have proven to be effective ways to encourage newspaper articles in regional print media. Thanks to "Google Alerts" we are able to track news articles about SMAC activities. In person contact made with constituents by SMAC staff and board members at arts events throughout the region.

# 5. Increase Access to the Arts (Legacy) by supporting Minnesota artists and arts organizations in creating, producing, and presenting high-quality arts activities; to overcome barriers to accessing high-quality arts activities; and to instill the arts into the community and public life in this state

Grants included public art projects in New London and Montevideo fall and winter art programs and performances in Winsted, the Upper Minnesota River Meander Art Crawl, RiverSong Music Festival in Hutchinson, Rhythm of the River festival in Jackson, and the New London Music Festival, the Minnesota Pottery Festival in Hutchinson, a Raku Rendezvous in New London, a "Discover Dassel Art Tour", a "Front Porch Music Series" in Slayton, concerts by the Buffalo Ridge Chorale in Lincoln County, the

Worthington Area Symphony Orchestra and the Southwest Minnesota Orchestra and a summer music series in Spicer. All of these projects increase access to high quality arts activities throughout our region. Arts & Cultural Heritage Arts Access funds also allowed arts organizations to purchase equipment, participate in workshops and improve their facilities to allow increased access to their activities. See attached list of Fiscal Year 2015 grants for complete list of awards and projects.

Seven arts organizations received a second year of support through SMAC operating support grants. This was a new program last year and we continue to work out the program parameters.

## Increase Art Education (Legacy) by supporting life-long learning and appreciation of the arts, including but not exclusive to K-12 activities

Seven 5th-12<sup>th</sup> grade students received grant awards to attend the Southwest Minnesota String Festival. Arts & Cultural Heritage Arts Education funds allowed the Crow River Area Youth Orchestra to conduct a varsity string program and introduction to strings classes, conduct ongoing orchestra classes and rehearsals for area youth who no longer have access to orchestra programs through the public schools; Prairie Dance Alliance to provide a summer dance camp with professional dancers instructing dance students from throughout the region; Hutchinson Center for the Arts to conduct summer art classes, Southwest Minnesota Orchestra children's concert and string concerto competition, as well as several art field trip and artists residencies in area schools. # 6. Increase Arts & Cultural Heritage activities (Legacy) by supporting events and activities that represent the diverse ethnic and cultural arts traditions, including folk and traditional artists and art organizations, represented in this state

Grants supported the International Festival in Worthington, Tawokaga Dakota Art classes at the Lower Sioux Community near Morton, the Upper MN River Valley Arts Meander, and "Singing for the Cows" a one woman historical play at the McLeod County Historical Society in Hutchinson.

## **<u>GOAL #II:</u>** Act as responsible stewards of public & private funds in the service of the arts.

## 1. Invest \$442,000 each fiscal year in arts activities and arts organization development in the region through SMAC grant programs

SMAC board and staff, with the assistance of grant review panelists and input from grant applicants, continually work to make our grant programs accessible and effective. Grants are tracked through our Access database. Revisions to the programs are made as needed prior to the beginning of the next fiscal year. In fiscal year 2015 SMAC awarded \$502,957 through 146 grant awards.

#### 2. Maintain a strong and highly functional board of directors

In addition to attendance at board meetings our board members participate through committee work and service on grant review panels. Standing committees include Long Range Planning, Marketing, Nominating, Annual Celebration Planning, Conference Planning, Grant Program, Conference Planning and Fundraising and Membership committees. Committees report at each board meeting. We held an all-day board strategic planning retreat during which we reviewed and reaffirmed our commitment to the State Arts Board/Regional Arts Councils' 25 year guiding principles, vision, key goals and strategies. We reviewed the results of our evaluation data from surveys and grantee comments and articulated the SMAC mission, vision and values and SMAC's goals for the next biennium. SMAC board members attended the SMAC workshops on evaluation and public art, SMAC grant workshops, the SMAC Artist Retreat and Arts Advocacy Day. Six SMAC board members and three SMAC staff members attended the Rural Arts & Culture Summit. Board education sessions were incorporated into board meetings. Board members use this training to inform their work at SMAC as well as to share with constituents in their counties.

#### 3. Fund high quality projects

SMAC has continued to refine rubrics to assist grant panelists in their evaluation of grant applications. Panelists are trained to apply the criteria consistently as they review grants. The on-line grant review process has allowed us to improve our review procedures. Grant panelists are appointed by the SMAC board and represent a broad range of backgrounds, geography and expertise in artistic disciplines.

## 4. Develop methods to increase our system's level of accountability, including but not limited to: peer review, checks and balances and public involvement

SMAC executive director is an active member of the Forum of Regional Arts Councils of Minnesota (FRACM) and serves as its treasurer and on the executive committee. The FRACM conducts best practices sessions prior to each in-person board meeting. They conduct peer reviews of biennial plan proposals and provide input on grant programs and other services. The executive directors of the Minnesota Citizens for the Arts and the Minnesota State Arts Board and the arts program director for the McKnight Foundation are invited to all FRACM board meetings. Other arts organization and foundation representatives are invited to make presentations at FRACM board meetings. Surveys seeking input are conducted with participants in FRACM programs.

#### 5. Continue to evaluate our resources to benefit the arts

Board members receive monthly reports on grantee final reports that include a summary of the projects and comments about their experience with SMAC. As noted in #2 above, we conducted a Board and Staff strategic planning retreat. Time at our spring board meetings was devoted to facilitating organizational evaluation and adjusting our strategic plan as needed. The board makes modifications in our grant programs based on input from applicants, panelists, staff and board members.

#### **Monitoring & Evaluation of Grants**

All grant recipients are required to submit a final report within 60 days of their project completion. The final report includes financial information and number of people served as well as narrative response to specific questions about the project and examples of how the project was advertised and promoted. Twenty percent of the grant award is withheld until the final report has been received and approved. Every effort is made to evaluate projects on site by board members, panelists and staff. The SMAC board is provided with a summary of information received from the final reports.

## Grants to Arts Organizations, Communities, Schools, and Individuals

Total: 146 grants totaling \$502,957 were awarded to area organizations and artists through fourteen grant programs, including:

- \$195,149 for 50 matching grants through our Art Projects Grant Program, \$25,200 for 2 Art Project Legacy Grants, and \$5,920 for 3 Art Legacy Project Planning Grants.
- > 7 Operating Support Grants totaling \$56,182
- 1 Arts Organization Start-up Grant totaling \$1050 to assist a new organization with obtaining 501(c) (3) status.
- \$4,339 for 2 Arts Organization Development Grants, awarded for organizations to increase their longterm stability and capacity through organizational development and management projects.
- \$94,203 for 13 Equipment/Facilities Improvement Grants (including legacy), awarded for the purchase of equipment items and facilities improvement that will improve the organization's capacity.
- 3 Board Initiated Grants totaling \$9,500 to sponsor the SWWC Service Cooperative's Young Writers & Young Artists Conferences and attendance at the National Association of Community Theatres Conference for members of the Dassel Fungus Among Us.
- \$30,158 to 12 area schools in matching grants for artist residencies and arts related field trips through our Arts in the Schools Grant Program.
- 7 grants were awarded to students through the Art Study Opportunity for Youth Grant Program for a total of \$2,480.
- 23 individual artists were granted a total of \$73,500 for projects to further their careers as artists through the Individual Artist Development, Career, and Career Legacy Grant Programs.
- > 23 Scholarships totaling \$5,976 enabled 27 people to participate in the Rural Arts and Culture Summit.

### Awards

SMAC awarded the Prairie Disciple Award, to recognize one individual from SW MN whose art work best exemplifies the highest quality of work in the SMAC region and this year's recipient was Raeanna Gislason, who has been teaching private piano lessons in Willmar since the early 1970's, and has been instrumental in founding and providing leadership for two music teacher groups in the community. She has been a leader, often holding groups together during the tough times and creating ways for survival and strength to head back towards success. She has performed beautiful art, purchased visual arts, sponsored exhibitions of local and Regional arts, and inspired and taught young musical artists.

## Technical Assistance

- SMAC staff met with artists, volunteers, staff and boards from arts & culture organizations and schools throughout the region to provide assistance with board development, personnel, grant writing, marketing, fundraising and financial management. This free assistance is available upon request.
- 8 Grant Writing Workshops were conducted at the SMAC office, and 12 grant writing workshops were conducted at additional locations throughout the SMAC region including Hutchinson, Luverne, New London, Pipestone, Adrian, Worthington, Milan, Ortonville, Redwood Falls and Renville. 53 people attended the workshops.
- 3 "Evaluating Art Projects and Programs" Workshops led by Leah Goldstein Moses of The Improve Group were conducted in Worthington, Marshall & Hutchinson, attended by 52 people.
- A Public Art Conference, in partnership with Forecast Public Arts, took place in Granite Falls, attended by 45 people.
- > 60 SMAC region residents attended the Rural Arts & Culture Summit held in Morris
- SMAC region arts and cultural organizations participated in an economic impact survey. *Creative MN: The Health and Impact of the Nonprofit Arts & Culture Sector* was released at an event at The Barn Theatre in Willmar attended by 40 people. - SMAC Artist Retreat was held in at the historic Danebod Folk School in Tyler with 62 artists attending. Workshops included Actors' Secrets to a Powerful Presence, Poetry All Day, Dirty Hands Activity, Dharma Drumming, Scratch Board Activity, Follow Your Dreams, Watercolor Prints Activity, and How to Become a COMPAS Roster Artist. There were also networking opportunities, including, "Story Swap: Exploring Rural Arts & Culture in MN".
- SMAC's Annual Art Celebration held in Marshall, MN at the Golf Club. The event featured local artist's booths, a spirit raffle, dinner, and music performed by Great Plains String Quartet & Emily Lodine. 2014 Prairie Disciple John Voit and 2014 Prairie Star Emily Lodine were honored at the event. (2015 Prairie Disciple Raeanna Gislason will be honored at the FY2016 celebration in September 2015.)
- SMAC Art Gallery provides an opportunity for regional artists to have a solo exhibit in an accessible space. Receptions were held honoring each artist. Exhibits in FY 2015 included: Curtis Gander, Hutchinson; Craig Edwards, New London; Don Sherman, Ortonville; Nan Karr Kaufenberg, Redwood Falls; John Larson, Milan; and James Graham, Hutchinson. Eleven regional musicians were showcased as performers at the artist receptions.
- VOICES newsletter was published monthly and included a calendar of events, art opportunities and news items.
- SMAC website <u>www.swmnarts.org</u> provided up-to-date information on available grants, news, on-line grant forms, calendar of arts events, and links to arts resources.

**Project:** Ceramic Mural Residency

**Final Report:** Artist in-residence Anne Krocek led art classes at the Jr/Sr High level in making a glass and ceramic mural that was permanently installed in the commons area of Hills-Beaver Creek High School. Students learned that they were participating in making public art by creating this mural. They learned about the different stages of clay and sculpting clay and how glaze is like liquid glass with pigment to add color and shine to their sculptures. High school students learned to cut glass and apply it like puzzle pieces to fill in the mural and make it whole. We had a public unveiling with students, school board and community members. Students each wrote an artist statement on the process of making the mural and their feelings. At times the project deadline seemed too demanding but we poured on the manpower and worked hard to stay focused and we accomplished our goal of a 4 ft. x 4 ft. x 6 inch mosaic mural in just 8 days with 38 students.

**Comments re: SMAC -** Since the residency involved us making a public piece of art, the numbers of people served is ongoing isn't it? I don't feel counting the number of people for the unveiling should be a "final tally". Many, many others will come into our school and see the mosaic on the wall. People that come for concerts, sport events, graduations, etc.

**Comments for Legislators:** We would not have been able to hire Anne to come do this mosaic residency had the grant not been available to apply for. We simply would not have had the funding to buy the materials or pay for the expertise of a public artist to teach us how to accomplish what we did.

Project: Conrad Herwig Jazz Residency

**Final Report:** Conrad Herwig conducted a residency with the SMSU Jazz Ensemble focusing on the authentic performance of jazz by large ensembles and the individual skills required. Additional educational opportunities were provided for area high school band directors and students through open clinics at Marshall high school and Kerkhoven-Murdock-Sunburg high school. Mr. Herwig spent four hours in rehearsals with the primary group plus an additional 2 hours with some of the members in clinics on improvisation and careers in music. The members of the Jazz Ensemble learned a great deal from the guest artist about authentic performance and what it means to play with a featured soloist. They had the opportunity to hear Mr. Herwig's ideas on developing greater musical and improvisational skills as a jazz artist. He shared experiences and insight that are valuable in helping students develop a sense of the art and business of jazz musicianship and their place in it.

Comments re: SMAC - I believe that the communication and process worked very well.

**Comments for Legislators:** This is the ninth year for this program, and I believe that the community and area music educators have begun to see the benefits of visiting jazz artists and what they can tell our students about the music, the culture, and the business. #### **Project:** Copper Street Brass Residency

**Final Report:** Adrian High School & Middle School brought the Copper Street Brass to our school for a one-day visit. They presented three educational sessions throughout the day including an elementary school lyceum, a showcase for the 6th graders and a rehearsal with our middle and high school bands in preparation for the evening concert. They performed alongside our students on the evening concert providing a once in a lifetime opportunity for the kids. Because we were not awarded full funding, we had to scale back the project as we were not able to afford the remaining expenses. Our students and community were able to experience live music by professionals. Due to our location in the state, access to quality, professional music performances are rare. The students also learned about brass instruments and how to work together to play in a small ensemble. They learned practice techniques and music theory. My students' learning took place over two months while we learned the concepts of the music, learned what cadenza was as well as thirteen different master works and their composers. After all the hard work, the best reward was being able to share the spotlight with the brass quintet at the concert that evening.

#### **Comments for Legislators:**

This grant allowed my students to have a rich musical experience with professional musicians. With this grant, we were able to bring the music to our community. While our community supports music, they do not often have the opportunity to attend professional music concerts, and the Copper Street Brass Quintet offered an amazing combination of education and entertainment for our students and community.

#### Project: Lamberton Jazz Festival

**Final Report:** Douglas Snapp (trumpet), Rich MacDonald (percussion), Craig Bailey (Saxophone) and Scott Agster (trombone) worked with the 10 participating bands. They presented a mini-performance before lunch. This performance focused on jazz improvisation. The clinicians also gave section-specific masterclasses. The festival concluded with an evening of performances by the clinicians and the 2015 guest bands, the MSU Jazz Mavericks. All of the participants received new techniques and ideas to improve their jazz playing and improvisational skills. Many of the participating schools are from rural areas and, without the Lamberton Jazz Festival, would not have an opportunity to work with and hear professional jazz musicians of this caliber.

**Comments re: SMAC -** SMAC has always been extremely supportive of the Lamberton Jazz Festival. The festival would not be possible without SMAC support. **Final Report:** This one-day residency addressed our four bands (5-8th grades) reaching a total of more than 250 students. The four classroom presentations featured performances of several of the Copper Street Brass Quartet's own arrangements of classical, jazz and pop tunes. The CSBQ challenged students to be active listeners and to be participants in discussions about what they heard, how the music works, and other observations with live professional musicians present. The evening performance featured music from Mozart to Dave Brubeck to Billy Joel and wowed the audience with its innovative blend of musical styles and dazzling fusion of electronic effects. The students were energized and involved as an engaged audience. **Final Report:** This project consisted of a pottery workshop at the Paramount Visual Arts Center as well as a residency and mentorship program with ceramicist Craig Edwards. Students involved included a core class of 20 high school students in the Ceramics & Sculpture Class and 30 younger students in other classes offered in the art department. The class was better and curriculum more well-rounded because of the residency. The work we did with Craig Edwards was part of one art history component for the class (Asian Pottery and Aesthetics). The workshop at the Paramount focused on wheel thrown and hand built ceramics. It allowed all students to have several hours on the wheel as they made their first attempts at it. We hired Ross Sutter to do a folk music & dulcimer residency. Ross visited the school on three different occasions for a total of 5 1/2 residency days. The fourth grade students built two different instruments: a limberjack dancing doll and a one-string dulcimer. Ross taught the students how to play each of the instruments and they performed on them for the whole school In addition, both classrooms visited a first grade classroom and taught the students how to play each of the instruments. Ross worked with students to teach them traditional European song dances and games. These were also performed at the final program for the whole school and the community. Ross was unable to attend a performance at the Senior Center, however students went and performed on their own. Students helped Ross with a project he is doing to record Swedish song dances. Our project consisted of two children's concerts coupled with a string concerto competition. Each 40-45 minute concert was comprised of a 20-25 minutes performance with full orchestra, a performance by Marshall Beats, Narration by Dr. Jan Loft, and a solo performance by this year's concerto competition winner, Olivia White on violin. The original plan included a planetarium show by Dr. Ken Murphy of SMSU however his planetarium equipment could not be set up in the concert hall. He did, however give us several links to online shows that were to be broadcast on the large screen in the auditorium. Unfortunately, due to weather, Marshall Schools closed the day of the concert. All musicians were in place and ready to perform. We immediately contacted the audio/video program at SMSU and asked them to come and record the concert with hopes of making a CD to distribute to attending schools. In the haste of setting up hours earlier than planned, there was a glitch with the system and a quality recording failed to materialize. We also contacted Studio One in Marshall, But they were not able to mobilize that quickly. Our concert competition winner, Olivia White, was able to have her orchestral debut at a later date, as she performed at our spring concert in front of an audience. The diverse members of the SMO which includes SMSU students, MHS students, Community members and homeschool students were able to rehearse and perform challenging music with fellow orchestra members to improve their playing ability while receiving one-on-one tutelage.

#### Final Report:

Prairie Dance Alliance (PDA) presented its 25th annual dance camp the last week in May 2015. There were two changes: we replaced instructor Whitney Hart with Stanley Glover (she had a last minute conflict and he was an outstanding replacement); also we added another dance assistant due to increased enrollment. PDA was extremely pleased with all aspects of camp. Instructors were excellent and the facility worked very well, even with the additional participants. We were able to recruit Stanley Glover as our modern instructor -- the kids loved him and he brought some name recognition to our camp. Also, PDA fulfilled a long standing goal of including members of the local high school dance teams who do not otherwise participate in classic dance. We had 11 members from Marshall and 6 from Redwood who came for an intensive 3 hours session in the afternoon. They received instruction in both ballet and jazz. PDA continues to evaluate our facility needs - but so far have been unable to come up with an alternative location.

Project: New Percussion Equipment

#### Final Report:

The Willmar Area Symphonic Orchestra, and community partner, Prairie Winds Concert Band, believe it was important to upgrade much of the percussion equipment both organizations used for rehearsals and concerts. Especially important to upgrade were the set of 3 timpani that were outdated and in poor condition. The suspended and crash cymbals and other smaller accessory instruments were also not up to the standard desirable for the level of repertoire both organizations were able to perform. The entire process went well, with the usual limitations of having many busy people involved, thus taking somewhat more time than was ideal. We didn't get to use the new equipment until the final concerts of the year, but the end result was everything we had hoped for! 1200 people served.

We have always found the staff at SMAC to be very helpful with both their training sessions, and their responses to specific questions.

#### **Comments for Legislators**

There is no doubt that offering opportunities to participate in high-quality music organizations like the Willmar Area Symphonic Orchestra and the Prairie Winds Concert Band helps to attract many talented and well-educated people to our area. Our audiences also appreciate the opportunity to hear quality music. Besides these 2 aspects, it is great to be able to offer local students a chance to play advanced repertoire that is beyond what they usually play at school. Another positive outcome to having these organizations in our community is that they provide an avenue for musicians to form smaller ensembles that play in many venues in our community. These ensembles play at festivals, churches, fundraisers, and so forth. It takes practice and the chance to play with other musicians that make it possible for these small ensembles to exist.

Without grants from organizations like SMAC and other arts grantors we simply would not be able to offer such a high level of musical performance. It would takes years to raise the money for a set of timpani - yet the difference our new percussion equipment makes to our sound is remarkable.

The "Mural in Artigas Plaza" (MAP) group put together an RFP to solicit interested mural artists to send us their resume and work samples.
