EXECUTIVE SUMMARY

The following survey report presents Minnesota residents beliefs about the Department of Natural Resources (DNR). This survey was originally conducted by Anderson, Neibuhr & Assoc. in 1988 to provide information regarding resident's awareness of DNR responsibilities, their satisfaction with DNR services, and their opinions about potential DNR services. The survey also yielded information concerning residents sources of information regarding the DNR and their level of participation in a variety of activities. The survey was reissued in December of 1991 so that the Department can continue to monitor its image and satisfaction level and as a benchmark in tracking trends and concerns.

Essentially, the same research was conducted in both studies. Some minor changes were made in the questionnaire design to improve the type of information gathered. Changes include the deletion of questions regarding sources of funding and the addition of others which focus on current issues. Subgroups were not looked at in this survey due to the insignificant differences found in the 1988 study.

The research has shown very little change over the last three years in Minnesota residents' view of the DNR. Some areas of awareness and satisfaction have shifted slightly but generally our image with the general public remains the same. The fact that very little change has occurred indicates the validity of the information gathered in the 1988 survey and it gives the Department a sound benchmark to track future trends.

Awareness of DNR responsibilities remains stable. The DNR is best known for conserving land and water, enforcing game and fish laws and managing wildlife populations. They are not well known for leasing public land or regulating mining. Many residents believe the DNR is responsible for providing timber wolf management, environmental education and issuing permits for the BWCA. The DNR needs to decide if these beliefs are important enough to better inform the public about our involvement in these areas or in fact, change our involvement. A good example might be increasing our responsibility for environmental education.

Overall, residents are satisfied to neutral with the services the DNR provides. Services that were rated important or very important were looked at in terms of their satisfaction level. Protection of endangered species, building maintenance, DNR licensing, hunting, fishing, wetland protection and safety education all had satisfaction ratings of over 70 percent. Issues that were important but were not rated as high on

satisfaction levels include protection of old growth forest, preventing the spread of milfoil, managing lakeshore development and communicating natural resource law. All DNR services are considered to be important by over two-thirds of Minnesota residents. The prevention of the spread of Eurasian watermilfoil is perceived to be the most important service, followed by how much the DNR is doing to reduce trash dumped along lakeshores and rivers.

Opinions regarding potential DNR services are virtually the same as in 1988. In 1988, 62% disagreed with the statement that the DNR should cut more timber in response to forest industry needs. In 1991, 68% disagreed with this statement. Because there was some concern in the way the question was worded, an additional question was included in the 1991 survey. Residents were asked to rate their agreement with the statment, "The DNR should manage forests to meet consumer demand for forest products." Only 26% disagreed with this statement. The difference in percentage between these two questions seems to indicate the importance residents place in having a role in the management of the states natural resources and in turn their perception of DNR services.

METHODOLOGY

The population of interest for this study was Minnesota residents 18 years of age and older. A random sample of 1000 Minnesota residents selected from the general population were sent the survey. A response rate of 55 percent was achieved. An alert letter, followed by the survey and in some cases a 2nd survey, were sent to each of the 1000 households.

For comparison purposes, the information used in this report from the Anderson, Neibuhr & Assoc. study includes only the information obtained from their mail survey. The 1988 study included a follow-up telephone survey to increase the response rate. Those who responded to the telephone survey were less likely to know or participate in activities related to the DNR.

The survey was reissued as a benchmark in tracking the information gathered in 1988. The survey will help the DNR watch trends develop and look for areas to focus services and communication efforts.

CONCLUSIONS

Demographics

- 1) Over 75 percent of the survey participants have been residents of Minnesota for longer than 25 years
- 2) Land Ownership

* 20 percent own lakeshore or rivershore property

* 11 percent make their income from farming

3) The median age of survey respondents is 45 years old

4) Male: 75% Female: 25%

5) Almost 70 percent attended college, 34 percent graduated

AWARENESS OF DNR RESPONSIBILITIES

- 1) The DNR is well-known for:
 - * Conserving Minnesota land and water (96%)
 - * Enforcing game and fish laws (96%)
 - * Managing wildlife populations (94%)
- 2) The DNR is not well known for:
 - * Leasing public land (44%)
 - * Regulating mining (30%)
- 3) Many believe the DNR is responsible for:
 - * Regulating timber wolf management (84%)
 - * Providing environmental education (82%)
 - * Issuing permits for the BWCA (63%)
- 4) Belief of Services that the DNR does provide have slightly increased.
- 5) Belief of Services that the DNR does <u>not</u> provide have all slightly decreased.

SATISFACTION WITH DNR SERVICES

- 1) Satisfaction with DNR services has remained about the same.
- 2) Over 70 percent are <u>satisfied</u> with the following services:
 - * What the DNR is doing to protect endangered species of animals (79%)
 - * The way the DNR maintains its buildings and campgrounds (76%)
 - * Fishing in Minnesota (72%)
 - * How well the DNR educates people about safety for activities such as the use of firearms and boating (70%)

3) People expressed the most <u>dissatisfaction</u> with:


- * How much the DNR is doing to reduce the amount of trash being dumped along lakeshores and rivers in Minnesota (29%)
- * What the DNR is doing to prevent the spread of Eurasian water milfoil (22%)
- * How well the DNR communicates natural resource laws and policies (18%)
- * What the DNR is doing to promote the protection of old growth forests (18%)
- * How well the DNR educates people about species such as zebra mussels (18%)

IMPORTANCE OF DNR SERVICES

- 1) All the DNR services included in the survey are considered to be important by over two-thirds of the residents.
- 2) What the DNR is doing to prevent the spread of Eurasian water milfoil is perceived to be the most important service. (69%)
- 3) Other very important services include:
 - * How much the DNR is doing to reduce trash dumped along lakeshores and rivers (64%)
 - * How well the DNR reforests harvested areas (49%)
 - * How well the DNR maintains the balance between use and preservation of natural resources (48%)
 - * What the DNR is doing to protect endangered species (47%)
 - * The fact that wetlands other than lakes are protected (46%)
 - * Fishing in Minnesota (45%)

SOURCES OF INFORMATION ABOUT THE DNR

- 1) The most common source of information comes from newspapers and television
- 2) Least common sources include telephoning a DNR office, the VOLUNTEER Magazine and citizen groups

OPINIONS REGARDING POTENTIAL DNR SERVICES

- 1) Responses to these questions are very much the same as the 1988 survey. Residents tend to express opinions that show concern for preserving Minnesota's natural resources.
- 2) Same questions different wording
 - * The DNR should cut more timber in response to forest industry needs (68% disagree)
 - * The DNR should manage forests to meet consumer demands for forest products (26% disagree)


3) Half agree that the DNR should create more camping opportunities

* A special tax on recreation equipment should be charged (45%)
* The DNR manages enough habitats for wildlife (36%)


PARTICIPATION IN ACTIVITIES
