Hi Steve-

I have been thinking about the "Pike Mountain" area a lot lately while working on npc mapping in the preliminary Outstanding MCBS Site. In particular, I have been thinking about the large chunk of private land right in the middle of this Site (primarily owned by the developer- Leonard Land Co). Here are some field observations regarding the private land adjacent to the Pike Mountain cRNA (T 59N, R16W, S31):

The mature mesic hardwood forest along the slope is definitely one of the nicest MH forest stands of the LTA and subsection (A-AB rank). Even though it is rocky, it has a decent duff layer and based on my field points- no obvious evidence of earthworms (would probably rank 1-2 IERAT?). I observed a new Goshwawk nesting location in this stand. The property also includes a cliff feature and most of the associated rock outcrop (the size and quality of these features is rare for this subsect). I also came across a small grove of large old pines near the wetland transition- could be FDn43a old growth (~2-4 acres?)?

I think the PM protection boundary that was delineated for the white paper pretty accurately reflects the highest quality portion of the private land in that section.

Hi all-

I haven't seen the Northmet tract boundaries, but based on Steve's description, it sounds like the Hay Lake tract has significant overlap with an MCBS preliminary survey site that will likely be the only "Outstanding" Site of Biodiversity Significance in the Nashwauk Uplands Subsection. The "Pike Mountain draft site boundary" depicted in the white paper highlights the area of highest priority for conservation action, including a "potential" scientific and natural area (includes lands in T59N R17W S25, 26, 35, &36 and T59N R16W S30 &31 and State, Federal, and private ownership).

FYI, the EE being drafted covers a large landscape unit of ~40,000 acres that includes the MCBS preliminary "Outstanding" site (and "Pike Mountain draft site") as well as three contiguous sites with preliminary ranks of "High". The native plant community mapping for this large unit is one of my primary work goals this winter.

Peggy,

The Northmet tract known as Hay Lake overlaps with what I would call a "potential" scientific and natural area. The federal land on the southwest boundary of the Hay Lake tract is a candidate RNA. Thus, for quite a few years, we've been in discussion with Forestry, Wildlife, and L&M about establishing an SNA on the adjacent state land. If that were to come to pass, we would also look at other private lands within the Pike Mountain draft site boundary shown on the attached white paper for inclusion in the SNA. These include some lands in the SW corner of the Hay Lake tract. Further internal discussions await the completion of the EE being worked on by Rebecca Holmstrom. I've copied her on this in case she has anything to add.
