#### SUMMARY

In fiscal year 1994 the Minnesota Department of Natural Resources, Division of Enforcement, Special Investigations Unit accounted for the disbursement of approximately 1.09% of the Division's budgetary allotment. The Special Investigations Unit conducted all activities utilizing two Conservation Officer part time investigators and an Area Supervisor temporarily assigned the Unit Team Leader position. During this period:

- An unprecedented nationwide application procedure and subsequent testing process resulted in the hiring of two specialized full time Investigators to fill vacancies created by retirement and voluntary resignation
- \* The Special Investigations Unit conducted a two week training program providing twelve Conservation Officers the ability and authorization to conduct part time covert investigations
- \* The Unit hosted the annual Midwest Natural Resources Covert Investigator's seminar providing three days of training and information to over seventy wildlife enforcement investigators

# Enforcement related activities during fiscal year 1994 included but were not limited to the following:

- \* Investigation into the illegal commercialization of perch by winter anglers on Lake Winnibigoshish resulting in fines exceeding \$20,000 for gross overlimiting and the issuance of fraudulent licenses
- \* The conclusion of a two year cooperative covert investigation resulting in federal indictments filed on ten defendants for Lacey Act felony violations relating to the illegal sale of walleye. In addition, state and tribal complaints have been filed on twenty additional defendants for similar violations
- \* A covert investigation and subsequent conviction of illegal taxidermy operations resulting in state/federal charges filed and fines exceeding \$5,000
- Additional investigations of 43 cases involving unlawful natural resource commercialization. The Special Investigations Unit had a 98% conviction rate for the cases which were prosecuted.
- \* Investigation of six cases involving license fraud, also resulting in a 100% conviction rate.
- \* Receipt, review, maintenance and associated enforcement of commercial records statutes pertaining to commercial license holders. These included:

- Administration of the Division's forensic research and forensic testing program. During the past year 110 samples associated with the securing of evidence in criminal cases were custodied from the Special Investigations Unit to University of Minnesota pathobiologists for forensic analysis. Research is continuing with DNA testing procedures on whitetail deer.
- \* Performed 22 Division of Enforcement applicant background checks and 2 background checks for outside agencies.

- \* Assisted many city, county, state and federal agencies in cooperative investigations. The Special Investigations Unit was instrumental in the recovery of four stolen snowmobiles, one watercraft and one automobile. Four felony arrests and convictions for possession of stolen property resulted.
- \* Maintaining the Division of Enforcement's statewide intelligence information system.
- Providing assistance on many occasions to Conservation Officers with specialized equipment, surveillance, investigations and interview techniques.
