### Legislative charge

Minn. Stat. § 116.03, subd. 2b.

### **Report to Legislature**

The commissioner shall prepare an annual permitting efficiency report that includes statistics on meeting the goal in paragraph (a) and the criteria for Tier 1 and Tier 2 by permit categories. The report is due August 1 each year. For permit applications that have not met the goal, the report must state the reasons for not meeting the goal. In stating the reasons for not meeting the goal, the commissioner shall separately identify delays caused by the responsiveness of the proposer, lack of staff, scientific or technical disagreements, or the level of public engagement. The report must specify the number of days from initial submission of the application to the day of determination that the application is complete. The report must aggregate the data for the year and assess whether program or system changes are necessary to achieve the goal. The report must be posted on the agency's Web site and submitted to the governor and the chairs and ranking minority members of the House of Representatives and Senate committees having jurisdiction over environment policy and finance.

## **Executive summary**

For the review period of July 1, 2015 – June 30, 2016, the MPCA:

- Issued 97% of **priority** air, water and land permits (tier 1 and 2) within goal timeframes.
- Issued 40% of **non-priority** air, water and land permits (tier 1 and 2) within goal timeframes.
- Issued 74% of **all** air, water and land permits (tier 1 and 2) within goal timeframes.
- Received 31% fewer permit applications compared to last year (4528 in 2015 and 3120 in 2016).
- Returned 53% fewer applications as incomplete compared to last year (69 in 2015 and 32 in 2016).

The MPCA's overall permitting efficiency continues to be very good – especially on the most important (also called priority) permits. These are the permits that represent economic growth and new job opportunities for the state. We did see a decrease in our overall permitting timeliness compared to last year for all permits (priority and non-priority) issued as well as for non-priority permits. This was anticipated as we continue to dedicate significant resources to build and train staff on our new data management and permitting system (Tempo). Once complete, we expect that productivity will exceed the levels experienced prior to initiating the project. We also expect permittees to be pleased with the Tempo system as it includes many new on-line services which will allow them submit and retrieve information electronically.

We received fewer applications during this review period which may be the result of a slow-down in the construction of new homes and businesses, therefore reducing the need for construction and industrial storm water permits.

Finally, the MPCA returned fewer applications (as incomplete) this review period compared to last year. The quality of the application has a direct impact on permit timeliness and, therefore, we have worked very hard over the last few years to provide application guidance and assistance to permittees. The reduction of returned applications indicates that permittees are doing a better job of completing the forms.

## Background

This report results from concerns expressed about the length and uncertainty associated with regulatory processes, including environmental review and permitting. In 2010, the Legislature directed the Office of the Legislative Auditor (OLA) to review the environmental review and permitting programs of the Environmental Quality Board, the MPCA, the Minnesota Department of Natural Resources (DNR) and local units of government.\* A range of businesses and elected officials suggested that the structure and process of permitting at that time was negatively impacting the business climate and economic growth in Minnesota. Permitting and environmental review process reform was identified by those raising concerns as an important step for Minnesota state government to facilitate job creation in the state.

To address these concerns, Governor Dayton issued Executive Order 11-4 (EO11-04) on January 24, 2011. The Executive Order requires MPCA and DNR to adopt a 150-day goal for reaching a permit decision following the determination by the appropriate agency that the permit application is complete. This same goal is reiterated in Session Laws 2011, Chapter 4, codified in Minn. Stat. § 116.03 except that the law requires that the 150-day goal and indicates that the time begins upon the initial submission of an application instead of when the application is determined to be complete. This law is referred to as the Permitting Efficiency Law, and requires, among other things, the MPCA to determine, within 30 business days of receipt of a permit application, whether the application is substantially complete, and to inform the applicant of the deficiencies if the application is incomplete. The Permitting Efficiency Law also required the MPCA and the DNR to submit semi-annual reports to the Governor and the Legislature on August 1 and February 1 of each year. The Permitting Efficiency Law was changed in the Legislature in 2014 to change the reporting requirement to annual reports due on August 1 to the Governor and the Legislature. The Law also established Tier 1 and Tier 2 permit categories. Tier 1 permits are permits that do not require individualized actions or public comment periods. These permit types have a 90-day issuance goal. Tier 2 permits are permits that require individualized actions or a public comment period, and have a 150-day issuance goal. The list of permit types in each tier can be found in Appendix A. This law was effective on January 1, 2015; the permit applications received prior to this date are included in the "Tier 2 or none" categories in this report.

## MPCA's Environmental permitting programs

The MPCA manages more than 15,000 air, water, and land permits. Most permits are issued for a period of five years although a few permit types are issued for 10 year terms or are non-expiring. Permits are issued to businesses, governmental units, and individuals, and cover a wide range of facilities and activities. Permits are required for the construction and operation of facilities that discharge or emit (or have the potential to discharge or emit) specifically defined pollutants and for certain activities.

With few exceptions, the MPCA almost exclusively implements federal regulatory programs on behalf of the U.S. Environmental Protection Agency (EPA), as the EPA's delegated authority. Without this delegation, many of the current permittees we serve and new applicants would be required to seek necessary permits directly from the EPA, Region 5, which is based in Chicago. While many of the requirements of these environmental permits are mandated by federal regulations, state laws and the MPCA's permitting processes often allow for increased flexibility and customer assistance, which results in greater overall efficiency than otherwise achievable working directly with the EPA.

Regardless of whether the permit is authorized under federal or state laws, most permits must undergo a rigorous public participation process to ensure that interested parties (from citizens to other governmental units) have an opportunity to provide input. This process requires a public notice of the draft permit – usually 30 days – and may include public meetings or hearings. The MPCA must review, consider and respond to all written comments received and revise draft permits, where appropriate. While this public participation process provides valuable public insight to the final permit, it may also add time to the permit review and issuance process.

To reduce time when possible, the MPCA uses a variety of permits to provide flexibility as well as to meet the needs of the regulated community. The use of general and registration permits allows the MPCA to cover similar facilities under a standardized permit (standardized requirements). For most general permits, there is only one state-wide public notice period; therefore, applicants that qualify do not need a public notice for their specific facility. Facilities that qualify for a general permit receive their permit much faster than those needing an individual (facility-specific) permit.

Types of permits issued by the MPCA include:

**Air permits** – Individual, general, and registration permits for facilities that emit defined air pollutants such as particulate matter, sulfur and nitrogen compounds, and carbon monoxide. Permitted facilities include power plants, refineries, manufacturing plants and dry cleaners.

Water permits – Individual and general permits for facilities that discharge pollutants such as treated sewage, sediment, residual chlorine, and phosphorus to surface and groundwaters of the state. Permitted facilities include animal feedlots, municipal and industrial wastewater treatment facilities, stormwater conveyance systems from construction projects, industrial sites and municipalities, and extensions of sewer systems.

Land permits – Individual and general permits for facility operation to prevent or minimize the release of pollutants such as landfill leachate, oil, gas, and other hazardous materials. Permitted facilities include municipal and industrial waste transfer stations and landfills, facilities that have below and above-ground storage tanks, and hazardous waste storage and treatment facilities.

# Priority permits

The mission of the MPCA's permitting programs is to protect and improve the environment and enhance human health as well as support jobs and economic development in the state. To achieve this goal, it is the MPCA's policy to prioritize permits for new or expanding projects which typically represent new economic opportunities and jobs. These "**priority**" permits are typically defined as needing some sort of construction at the site. A new permit or the significant modification of an existing permit is required for these projects. Often these are the most technically complex and controversial projects and, therefore, require more time to issue. The remaining projects (called "**non-priority**" permits) are generally routine permit re-issuances that do not require substantive changes or involve construction and, therefore, are typically less time-sensitive to permittees. Permittees covered under these existing permits are allowed to continue to operate until such time as MPCA staff can be assigned to work on their permit reissuance.

## Improvement efforts

The MPCA is in year three of a four-year project to overhaul its data and information management systems. The Tempo system, once complete, will:

- Improve business operation efficiency by lessening the need for paper transactions.
- Create flexibility to more readily allow the integration of new technologies.
- Improve access to quality data for partners and citizens.

The major effort — the Transformation Project — focuses on the data and information management systems that support the MPCA's environmental and regulatory programs.

As the MPCA moves to a new information management system, we will be increasing the number of online services offered — from 10 currently to 21 when the project is complete. The first set of new and revised services was released in the fall of 2015. The final set of on-line services, including air modeling and Title 5 air permit reissuances, will be released in the fall of 2016.

The MPCA is also using this as an opportunity to standardize its business functions. For example, the MPCA currently has more than a dozen permitting programs, each with its own process for applying for and obtaining a permit. By mapping out each of the processes, staff members found ways to standardize and streamline each process where possible to improve efficiency and provide more transparent service delivery to applicants. By standardizing business practices and providing more online services, the MPCA hopes to provide faster and more efficient service to the parties it permits, regulates and partners with.

In addition, the MPCA's updated system will allow the MPCA to combine information currently stored in several databases. This will reduce the staff time needed to maintain these various databases, as well as allow staff to get a more complete picture of all the activities occurring at a site or facility.

MPCA permitting staff has been using the new "Tempo" system for about six months and, as expected with any new data system, we have seen a drop in productivity. However, staff proficiency continues to increase rapidly and we expect to be back up to, and exceeding pre-Tempo productivity levels within a year or so. We also expect that permittees will be pleased with the new system as it includes many new on-line services which will allow them to more easily submit and retrieve permitting information. Additional information about the new Tempo system can be found on the MPCA website.

While this bigger effort is underway, the MPCA continues to design and implement smaller continuous improvement projects. For example, the MPCA recently issued a general permit for small, low emitting facilities. General permits are created for lower-risk permits and are less expensive and require less

testing than individual permits. The goal is to decrease the regulatory burden on the smaller painting and sanding businesses that qualify for this general permit.

In another project, the MPCA streamlined the process for approving chemicals used by municipalities and industries in the treatment of wastewater. This project was initiated in response to concerns from permitted facilities and MPCA staff. It included creating a list of pre-approved chemicals commonly used by facilities. For new chemicals, the MPCA streamlined our review and approval process from more than 60 days to less than 5 days.

## Data

Since the Permitting Efficiency Law became effective on March 4, 2011, the MPCA has collected the permitting data required by the law. Previously, semi-annual reports were required. New legislation in 2014 changed the reporting requirement to an annual report due August 1 of each year. The legislation also established two categories for permits, with separate goals for permit issuance. Table 1 below summarizes permitting data only for the current review period, as required by law. Table 2 summarizes data going back to March 4, 2011, and is intended to provide a broader perspective. This is important as most permits are issued for a period of five years – sometimes longer. As such, the benefits of many of the process improvement efforts by the MPCA today may not be evident for several years. It is, therefore, challenging to draw conclusions about the overall timeliness of the MPCA's permitting programs based on a short-term "snap shot." Shorter time periods are influenced by such factors as changing or unresolved federal regulations and the economy – making it difficult to compare one review period to the next. The MPCA continues to make day-to-day changes with the goal of providing measureable, consistent, long-term improvements.
