Subject: Semi-annual Appointment Report, January 1 - June 30, 2016

The attached semi-annual Appointment Report (required under Minnesota Statutes 43A.04, Subd. 7) shows that there were 3,140 appointments across all job categories January 1 – June 30, 2016. This number is a 15% decrease from the same period last year. The biggest decrease in appointments are in the following categories:

- Competitive Open (-214, 20% decrease from prior year)
- Temporary (-165, 23% decrease from prior year)
- Trainee to Probationary Status (-94, 92% decrease from prior year)

An appointment is a count of jobs, not people. This report does not reflect the actual number of new employees hired because one person may have several different types of appointments throughout the reporting period.
