The DNR has used these funds to conduct a number of activities on the site including restoration of areas to native species, invasive species control, trail system establishment, fencing removal, and reforestation of areas damaged by a major blowdown in 2012.

Protection of the La Salle Lake property was a high priority for multiple stakeholders. It was the number one priority for the DNR Northwest Region in 2010-2011, which had sought to protect it for over a decade. The acquisition also enjoyed strong local support including unanimous approval from the Hubbard County Board. Numerous organizations and individuals provided letters of support including: the Park Rapids Area Chamber of Commerce, the Hubbard County Coalition of Lake Associations (COLA), the Minnesota Deer Hunters Association, Trout Unlimited, and the Audubon Society.

Acquisition of the La Salle Lake property successfully seized a rare opportunity to protect a large area of habitat of regional and statewide significance that includes the entirety of Minnesota's second deepest lake, a coldwater stream, high-quality forest and wetlands, and over a half mile of Mississippi River shoreline. The property is ranked as having Outstanding Biodiversity Significance by the Minnesota County Biological Survey (MCBS). It also provides excellent recreational opportunities for hunting, fishing, hiking, camping and wildlife observation. The acquisition furthers the goals of multiple state conservation plans and connects large parcels of land already in public ownership preventing forest fragmentation and guaranteeing wildlife large landscapes in which to roam. This unique and important habitat was at risk of development and was listed for sale until The Trust for Public Land obtained an option to purchase the property and ultimately conveyed it to the DNR for permanent stewardship.

This newest State Recreation Area has now operated successfully for two seasons and is used and enjoyed by many people. The DNR is currently working on further visitor services, interpretation and day use area development.

A. Project Partners:

The Trust for Public Land (TPL) will be facilitating the fee-title acquisition and assisting the Minnesota DNR in development of management plans. TPL has a proven track record of successful management of complex and time-sensitive real estate projects. Because of the immediacy of this rare real estate opportunity, TPL has offered to help and the Minnesota DNR has encouraged the partnership. The Minnesota DNR will be the final fee-title holder and will be developing and implementing the management plans for the site. This project will have many other partners throughout the process including the landowner, local governments, educational institutions, environmental non-profits, local businesses and local sportsman groups.

B. Project Impact and Long-term Strategy:

La Salle Lake State Recreational Area will provide nearly one thousand acres of rare habitat and unique terrain for Minnesotans and other visitors to enjoy for generations to come. The La Salle Lake property will provide a connection to the Itasca State Forest, the Mississippi Headwaters State Forest as well as other publicly owned lands surrounding the property. An innovative DNR multiple-division Management and Recreational Use Plan is being developed and will be implemented once the property is acquired. An Operations and Maintenance Plan that identifies potential future sources of funding will also be developed to ensure La Salle Lake will be a well-managed, viable resource for Minnesota.

C. Spending History: Funding for the Phase I La Salle Lake acquisition, which closed in December 2010, consisted of \$585,000 of 2010 Outdoor Heritage Fund, \$337,299.80 RIM, and \$17,700.20 Lakeshore Lease (SNA).
