### **Sound bite of Project Outcomes and Results**

The Trust for Public Land protected approximately 20 acres as an addition to the Minnesota DNR Crystal Spring SNA in Washington County. This strategic property will provide significantly safer public access to the SNA and contains high quality native plant communities and several rare species of birds and plants.

### **Overall Project Outcome and Results**

Located only 30 miles northeast of the Twin Cities in Washington County, Crystal Spring Scientific and Natural Area (SNA) offers the region's 3.3 million residents a close-to-home opportunity to experience unique flora and fauna and beautiful views of the National Wild and Scenic St. Croix River. Acquired and created with help from The Trust for Public Land in 2015, the original 38-acre, state-owned SNA encompasses significant biodiversity, thriving communities of native plants, and habitat for several rare species of birds and plants. The SNA's dramatic geologic features include a scenic waterfall, steep rocky cliffs, a winding cold-water stream, thick old forests, and panoramic views of the National Wild and Scenic St. Croix River.

Utilizing the M.L. 2015 ENRTF MeCC appropriation, The Trust for Public Land acquired an additional 20.98 acres which it conveyed to the Minnesota DNR on October 24, 2018 as an addition to the Crystal Spring SNA. The Crystal Spring SNA Addition North property provides significantly safer public access to the SNA, and the land contains high quality native plant communities and several rare species of birds and plants.

Due to the funding provided by the Environment and Natural Resources Trust Fund as recommended by the Legislative Citizen Commission on Minnesota Resources, and the Reinvest in Minnesota Program (RIM), the 68 acre Crystal Spring SNA is permanently protected and available for all Minnesotans to enjoy.

**Appropriation Language:**

\$750,000 the first year is from the trust fund to the commissioner of natural resources for an agreement with The Trust for Public Land for the eighth phase of the Metropolitan Conservation Corridors partnership to acquire in fee at least 35 acres of high quality priority state and local natural areas in the metropolitan area, as defined under Minnesota Statutes, section 473.121, subdivision 2, and portions of the surrounding counties. A list of proposed acquisitions must be provided as part of the required work plan. Land acquired with this appropriation must be sufficiently improved to meet at least minimum management standards, as determined by the commissioner of natural resources. Expenditures are limited to the identified project corridor areas as defined in the work plan. This appropriation may not be used for the purchase of habitable residential structures, unless expressly approved in the work plan. A list of fee title acquisitions must be provided as part of the required work plan. This appropriation is available until June 30, 2018, by which time the project must be completed and final products delivered.

## **I. PROJECT TITLE: Metropolitan Conservation Corridors Phase VIII – Strategic Lands Protection**

### **II. PROJECT STATEMENT:**

The Trust for Public Land will protect through fee title acquisition approximately 35 acres of high quality habitat and 0.2 miles of shoreline within the greater Twin Cities Metropolitan Area. These lands have been identified and prioritized through state, regional and local natural resource plans due to their high biodiversity, connectivity, and ability to create corridors for wildlife movement.

In the Twin Cities Metropolitan area and surrounding counties, opportunities to protect priority conservation lands decrease daily because lands are being developed and land values are escalating – particularly for properties adjoining already protected lands or for those that have lakeshore and river/stream frontage with high natural resource values. Communities are facing challenges to protect and restore these areas, while also providing access to enjoy natural areas close to home.

To address these challenges, The Trust for Public Land is strategically focusing its conservation efforts on protecting remaining high priority natural areas in the Metro Area – particularly in Washington and Chisago Counties. Within the Metro Conservation Corridors Partnership, key corridors have been identified through science-based classifications and Geographic Information System (GIS) mapping. The goals of The Trust for Public Land’s Strategic Land Protection Program are:

- To protect lands and waters within targeted high-biodiversity focus areas – including along streams, rivers and lakes -- that are imminently threatened by fragmentation, conversation, degradation or sale – and that are currently not eligible for other protection funding due in large part to hunting requirements
- To create corridors of habitat to facilitate the movement of wildlife
- To create close-to-home opportunities for outdoor recreation, wildlife viewing, photography, fishing and other experiences for Minnesotans

By permanently protecting these strategically selected lands, multiple long term benefits will be achieved:

- Provision and protection of high quality habitat for migrant and resident wildlife species
- Resilience of native animal and plant populations (including “Species in Greatest Conservation Need”) in the face of climate change and invasive species, due to improved ecosystem connectivity
- Protection of our lakes, rivers and streams and improved quality of our ground water
- Increased access to outdoor recreation and enjoyment in the Metro Area where nearly 60% of the state’s population lives, and is projected to increase by 28% over the next 30 years

The Trust for Public Land is targeting strategic parcels in the following areas of Washington and Chisago Counties with the highest capacity to provide benefits to wildlife, humans, and water quality; adjacency to already protected land; and landowner willingness to sell for conservation purposes:

- St. Croix/Franconia Bluffs SNA and Crystal Spring SNA Additions: In the St. Croix Valley in Washington and Chisago Counties, The Trust for Public Land is building on its past successful protection partnership with DNR’s SNA program to protect critical habitat in this important ecological corridor as defined by DNR’s Division of Ecological Services. The St. Croix has been identified in Tomorrow’s Habitat for the Wild and Rare plan as having the greatest concentration of “Species of Greatest Conservation Need.” Priority is land of high biodiversity significance and sensitive ravines that impact water quality leading into the St. Croix National Scenic Riverway. Land acquired would be added to Franconia Bluffs SNA or to Crystal Spring SNA.

- **Keystone Woods and Carnelian Creek Area:** In the forested areas of northern Washington County, The Trust for Public Land is working with landowners to protect lakeshore and high biodiversity wetlands and uplands. The MCBS has identified large portions of this land as having high biodiversity significance, including aspen-oak stands, oak openings and barrens, Big Woods, wet prairie, conifer bogs and swamps. MNDNR's Natural Heritage Database contains fourteen records of rare plant communities, plant species and animal species, including Blanding's turtle and Red-Shouldered Hawk. These areas are a high priority for protection for Washington County. The Keystone Woods Area could either become a new SNA or County park land. The Carnelian Creek Area would become County park land.

#### **IV. PROJECT ACTIVITIES AND OUTCOMES:**

**ACTIVITY 1:** Strategic protection of fee title lands in the greater Twin Cities Metro Area, specifically Washington and Chisago Counties

**Description:** Acquire land in fee title and convey it into public ownership for stewardship and protection. Please see attached Acquisition List showing the lands that may be acquired in part with funding from this request. TPL will prioritize potential land protection projects within the Metro Conservation Corridors based on the priorities established by the public agencies with which we work and on landowner willingness to sell. TPL will provide references to adopted plans in which acquisitions have been included. Priority will also be given to high quality natural resources and on lands that provide natural buffers to water resources. We will also consider resource mapping, stakeholder suggestions, and joint recommendations made by the coalition of groups involved in this overall effort. TPL will work with the long-term steward to ensure a restoration and management plan consistent with the highest quality conservation and ecological goals for the site is developed and that funding is identified for creation of a management plan.

For each fee title acquisition, TPL will:

1. Seek County board approval for each acquisition going to DNR
2. Ensure a restoration and management plan is prepared for each acquisition

3. Identify funding source to implement such plans
4. Provide or have the final title holder provide an analysis of increased operations and maintenance cost likely to be incurred and how these costs will be covered

Unless necessary to protect priority lands and subject to work plan amendment at that time, TPL will not acquire residential structures. Prior to acquiring property, The Trust for Public Land will also (a) obtain written permission from the commissioner of natural resources, and (b) submit the most recent tax assessed value and most recent tax statement for the property and the amount intended to be offered for the property to the commission and the commissioner of natural resources.

**VII. PROJECT STRATEGY:**

**A. Project Partners:** The Trust for Public Land partners with the Metro Conservation Corridor organizations as well as with towns, counties, lakeshore associations, citizen groups and others to successfully acquire and permanently protect land. Agencies specifically ask for our help with protections because they lack staff, resources and capacity to do so. In the parcels identified above, the likely long term stewards will include: Washington County, and the DNR-SNA.

**B. Project Impact and Long-term Strategy:** These fee title acquisitions are part of a larger strategy of the Metro Conservation Corridors Partnership to conserve high quality habitat and connect corridors in the high growth area of Minnesota. The work of The Trust for Public Land and the MeCC Partnership is informed by state, regional and local plans to protect habitat and water quality. Conserving high quality habitat in the Metro area will require sustained effort for at least a generation. Metro Conservation Corridors Partners will continue to leverage funding and coordinate resources to achieve the long term vision of clean water and protected, restored land close to home for most Minnesotans. For every \$1.00 spent in ENRTF funding, the MeCC Partnership has leveraged \$3.76.

To date, the MeCC Partnership has protected over 11,000 acres, and 28 miles of sensitive shoreline. There are still over 80,000 acres of regionally significant natural areas in the Metro Region that are unprotected. The Trust for Public Land will continue its work as long as critical habitat close to where so many Minnesotans live, work and play remains unprotected and in danger of degradation and loss.

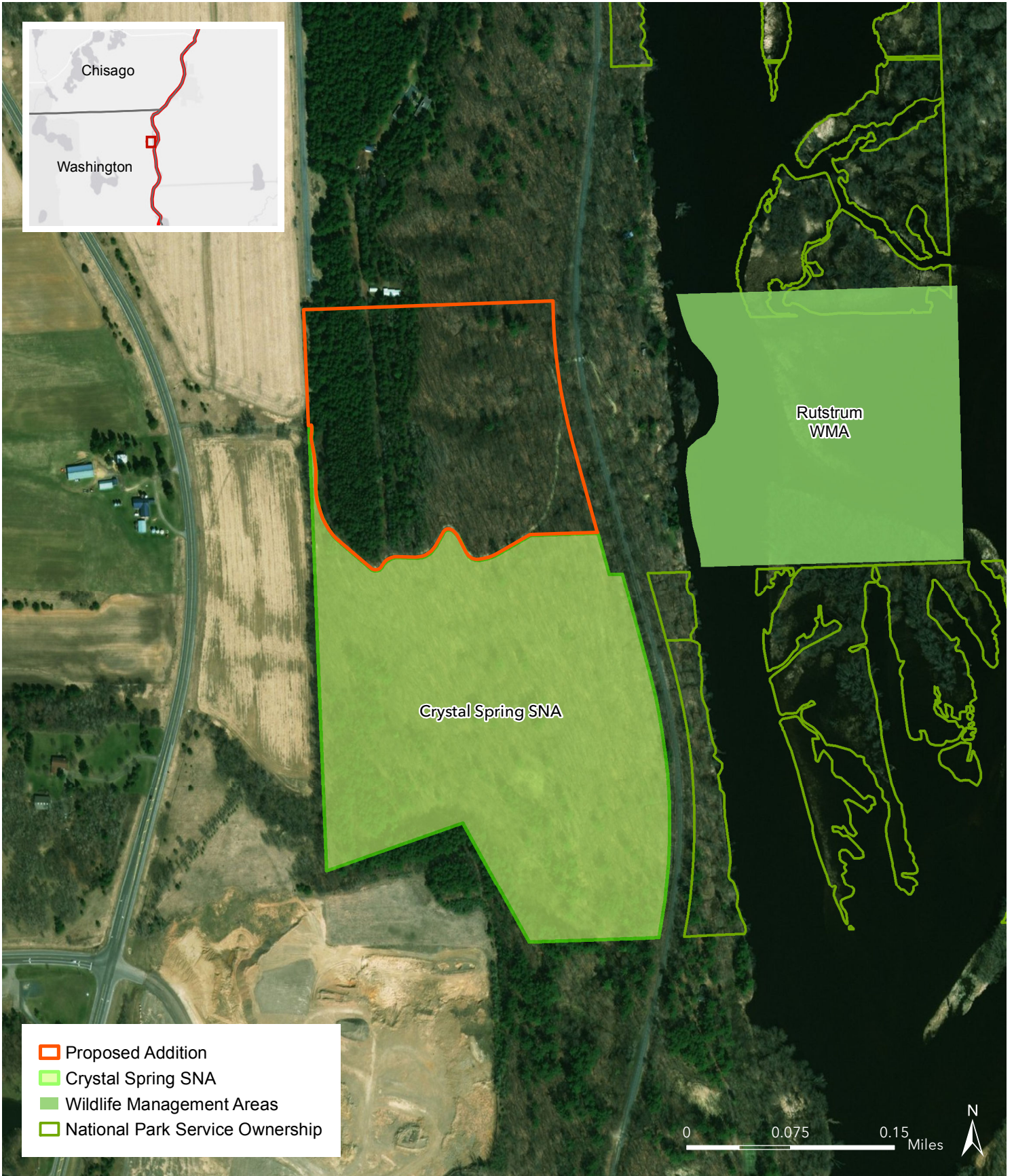
