Executive summary

The Minnesota Department of Human Services (department), consistent with federal requirements, ^{1,2} conducts a statewide survey of prices charged by licensed family child care and licensed center child care providers. The market rate survey is a component of the Minnesota Child Care Provider Business Update.

Based on prices reported on the survey, counties are grouped into price clusters by provider type. Price data is analyzed separately for licensed family child care and licensed center-based child care. All prices reported by providers in the counties that form a price cluster are grouped for analysis and survey results apply to the entire price cluster.

Separate results are generated for hourly, daily and weekly prices in four age groups. The 50th percentiles and 75th percentiles of provider prices are reported here. The 50th percentile (median) is the price where one-half of the prices are higher and one-half are lower. The 75th percentile is the price where three-quarters of the prices are lower and one-quarter are higher.

Although results are used to inform setting of maximum rates paid for care under the Child Care Assistance Program, results in this document are distinct from these maximum rates. Current Child Care Assistance Program maximum rates were set by the Minnesota Department of Human Services, based on legislative direction and effective on Feb. 3, 2014. These maximums are based on the higher of the 25th percentile of the 2011 market rate survey results, or the maximums in place on Nov. 28, 2011.³




