Introduction

The 1998 Legislature enacted a law requiring school district superintendents to annually report projected costs associated with student passage of the Basic Standards tests required for high school graduation. Minnesota Statute 123B.143, Subdivision 1 states that school district superintendents must:

"(5) by January 10, submit an annual report to the commissioner in a manner prescribed by the commissioner, in consultation with school districts, identifying the expenditures that the district requires to ensure an 80 percent and a 90 percent student passage rate on the basic standards tests taken in the eighth grade, identifying the amount of expenditures that the district requires to ensure a 99 percent student passage rate on the basic standards test taken by 12th grade, ... "

This report is a compilation of the information provided by the school districts, which describes the data submitted and also summarizes some of the other information supplied by the districts.

Information Required by Report

A copy of the Superintendents' Annual Report on Projected Expenditures and Student Passage Rates can be found at the end of this report as Appendix A. The report required two sets of estimates. Part I estimates are considered short-term and identify the annual expenditures required to attain the target passage rates by FY 2002. Part II estimates are considered long-term and should identify annual expenditures required to attain the target passage rates over a longer period of years. The number of years considered to be long-term was left to the discretion of the school districts. Estimated expenditures were to include what the district requires to provide all school district programs in the general, food service, community service and debt service funds, meet all state requirements including full implementation of the Profile of Learning for the 2001-2002 school year, and attain the target passage rates on the basic standards tests in the 8th and 12th grades. The report assumes the score required to pass the basic reading, math and writing test (by 12th grade only for writing test) will remain at 75 percent correct, and that current requirements for students to participate in basic standards testing will remain unchanged.

If unable to attain the target passage rates, school districts were asked to report the maximum passage rate the district expects to attain given the level of expenditures reported. The districts were requested to submit an explanation of the demographic and other factors contributing to the district's expectation that it will not be able to attain the target passage rate.

School District Responses Concerning Limitations on Projecting Cost Factors

The vast majority of school districts did submit data as requested. However, a substantial number of school districts cited objections to providing the estimates required in the report, or explained their difficulties in predicting such cost factors.

Limitations of Reported Data

The reported data has limitations that make comparisons across school districts difficult. The report was designed to be somewhat open ended, in that the design of the report gave districts a fair amount of latitude in determining how to complete the report. Although a large number of school districts provided supporting documentation for the cost estimates, many more did not; moreover, it was not a requirement of the report. In compiling this data a number of limitations to the data were noted. Some of these limitations are discussed below.

1. Although the instructions on the report specified that an estimate of the full costs of implementation of the Profile of Learning be included, it is not clear how many districts included these costs as part of the overall estimates.
2. While the reporting instructions called for districts to report total expenditures needed to reach the specified student passage rates, school districts used a variety of methods in allocating costs to the six tables of the report.
3. Additional expenditures needed to achieve a 99% target passage rate by 12th grade do not necessarily imply that a particular target passage rate at the 8th grade level need first be met. For example, a district may include additional resources for meeting the 12th grade target passage without any consideration of achieving an 80% or 90% passage rate at the 8th grade level.

Data Analysis

Detailed school district tables by each part can be found in Appendix B. Information included on each table is the district's projected passage rate, total projected expenditures by each fund, and projected expenditures per ADM. In addition, a discussion of the districts included in the analysis follows. The data analysis for each part is also summarized.

School Districts Included in Analysis

A total of 331 school districts were included in the analysis. Districts that didn't serve grades 8-12 were not required to submit a report. Therefore, they were excluded from the analysis. The districts are as follows:

In addition to the districts that are excluded entirely from the analysis, many districts for a variety of reasons chose to omit data for one or more parts of the report. The most typical pattern of response was to complete tables associated with 8th grade passage rates (parts IA, IB, IIA, and IIB) but leave blank the tables associated with the 12th grade passage rates. Another typical pattern was to complete the short-term section of the report, but leave long-term tables blank. A district responding that it could not meet the target passage rate specified on a given part may also leave the corresponding expenditure table blank. Of the 331 school districts that completed the report and supplied data, a total of 5, 40, 35, 10, 44 and 38 districts, respectively, omitted data for parts IA, IB, IC, IIA, IIB and IIC.

Part IA: 80% Passage Rate by 8th Grade, Short-term

Of the school districts reporting, 326 reported data for this part. Of those, 292 districts or 90% expect to attain the 80% target passage rate. Of the remaining 34 districts, 27 expect to attain at or above a 70% passage rate and the remaining districts at or above a 50% passage rate.

Data from Part 1A, 80% passage by 8th grade short-term, are grouped by strata in Table 1. This table shows current and projected expenditures per ADM (for all funds), projected passage rates, current 8th grade test scores and average concentrations for several demographic factors. There is a clear difference in projected passage rates between urban and suburban school districts, with both Minneapolis and St. Paul reporting less than the 80% passage rate, while only 4% of suburban districts fall into that category. Ninety percent or more of the outstate school districts of all size strata except the 1,000-1,999 category reported that they could attain an 80% student passage rate.

The average additional projected cost per ADM was \$601. Generally, the largest and smallest school districts show a tendency toward higher expenditures per ADM, both in terms of total expenditures and additional costs, with metro suburban districts and outstate school districts in the >2000 category reporting significantly lower projected additional costs.

Part IB: 90% Passage Rate by 8th Grade, Short-term

Of the 291 school districts reporting for Part IB, 205 districts or 70% expect to attain the 90% target passage rate. This is a significant reduction from Part IA. Of the remaining 86 districts, 75 districts expect to attain between an 80% to 89% passage rate, with the remaining districts falling below 80%.

Table 2 shows data from Part IB, 90% passage rate by 8th grade short-term, grouped by strata. Only the districts reporting in Part IA that indicated they would be able to attain an 80% or more student passage rate were required to complete Part IB. Therefore, Minneapolis and St. Paul did not complete this section. Of the districts responding to this part, the average projected additional cost per ADM for all districts was \$575. The additional cost patterns are similar as reported in Part IA, with the metro suburban school districts reporting lower projected additional costs and smaller districts reporting higher projected costs.

Part IC: 99% Passage Rate by 12th Grade, Short-term

Of the 296 school districts reporting for Part IC, only 175 districts or 59% expect to attain the 99% target passage rate. Of the remaining school districts, 72 expect to attain between a 95% and 98% passage rate, 49 districts expect to attain a passage rate below 95%. Of those districts, three did not expect to attain an 80% passage rate.

Table 3 shows the data from Part 1C, 99% passage by 12th grade short-term, grouped by strata. The total number of districts reporting on this part was considerably fewer than for Part IA or IB. The percentage of districts expecting to attain the targeted passage rates was also down considerably for all strata. Although most categories showed that 60% or more of the districts expected to attain a 99% passage rate. The average projected additional cost per ADM was \$1,093 with the largest and smallest school districts reporting higher expenditures per ADM.

Part IIA: 80% Passage Rate by 8th Grade, Long-term

Of the school districts reporting, 321 districts reported data for this part. Of those, 302 districts or 94% expect to attain the 80% target passage rate. This is a four-percent increase over the comparable short-term table. Both Minneapolis and St. Paul school districts expect to attain an 80% passage rate in the long-term. Of the remaining 19 school districts only four school districts did not expect to attain a passage rate of over 70% in the long-term.

Data from Part IIA, 80% passage by 8th grade long-term, are grouped by strata in Table 4. The average projected additional cost per ADM was \$1,110. As with the previous tables, the largest and smaller school districts show a tendency towards higher costs per ADM. However, the cost per ADM for the urban districts is significantly higher (\$4,748) than the next highest category, 500-999(\$896). School districts in the >2,000 and metro suburban categories reported lower projected additional costs per ADM.

Part IIB: 90% Passage Rate by 8th Grade, Long-term

Of the 287 school districts reporting for Part IIB, 224 districts or 78% expect to attain the 90% target passage rate. This is an eight- percent increase from the 90% short-term table. Of the remaining 63 districts, 54 said they expect to attain at or above an 80% passage rate at 8th grade long-term and 9 districts indicated they did not expect to make 80%.

Table 5 shows the data from Part IIB, 90% passage rate by 8th grade, long-term grouped by strata. The average projected additional cost per ADM is \$1,485. The urban districts reported the highest additional cost followed by the outstate school districts in the 500-599 category. The remaining categories reported similar projected costs per ADM.

Part IIC: 99% Passage Rate by 12th Grade, Long-term

Of the school districts reporting, 293 reported data for this part. Sixty-two percent of the districts expect to attain a 99% passage rate. This is a slight increase from the 59% of school districts reported in the comparable short-term table. Sixty-eight districts expect to attain between a 95% and 98% passage rate. Eighteen districts reporting do not expect to attain above a 90% passage rate at 12th grade, long-term.

Data from Part IIC, 99% passage by 12th grade, long-term is shown in Table 6. The average projected additional cost per ADM is \$1,631. The urban school districts reported the highest projected additional cost per ADM (\$3,832.) School districts in the >2000 category reported the lowest projected additional costs per ADM (608). The remaining categories reported similar projected additional costs.

Conclusions

As expected, attainable passage rates went up between the short-term and long-term parts as did average additional costs. Moreover, when moving through the target passage rates, whether short or long-term, expected attainment of those targets went down and average additional costs increased when moving from the 80% to 90% to 99% target passage rates.

Even so, a significant number of school districts do not feel they can attain the target passage rates no matter how much time is given and no matter how much additional expenditures are added.

Finally, there appears to be little belief among many of the districts reporting that the estimates provided are reliable, or that increased district expenditures will necessarily lead to the increases in student passage rates cited in these reports. Even if the data reporting were more standardized across the school districts, it is still unclear how comparable the information would be across districts. Any conclusions drawn from this information should be viewed with these limitations in mind.

School superintendents must:

(5) by January 10, submit an annual report to the commissioner in a manner prescribed by the commissioner, in consultation with school districts, identifying the expenditures that the district requires to ensure an 80 percent and a 90 percent student passage rate on the basic standards test taken in the eighth grade, identifying the amount of expenditures that the district requires to ensure a 99 percent student passage rate on the basic standards test by 12th grade,
