VETERANS REPORT TO THE LEGISLATURE

Minnesota State

The 2013 Legislature adopted the following language which can be found in 2013 Minn. Laws Chap. 99 Art. 2 Sec. 23 Subd. 2a (b):

Minnesota State Colleges and Universities must adopt a policy recognizing for applicants who are veterans, the applicant's veteran status as a positive factor in determining whether to grant admission to a graduate or professional academic degree program. The Board of Trustees must report to the chairs and ranking minority members of the legislative committees and divisions with jurisdiction over higher education policy and finance annually by February 15 on the number of veterans who apply for a graduate or professional academic degree program and the number accepted.

The majority of veterans that apply for admission to graduate programs at the state universities are accepted. There were 163 completed veteran applications to graduate programs in fiscal year 2016 and 154 were accepted, as shown in Table 1 below.

Minnesota State Colleges and Universities (Minnesota State) served over 10,000 veterans through instructional programs, veteran-friendly policies and support services during fiscal year 2016. This number represents a 45 percent increase from the 6,900 veterans that were served in fiscal year 2008. Minnesota State provides veteran-oriented and service member-oriented information, interactive military-to-college tools, access to military-friendly services and help. These resources are made possible by partnerships between Minnesota State and the Minnesota Department of Veterans Affairs Higher Education Veterans Program, the Minnesota Army National Guard, other branches of the armed services and state and federal agencies. Minnesota State is a corporate member of the Beyond the Yellow Ribbon Initiative. Each of the state colleges and universities is also a member of the Servicemembers Opportunity Colleges consortium and offers a wealth of campus-specific resources to veterans and service members.
