RE: Semi-annual Appointment Report, January 1 – June 30, 2017

The attached semi-annual Appointment Report (required under Minnesota Statutes 43A.04, Subd. 7) shows that there were 5,936 appointments across all job categories January 1 – June 30, 2017. This number is a 1.5% increase from the same period last year. The biggest increase in appointments were in Qualified Disabled Examination with 72 new appointments this reporting period. The increase is attributed to the Connect 700 program updates implemented October 2016.

This report only includes appointment types required under Minnesota Statues 43A.04, Sub.7. An appointment is a count of jobs, not people. This report does not reflect the actual number of new employees hired because one person may have several different types of appointments throughout the reporting period.

The following summarizes the number of appointments filled in the last three years:
