As we discussed, attached are the following revised documents, which correct a typographical error in the original document. Normally we would not send a letter such as this, and revised documents, to correct minor typographical errors. We are doing so because the typographical error is in the language that describes the mortality tables that were developed in connection with the experience study. We expect that the LCPR will formally adopt these tables based upon the descriptions in our reports.

- Minnesota Correctional Employees Retirement Fund 4-Year Experience Study for the period July 1, 2011 through June 30, 2015, initially dated July 26, 2016
- Letter regarding Proposed Assumption Changes for the Correctional Employees Retirement Fund, initially dated August 10, 2016
