The Minnesota Board of Cosmetology submits its quarterly report to the Legislature summarizing inspection numbers, the number of licensees by type, and the number of inspectors employed for the third quarter (July – September) of 2017, as required by Laws of Minnesota 2017, 1st Spec. Sess. chapter 4, article 1, section 29.

The report for the third quarter of 2017 is as follows:

- In Q3 2017, the board conducted 914 total inspections, including:
  - 757 cosmetology salon inspections
  - o 36 esthetician salon inspections
  - o 107 nail technician salon inspections
  - 14 cosmetology school inspections
- In the last year (as of October 8, 2017), the board inspected 2,240 total salons, including 2,170 existing salons (38% of total existing salons), and all 33 cosmetology schools (100% of schools).
- As of October 5, 2017, the board had the following numbers of current licensees:
  - 25,244 cosmetologist practitioners, 2,319 esthetician practitioners, 4,595 nail technician practitioners
  - 4,380 cosmetologist salons, 383 esthetician salons, 612 nail technician salons
- There are currently five inspectors employed with the board's inspections division.
