FY 2017 YEAR IN REVIEW

Minnesota has art woven into the essential fabric of its people and heritage. Its vibrant cities, towns, and rural communities so often lead national metrics of health, happiness, and education—in large part because of the state's unique culture and the value placed upon it by all sectors.

The arts challenge, spark conversation, build relationships, and reflect our selves back to us while projecting our dreams, insights, and aspirations to the world. In a state that has always prioritized the importance of the public good, the arts are an essential contributor to, and crucial measure of, the health of the state.

Minnesota's reputation as a leader owes much to the vibrancy of its arts and culture—a legacy dating back more than a century to the visionary businesspeople who helped found its major cultural institutions, and the visionary legislators who created an arts agency within state government to steward public investment in the arts. These investments have been key to many of Minnesota's great success stories, and they have paid great dividends for our state. The most recent *Creative Minnesota* study valued the economic impact of the arts in Minnesota at \$2 billion per year, and the arts are estimated to support more than 60,000 jobs in the state—and with much of this economic impact spread throughout the state, the arts provide value for *all* Minnesotans.

The arts are crucial to inspiring all the people of our state, of all ages, with an appreciation of who we are, and more importantly, a vision of what we can be.

Extraordinary Commitment

The State of Minnesota has a long history of supporting arts and culture through decades of appropriations from the general fund. In 2008, public resources available expanded greatly when the people of Minnesota passed the Clean Water, Land, and Legacy Amendment. This extraordinary measure wrote into the state constitution a significant, ongoing source of support for arts, arts education, arts access, and preservation of Minnesota's cultural heritage.

As the recipient of both general fund and arts and cultural heritage fund dollars, the Minnesota State Arts Board acts on behalf of Minnesota voters, residents, and communities. Its statewide citizen board is appointed by the Governor and approved by the Senate. Together, the board and its staff focus on outcomes, and on the responsibility for sound stewardship and conscientious fiscal management of funding to produce results for Minnesotans across the state.

The Arts Board distributes state-appropriated dollars through ten competitive grant programs, through block grants to Minnesota's eleven regional arts councils, and through other programs and services designed to bring the benefits of the arts into the lives of more Minnesotans.

These funds foster and stimulate the creation, performance, and appreciation of the arts in multiple forms and mediums throughout the state. These dollars have a direct and appreciable impact on the lives of Minnesotans through:

- Stimulating existing arts sectors and programs
- Fostering growth and new creation, leading to direct economic impact
- Reducing barriers and roadblocks for underserved groups
- Promoting conversation between the people of the state
- Communicating points of view and appreciation of differences
- Providing lifelong education and stimulation
- Exploring the many aspects and experiences of Minnesota heritage
- Maintaining Minnesota's place as a national leader and trailblazer in arts and culture
- Attracting talent to Minnesota to safeguard its future in education, business, culture, and commerce.

An Enlightened Public Investment

The State of Minnesota appropriated \$37,902,640 to the Minnesota State Arts Board for fiscal year 2017. Of that amount, \$7,530,000 came from the state's general fund and \$30,372,640 came from the arts and cultural heritage fund. This report contains highlights and stories of how these funds were granted, enhancing the lives of Minnesota residents and contributing to the health and vitality of their communities.

Grant Making

Grant making is the Minnesota State Arts Board's primary service. The Arts Board offers grant programs that are directly aligned with the priorities outlined in the Legacy Amendment to the Minnesota Constitution. During the fiscal year 2017, the Arts Board received and reviewed nearly 1,400 grant applications and awarded 640 grants totaling nearly \$26 million.

A complete list of all grants awarded is available on the Arts Board Web site at arts.state.mn.us/grants/2017/index.htm. The following are grant categories, specific examples of grantees, and their activities during fiscal year 2017.

Grants for Arts and Arts Access

Arts and arts access grants advance the Arts Board's mission of fostering greater participation in arts and culture in Minnesota. The board offers these six grant programs working toward this goal:

> Arts Access, helping identify and break down barriers that prevent underserved groups from participating in the arts

- Artist Initiative, providing grants for individual artists for creative or career development
- Arts Tour Minnesota, supporting arts programs that tour to communities through the state
- Cultural Community Partnership, enhancing the career development of artists of color by supporting collaborative projects with other artists or nonprofit organizations
- Operating Support, providing general support for arts producers and presenters, including established arts organizations, nonprofits that serve practicing artists, and arts education organizations
- Partners in Arts Participation, supplying assistance to health and human service organizations to incorporate the arts into their programs.

Arts and arts access grants have substantial and broad impact in diverse communities throughout the state of Minnesota. The following are examples of how fiscal year 2017 funds have been invested:

• **ArtReach St. Croix** received \$18,250 to collaborate with area state park naturalists to "take the show on the road" through a mobile art gallery and pop-up performance venue, inviting the region's rural residents to experience art in the landscape.

- **Chamber Music Live** of Houston received \$5,000 to host the Apollo Music Festival, a series of free chamber music concerts. Ensemble artists performed at the highest artistic level, giving local audiences access to the beauty and intimacy of live performances.
- The Minneapolis based **Children's Theatre Company** received \$108,000 to tour its production of *Seedfolks* to nine greater Minnesota communities; the play featured actress Sonja Parks portraying fourteen characters determined to build a garden in a vacant lot, performances were accompanied by engagement activities in each community.
- **The Duluth Clinic** was granted \$25,000 to collaborate with Project Lulu to provide cancer survivors and caregivers opportunities for artistic expression through writing, drawing, and movement experiences.
- The Duluth Playhouse and Scottish Rite Clinic received \$43,536 to conduct three ten-week sessions of "Stage Play: Theatre for Children

"Stage Play: Theatre for Children with Autism." This program served youth with a variety of autism spectrum and related disorders.

- The Film Society of Minneapolis/ Saint Paul was granted \$ 47,951 for Cine Latino 2016/17, a unique program of 50 Spanish-language films enhanced by off-screen community activities; this standalone event in fall 2016 was a feature of the 2017 Minneapolis St. Paul International Film Festival.
- Giving Voice Initiative of Edina was granted \$5,000 to lead a multipartner collaboration to create a unique community chorus for persons with Alzheimer's and their care partners in the Saint Paul area, and through public performance helped reduce the stigma of dementia.
- Home and Community Options of Winona received \$24,998 to work with community artists to provide

- learning opportunities and inclusive arts experiences for people with disabilities.
- **Jennifer J. Ilse** of Minneapolis was granted \$10,000 to develop and implement a community engagement project to create a new dance and theater performance about the loss of one's parents. Three to five public movement workshops were held in collaboration with the South Minneapolis Coalition for Grief Support.
- **Kairos Alive!** of Minneapolis received a \$44,562 grant to provide dance/story/song/theater performance opportunities to veterans of all ages, their families, and the extended community to enhance the well-being of all participants, respect for veterans, and new accessible arts programming.
- Penumbra Theatre of St. Paul was granted \$48,642 to pilot an accessibility program in partnership with VSA Minnesota to proactively welcome and include people with disabilities in Penumbra arts programming.

- Jon A. Solinger of Pelican Rapids was granted \$10,000 to exhibit prints and give an artist talk at three regional libraries about his Working Land project, which depicts rural workers and workplaces in his Otter Tail County neighborhood. He also researched cultural venues around Minnesota to bring his work to a statewide audience in the future.
- Vail Place of Hopkins, a program assisting people with mental illnesses, received \$21,120 to work with History Theatre professional artists to develop performance pieces based on clients' lived experiences.
- Bemidji's Watermark Art Center was granted \$47,951 to foster strategic, long-term engagement with Native

- American peoples living within, and outside of, the White Earth, Leech Lake, and Red Lake tribal boundaries.
- Kari CL Weber of New London received \$10,000 to create a series of landscape paintings that call attention to Minnesota's rural communities and agricultural spaces. The work was exhibited at the Great River Gallery in Little Falls, Kaddatz Gallery in Fergus Falls, and at the Studio Hop that takes place in Willmar, Spicer, and New London.

The Arts Board also provided operating support grants to 171 organizations including Alexandria Area Arts Association, Alexandria; Central Lakes College Theatre, Brainerd; Children's Theatre Company, Minneapolis; Duluth Superior Symphony Orchestra, Duluth; Fairmont Opera House, Fairmont; Historic Holmes Theatre, Detroit Lakes; Interact Center for the Visual and Performing Arts, Saint Paul; Juxtaposition Arts, Minneapolis; Lanesboro Arts Center, Lanesboro; MacPhail Center for Music, Minneapolis; Minnesota Marine Art Museum, Winona; Mu Performing Arts, Saint Paul; New York Mills Regional Cultural Center, New York Mills; Pillsbury House Theatre, Minneapolis; Reif Center, Grand Rapids; Saint Francis Music Center, Little Falls; TU Dance, Saint Paul.

Grants for Arts Education

These grants provide investment in lifelong arts learning across the state of Minnesota. Grant programs include:

- Arts Learning, supporting projects that build understanding and skills in arts for lifelong learners
- Community Arts Education Support provides funding for organizations and programs that make arts education more accessible to Minnesotans of all ages and artistic abilities.

The following are examples of how fiscal year 2017 funds were invested in arts education:

- **Susan Feigenbaum** of Eden Prairie received \$13,941 to teach clay classes at five communities for older adults. Independent, assisted, and memory care residents learned art concepts, art-making skills, engaged socially, and shared their learning at art exhibits open to the public.
- The Itasca Orchestra and Strings Program of Grand Rapids was granted \$7,933 to present a one-week

summer jazz camp to introduce stringinstrument students to jazz and improvisation basics.

- The MacPhail Center for Music in Minneapolis was granted \$104,170 to deepen its impact in five greater Minnesota communities through the Online School Partnership program, providing supplemental music learning opportunities through both online instruction and in-person enhancements for young people pre-K-12.
- Rochester STEM Academy was granted \$21,280 to collaborate with spoken-word poet Frank Sentwali and videographer Mike Hazard to produce stories and poems that explore the immigrant experience.
- Partnership Resources, Inc. of St. Louis
 Park was granted \$37,839 to partner with
 Potek Glass to create collaborative glass art installations, created by adults with
 developmental disabilities and others, to
 share with the public at three locations.
- White Bear Center for the Arts was granted \$30,000 to collaborate with photographic artist Wing Young Huie to work with 1,200 White Bear Lake Area High School-South Campus students in a residency utilizing photography to develop cultural awareness.

The Arts Board provided support to eleven community arts education organizations or programs that offer lifelong learning in the arts in a variety of disciplines such as: Artaria Quartet's Chamber Music School, West Saint Paul; Eden Prairie Art Center, Eden Prairie; Lake Superior Youth Chorus, Duluth; Universal Music Center, Red Wing; and Young Dance, Minneapolis.

Grants for Arts and Cultural Heritage

Grants under this category focus on building connections between Minnesotans of all backgrounds. Grant programs include:

- Folk and Traditional Arts, celebrating the ethnic and cultural traditions of artists and their work
- Minnesota Festival Support, encouraging community building and showcasing artists of diverse mediums and traditions

The following are examples of how fiscal year 2017 funds were invested in arts and cultural heritage:

- The Faribault Diversity Coalition was granted \$5,000 to collaborate with artists from the local Cambodian and Somali communities to teach Faribault youth traditional dances from those cultures.
- TaikoArts Midwest of Minneapolis received \$5,000 to bring Portland, Oregon based master artists Michelle Fujii and Toru Watanabe of UNIT SOUZOU to Minnesota for a series of workshops and performances that explored taiko drumming, Japanese folk dance, and the deep connections between the two.
- Duluth's **Leah H. Yellowbird** received \$47,960 to visit the 11 federally recognized Native nations in Minnesota, to study traditional beadwork designs, and create new beaded works representing designs from each of the 11 communities.
- The Korean Service **Center** of Lauderdale was granted \$33,680 to work with Jangmi Dance and Shinparam to teach the arts of traditional Korean dance and drumming to students of Korean descent. Workshops led to a culminating performance to share these art forms with people of Korean descent and the general public.
- The RiverSong

introducing a diverse audience to a variety of music in a scenic, riverside setting.

- **Twin Cities Film Fest** was granted \$68,750 to give Minnesota filmmakers a national voice by showcasing exceptional local films, stimulating professional growth, growing access for Minnesota audiences to independent cinema, and introducing new and underrepresented voices in film.
- **The Grand Marais Arts Colony** was granted \$31,413 for the Grand Marais Arts Festival, showcasing more than 70 local and regional artists through artist booths, demonstrations, and activities in celebration of art on the North Shore of Lake Superior from July 8-9, 2017.
- **The Lowertown Blues Festival** in Saint Paul received \$20,000 to showcase 100 Minnesota blues artists to 25,000 attendees from July 21-22, 2017.
- The Historic Paramount Theatre in Austin was granted \$34,850 for the Austin ArtWorks Festival, which featured a broad selection of experiences in the visual, performing, and literary arts including interactive activities, artistic demonstrations, and an outdoor stage featuring musical guests.

Minnesota's Regional Arts Councils

The 11 regional arts councils cover every area of the state of Minnesota. Together, the Minnesota State Arts Board and the regional arts councils serve all of the state's 87 counties. As directed by statute, the Minnesota State Arts Board issues block grants to the regional councils as well as acting as their fiscal agent.

During fiscal year 2017, \$10,840,761 was awarded in the form of block grants to the 11 regional arts councils. With these funds, the councils together provided 1,789 grants reflecting arts services and support tailored to the needs of the people and communities in these geographic regions A list of the 11 councils, the geographic areas they serve by county, and the amount of their block grants for fiscal year 2017 can be found in the "Fiscal Year 2017 Block Grants to Regional Arts Councils" section of this Annual Report. The section "Fiscal Year 2017 Summary of Requests and Grants to Regional Arts Councils" presents the number of applications and grants awarded, and the total dollars requested and granted by the regional arts councils.

Partnerships I Service I Professional Development

The Minnesota State Arts Board expands its capacity and extends its reach by working in collaboration with other agencies and organizations that share similar goals and philosophies. The following are key partnerships that were in place during fiscal year 2017.

Percent for Art in Public Places

Up to one percent of the total budget appropriated for construction of new or renovated state buildings may be used to purchase or commission works of art. The Percent for Art in Public Places program, established in 1984 by legislative mandate, operates under the auspices of the Minnesota Department of Administration and is managed by the Minnesota States Arts Board.

During fiscal year 2017, Percent for Art projects included the following:

- Installing **Chromalume Chime Garden** by Kevin Dobbe (Rochester, Minnesota) for the Academic Partners Classroom Addition, Century College, White Bear Lake. **Chromalume Chime Garden** is an interactive sound, music, and light installation located in the exterior area of the building. When visitors interact with the artwork, a series of light and sound events occur, creating an atmosphere of wonder, exploration, and serenity.
- Installing The River of the Past Runs Into the Future, Growth and Healing, and The Evolution of the Beast by Ann Klefstad (Duluth, Minnesota) for Central Lakes College, Staples. The artworks are steel wall reliefs

installed in three interior locations on the campus.

- Commissioning schematic design proposals from three artists for the **Oliver Kelley Farm** with the Minnesota Historical Society, Elk River.
- Establishing a site selection committee, developing request for proposals, facilitating artist selection, and commissioning schematic design proposals from three artists for the **Wade Municipal Stadium** in Duluth.
- Establishing a site selection committee, developing request for proposals, and facilitating artist selection for the **Minnesota State Academy for the Deaf**, Frechette Hall in Faribault.
- Establishing a site selection committee, developing request for proposals, and facilitating artist selection for **Minnesota Veterans Home** in Minneapolis.
- Establishing site selection committee for Saint Paul College, Health and Science Alliance Center in Saint Paul.

Poetry Out Loud

Poetry Out Loud is a national poetry recitation competition cosponsored by the National Endowment for the Arts and The Poetry Foundation. Through Poetry Out Loud, high school students learn about great poetry through

memorization, recitation, performance, and competition. Fiscal year 2017 was the twelfth year that Minnesota participated in this initiative. The Arts Board worked in partnership with the Loft Literary Center, Minneapolis, to administer the program.

Nearly 7,600 students in 33 Minnesota schools participated in the program in 2017. These young people represented the communities of Apple Valley, Arden Hills, Big Lake, Bloomington, Brooklyn Center, Duluth, Farmington, Hopkins, Marshall, Mendota Heights, Milaca, Minneapolis, Northfield, Richfield, Saint Paul, Wabasha-Kellogg, and Woodbury.

The state competition was held at Open Book (Minneapolis) in March 2017. Anna Kochevar of Arcadia Charter School (Northfield) was named the winner with her recitation of "The

Gaffe" by C. K. Williams, "Dear Reader" by Rita Mae Reese, and "The Idler" by Alice Moore Dunbar-Nelson.

Other Minnesota champions included runners-up Abigail Etterson, Harbor
City International School (Duluth) and Awazi Jaafaru, Twin Cities Academy High School (Saint Paul)

In April of 2017, Kochevar represented Minnesota at the national finals in Washington, DC. She competed with champions from all 50 states, the District of Columbia, the U.S. Virgin Islands, and Puerto Rico. She was one of 10 students who advanced to the final round of the national competition.

Digital Strategy and Engagement Training

During FY 2017, the Arts Board supported a pilot program of workshops centered on digital strategy and engagement for artists and small and midsized arts organizations. These took place in four Minnesota locations: two in the Twin Cities, one in northern Minnesota (Duluth), one in southern Minnesota (Rochester).

The training program was designed and presented by Sarah Lutman, a Saint Paul based arts consultant who has a track record of three decades of service in the Minnesota arts and philanthropic communities. In recent years, Lutman has developed expertise and a body of work related to digital strategy for cultural organizations. The work began with her landmark study **Like, Link, Share: How Cultural Institutions are Embracing Digital Technology**, published in January 2015. That research was supported by the Philadelphia based Wyncote Foundation, a leading supporter of nonprofit media efforts. Since then, Lutman has developed and delivered digital strategy workshops and training for a number of organizations including the League of American Orchestras, Curtis Institute of Music's Digital Strategy Task Force, and Grantmakers in the Arts.

The Minnesota workshops were tailored for Minnesota participants and took into account factors influencing this work that are unique to our state: the continuing challenge of broadband access in rural areas; the scarcity of digital and social media training available to nonprofits; and the emphasis that Minnesota arts organizations place on physical versus digital engagement. Workshops were targeted to individuals and organizations who have, or perceive that they have, the greatest challenges in developing and implementing a digital strategy. Key topics included: initial self-assessment; review of recent audience and consumer research; using an "audience first" approach; thinking about assets brought to the table; determining which platforms are right; building a digital editorial plan; and developing metrics and measuring impact.

One hundred thirty-three individuals participated in the training.

Creating Connection Minnesota

The Arts Board also supported a pilot project, led by Arts Midwest, to apply the findings and key concepts of the national Creating Connection initiative in Minnesota. The initiative is being developed and tested in Oregon, California, and Massachusetts; Minnesota and Michigan are piloting aspects of the initiative. At its core, Creating Connection is a set of concepts and techniques to broaden engagement in the arts.

Minnesota arts organizations were invited to participate in in-person training sessions—two in the Twin Cities, one in southeast Minnesota (Red Wing), and one in northwest Minnesota (New York Mills) as well as in follow-up online sessions.

Eighty organizations were invited to participate in the pilot. Their experiences will be monitored and the effectiveness of the tools and techniques will be evaluated.

YEAR IN REVIEW

Showcasing the Work of Minnesota Artists and Organizations

The Arts Board hosted two arts exhibitions during fiscal year 2017 to spotlight the work of its talented grantees.

In the fall of 2016, the board showcased the work of artists and organizations that had been funded through the Arts Board's Folk and Traditional Arts grant program. It featured a wide range of visual and performing arts, including Sami-inspired jewelry, indigenous Mexican drumming, Norwegian clothing construction, Aztec dance, hand woven textiles, Ukrainian dancing, wood turning, Indian dance, and more.

In spring 2017, the board opened its Greater Minnesota Artist Showcase, featuring work by visual arts artists who had received Artist Initiative grants from the Arts Board. The showcase included artists from Bemidji, Breckenridge, Coleraine, Delano, Duluth, Ely, Good Thunder, Hibbing, Hovland, Knife River, Lanesboro, Mankato, Marshall, Milan, New London, Northfield, Rochester, Saint Cloud, Sauk Rapids, Shafer, Waite Park, Willmar, and Winona.

Statewide Arts Information

The Minnesota State Arts Board continues to use its Web site—**www.arts.state.mn.us**—as its primary communications vehicle. The site is designed to be user-friendly, and a comprehensive source of information about the Arts Board and about the arts in general.

Among the features that can be found on the Web site:

- Arts Board grant program details, application forms, and instructions
- Programs and activities funded by the arts and cultural heritage fund
- Calendar of grant deadlines and grant review meeting dates

Minnesota is a recognized national arts leader. It attracts, nurtures, and sustains creative people and organizations and recognizes them as assets. It is a magnet for arts enthusiasts and a destination for tourists. Residents and visitors are assured a world-class, quality arts experience.

Every Minnesotan appreciates, creates, attends, participates and invests in the arts. Minnesota's effective, innovative, vibrant, public-private support for the arts is the strongest in the country. Universal support and appreciation for the arts help ensure the state's exceptional quality of life.

Guiding Principles

To that end, decisions that the Minnesota State Arts Board and the regional arts councils make about how best to use the funds will be grounded in the following guiding principles:

- STATEWIDE APPROACH The needs and interests of the entire state will be considered when determining how best to allocate funds.
- DEMOGRAPHIC AND GEOGRAPHIC FAIRNESS Minnesotans of all types, and in every community, will recognize and experience the tangible results of the arts and cultural heritage fund.
- COMPREHENSIVE The full spectrum of arts providers and arts disciplines will be considered when determining how best to serve Minnesotans with these funds.
- SUSTAINABLE Some arts activities are meant to be one-time or short term; others are meant to exist and thrive over time. All are valuable and will be eligible for support. In the latter case, funds will be allocated strategically so that the activity or organization funded can be successful into the future, beyond the life of the arts and cultural heritage fund. Funds also will be used to create a sustainable climate in which artists can live and work.
- ANTICIPATORY AND FLEXIBLE Decisions about how best to allocate the funds will be reassessed on a regular basis and will adapt as needs and opportunities change.
- TRANSPARENCY AND PUBLIC INVOLVEMENT Broad public input and engagement in decision making will be vital to produce the outcomes that Minnesotans' expect.
- ACCOUNTABILITY AND STEWARDSHIP Public funds belong to Minnesotans. The Arts Board
 and regional arts councils will use them in the most effective manner possible and will routinely
 report the outcomes achieved through the uses of the funds.

RULES CHANGES

Minnesota Statutes 129D.04, subdivision 1, grants the Minnesota State Arts Board authority to promulgate rules. The board's administrative rules are found in Minnesota Rules, chapter 1900.

The board began a rulemaking process during fiscal year 2015 to repeal obsolete rules, clarify and simplify existing rules, and add rules for what had been pilot grant programs.

The draft rules and the dual notice (to adopt the rules without a public hearing unless twenty-five or more persons request a hearing, and notice of hearing if twenty-five or more requests for hearing are received) were published in the *Minnesota State Register* on September 14, 2015. The board did not receive twenty-five requests for a hearing, so proceeded to adopt the rules without a hearing.

The rules were approved by the Office of Administrative Hearings on May 31, 2016; and filed with the Office of the Secretary of State on June 27, 2016.

The notice of Adopted Permanent Rules Relating to Arts Funding was published in the *Minnesota State Register* on July 25, 2016.

COMPLAINTS / CONCERNS

The Arts Board's appeals process is outlined in Minnesota Rules, chapter 1900, section 1110. https://www.revisor.mn.gov/rules/?id=1900

The process states "There is no right of appeal for disputes of decisions with respect to interpretation of review criteria. An appeal may be made only if it is asserted that the board, or its staff, or advisory panels, did not follow the policies and procedures as provided by this chapter."

The board received two appeals during FY 2017:

- On September 30, 2016, Kathryn Nobbe submitted an appeal, asking the board to accept her application to the FY 2017 Artist Initiative visual arts grant program. An application had not been received by the board by the announced deadline.
 - The board considered the appeal at its November 2, 2016, meeting. Minnesota Rules 1900.0810 states, "All applications must be received at the board office by the deadline in the current program information. A late application shall not be considered by the board." The board determined that the appellant had not provided evidence that the board had failed to follow its policies and procedures; it denied the appeal on the basis that the appellant had not shown sufficient cause for an appeal.
- On May 12, 2017, Deborah Ramos submitted an appeal on behalf of Festival de las Calaveras, asking the board to accept an application to the FY Minnesota Festival Support. An application had not been received by the board by the announced deadline.
 - The board considered the appeal at its June 7, 2017, meeting. Minnesota Rules 1900.0810 states, "All applications must be received at the board office by the deadline in the current program information. A late application shall not be considered by the board." The board determined that the appellant had not provided evidence that the board had failed to follow its policies and procedures; it denied the appeal on the basis that the appellant had not shown sufficient cause for an appeal.
