#### Annual Legislative Forum

December 4, 2006: The MSCOD hosted its annual Legislative Forum via video conference. 150 people attended from the seven locations via videoconference site and over 40 disability organizations participated in the event. For the first time ever we also were able to web stream the event too with around 70 people accessing the event. Representative Paul Thissen, Chair of the House Health Care and Human Services Committee, spoke at the event. Organizations were encouraged to share their legislative agenda for the upcoming session. At the event, individuals asked questions of state agencies and disability organizations. In addition, members of the Minnesota Consortium for Citizens with Disabilities (MN-CCD) and other groups presented their proposals for the 2007 legislative session.

## **Town Hall Meetings**

The MSCOD began holding quarterly town hall meetings to focus on specific disabilityrelated issues. The meetings were held via videoconference and were Web streamed and closed captioned. Video streamed out to 12 county locations throughout the state. Town Hall Topics included:

The MSCOD provides disability-related technical assistance to individuals, businesses, governmental, and agency representatives from all over Minnesota by phone, e-mail, letter, and in person. Most contacts were from individuals in need of resources in order to live more independently. The MSCOD continues to work with the legislators to assist in providing solutions to both individual and broad problems and issues.

#### Training/Presentation

The MSCOD provides training on a number of topics to any group or organization requesting such information. Presentations are tailored to meet the needs of each particular group to ensure effectiveness.

The MSCOD continued to advocate for individuals with disabilities at the Minnesota State Legislature. Members of the Minnesota Consortium for Citizens with Disabilities (MN-CCD) were able to effectively advocate for Minnesotans with disabilities.

The MSCOD also worked with legislators to enact other disability-related legislation including:

- The removal of the MSCOD's sunset provision has now resulted in the MSCOD becoming a permanent fixture in Minnesota's baseline budget.
- Granting preference to people with disabilities and disabled veterans in housing provided by the public housing authority.
- Exploring the possibility of incorporating the adaptability design elements in the State Building Code for single family homes, duplexes, triplexes, and multi-level townhouses.
- Convening a work group to address equipment issues for safe patient handling.

- Facilitating a statewide review of the assistive technology needs of people with disabling conditions, and seniors. The Council shall present to the chairs of the house and senate committees having jurisdiction over human services, by January 1, 2009, the recommendations.
- The Council on Disability in fiscal year 2008 is to provide \$100,000 financial support to the, Minnesota Regional Assistive Technology Collaborative, and \$200,000 is for a transfer to the commissioner of administration for the purposes of completing the state's remaining share of the local match required to access the federal Technology Related Assistance Act for Persons with Disabilities.

- The Governor's Council on Developmental Disabilities conducted a survey that had been conducted in 1966 and recreated it again to conduct the survey in 2006. MSCOD contributed to this survey. The survey was on employers' attitude regarding disability.
- Conducted Annual Customer Satisfaction Survey using <u>Supersurvey.com</u>, which assists the Council in determining the strategic direction. This year, we received 181 responses, higher than any previous year.
- Over 10 accessibility surveys were conducted to businesses, state agencies and others as requested.

# **ADVISORY FUNCTIONS**

In accordance with M.S. 256.482, Subd. 5, Sections (1), (2), (4), (6) and (7), the duties and powers of the Minnesota State Council on Disability include: to advise state elected officials, state agencies and the public on matters pertaining to public policy and programs, services, and facilities for persons who have a disability in Minnesota.

#### Legislature

• Advised the Legislature on the needs of voter access, healthcare, disability parking, transportation, education, housing, and Metro Mobility.

#### **Technical Assistance and State Agency Advisories**

- Voter education, election judges training on disability awareness and accessible voting equipment
- Disability parking and special plates policy to Department of Public Safety
- Disability Awareness, access and ADA employment to the Department of Employee Relations
- Consulting with Minnesota Department of Transportation
- Technical consulting on workers' compensation division of the Department of Labor Workers Compensation cases regarding home modifications.

# **MSCOD STATUTORY RESPONSIBILITIES**

## General Duties, MS 256.482, Subd. 5, Sections (1), (2), (4), (6)

**and (7)** describes the powers and duties of the Minnesota State Council on Disability to include: advise state elected officials, state agencies and the public on matters pertaining to public policy and programs, services, and facilities for persons who have a disability in Minnesota.

#### Access Code Development, MS 16B.61, Subd. 5, Section e the

commissioner of the department of administration, state building codes division is required to consult with the council on disability before any rules are proposed for adoption for current disability access requirements.

**Building Code Access Appeals**, **MS 16B.67** the council on disability may appeal any final decision of any municipality as to the application of the code to the commissioner of administration.

<u>State Agency Reasonable Accommodation Plan, MS 43A.191</u> agency affirmative action programs require the council on disability to serve in an advisory role for the department of employee relations in providing assistance with the state agency reasonable accommodation plan.

**Disability Parking Certificate Restriction**, **169.345**, **subdiv. 3** the commissioner of the department of public safety shall not issue more than three replacement certificates within any six year period without the approval of the council on disability.

**Special Vehicle Variance**, **MS 174.30**, **Subd. 2**, **Section (c)** the commissioner of the department of transportation shall consult with the council on disability before making a variance from the operating standard for special transportation services.

<u>WC Home Modifications, MS 176.137, Subd. 4, Section 1</u> the council on disability advises the workers' compensation division of the department of labor and industry and the workers' compensation court of appeals as to the necessity and extent of any alteration or remodeling of an existing residence or the building or purchase of a new or different residence which is proposed by a licensed architect.

<u>Access Review Board, MS 471.471</u> the council on disability has membership on the Access Review Board and advises on the installation of stairway chairlifts in buildings that could not otherwise be made more accessible.

## Transportation Accessibility Advisory Committee, MS 473.386,

**Subd.** 2, section e the council has membership on the transportation accessibility advisory committee of the metropolitan council.

<u>School Access Improvements, MS 123B.58</u> the commissioner of the department of children, families & learning will consult with the council on disability when developing criteria to determine the cost-effectiveness of removing barriers in older buildings.

**School Access Grants, MS 123B.69** the commissioner of the department of children, families & learning, in consultation with the council on disability, shall review applications for access grants.

**Library Access Grants, MS 134.45**, **Subd. 2** the commissioner of the department of children, families and learning, in consultation with the council on disability may approve or disapprove access grants to public libraries for removal of architectural barriers.

**<u>Children's Development Plan, MS 145.951</u>** the commissioner of health may in consultation with the director of the council on disability develop an implementation plan for the establishment of a statewide program to assist families in developing the full potential of their children.

**Licensing Criteria**, **MS 148C.11** the council on disability advises on the development of special licensing criteria for issuance of a license to alcohol and drug counselors who practice with a member of the disability population.
