- *The ECLDS system was a project of the Race to the Top Grant. It has been integrated with the MN P20W information system.*
- *ECLDS anticipates new data from programs such as; scholarships, Kindergarten Entry Profile (KEP) and child welfare.*

### **Questions from ELC Members:**

**1. We do not have any info on how they are coming into kindergarten?**

- *We have the Kindergarten Entry Profile, however this is just a very small sample of the Kindergarten population. MDE would like to expand the KEP but needs additional funding.*

**2. Is there prenatal data in ECLDS?**

- *We have birth data, but that is all.*

**3. Is there a plan going forward to follow children to see the return investment to society?**

- *Maintenance funding is needed in order to do this.*

**4. How much would be needed for maintenance funding?**

- *MDE estimates \$300,000-\$500,000 a biennium.*

**5. Is there any funding to go beyond descriptive statistics?**

- *The Governance agreement does not allow the data to be used for research purposes.*

**6. Kindergarten Entry Profile (KEP)—where does the Kindergarten Entry Profile work “sit” and can we look at those children going forward?**

- *The Department of Education coordinates the work of the KEP. It is a very small sample that is reported to the state. The data is not quite ready to be released yet.*

**7. What would it take to expand the KEP?**

- *MDE would need additional funding in order to expand and support districts in administering the KEP. MDE does not want to mandate it, without being able to provide funding to districts.*

**8. What is the estimated cost for expanding the KEP?**

- —1.3-1.5 million – MDE did highlight this in the ESSA plan.

9. **Are there informational sessions/legislator training sessions that would encourage the use of ECLDS?**

- *We are in a better position to do that now. We have been so busy building it that a lot of training and support sessions have not been made available. This will be an area we will begin to look at. Minnesota is one of the few states that has a functioning ECLDS system through the Race to the Top work.*

**Comments from the Anita Larson, ECLDS Project Manager**

- *With the grant, we are able to help groups use the data, you don't need a statistician to analyze the data.*
- *We have a glossary in the system for background information.*
- *This website is mobile first, so you can also view the website on your phone as you would on a laptop/desktop computer.*
- *We have a data dictionary that shows where the data originates from.*
- *We are currently exploring the use of integrating Family Home Visiting data.*
- *The 2018 session is not a budget year. Unsure if there would be support for expanding the system in 2018.*

- World's Best Workforce benchmarks
- Districts utilizing it to meet their ESSA objectives
- Results of pre-k 3rd grade initiatives (MDE)
- Teacher credentials

### Questions/comments from ELC Members:

**1. Where is the ELC reflected in the organization and process chart?**

- *Currently there are 3 members from the council who are also participating on the steering committee. The Assistant Commissioners from the council also make up members of the state agency oversight committee.*

**2. What systems are we talking about?**

- *We are working to identify that now. We are in the very early stages of the process. We are asking the questions: What is desired, what is feasible, what is available, how can we be thoughtful with our alignment, and how can we collaborate more.*

**3. Is their child care representation on the committee?**

- *There are members that are former providers and can represent childcare in some capacity.*

**4. Is there school based program representation on the committees?**

- *There is a representative from the Early Childhood Family Education area, which can often be a first point of entry for families accessing their school district.*

**5. Are we building any way to sustain this effort if the children's cabinet disappears?**

- *We are making sure the people who are on the ground are there and we have Assistant Commissioners and division directors at these meetings who can assist in identifying barriers that could be addressed now.*

**6. Is there a plan to increase the Early Learning Council role in the steering committee?**

- *The EC Reform work can provide regular updates to the council, we do have council representation and we can discuss this further internally to see where the ELC fits in this process.*

**7. Are people going to be added, once the group's work is expanded to go beyond 0-3 and look at 0-8?**

- *This group is going to meet until June, but it may change due to what is discovered that has to be addressed?*

**8. How we can work together to make sure there is coordination between both groups?**
