The Department of Iron Range Resources & Rehabilitation is funded by a portion of a local taconite production tax paid by mining companies on each ton of iron ore pellets produced. The tax is paid by mining companies in lieu of property taxes. Prior to the agency receiving funding, dedicated amounts of the tax are legislatively distributed to local governments, schools and counties. The commissioner presents an annual budget for approval to the Iron Range Resources & Rehabilitation Board and Governor.

OUR SERVICE AREA

Our service area is a 13,000 square-mile portion of northeastern Minnesota, including 50 cities, 132 townships and 15 school districts. The service area is defined by school district borders.




OUR BOARD

The Iron Range Resources & Rehabilitation Board is an advisory board composed of state senators and state representatives elected from senatorial or legislative districts in which one-third or more of the residents live within the agency's service area. One additional state senator is appointed by the senate Subcommittee on Committees of the Committee on Rules and Administration. Board members are appointed in January of odd-number years and serve until January of the next odd-numbered year. All expenditures and projects made by the commissioner are submitted to the advisory board. The board recommends approval, disapproval or modification of expenditures and projects.*

*2017 legislation made the nine-member Iron Range Resources & Rehabilitation Board an advisory board.





BUSINESS DEVELOPMENT

The agency's business development programs are designed to diversify the economy of northeastern Minnesota. Partnerships with economic development entities, financial institutions, businesses and other funding sources support and help create jobs in northeastern Minnesota.

During the biennium, Iron Range Resources & Rehabilitation provided \$12.5 million in business development loans, generating a total project investment of



Range Steel Fabricators

Range Steel Fabricators (RSF) entered its second century of industrial steel fabrication on the Iron Range, and new owners Jeff and Gina Halter are positioning the company for growth through equipment modernization.

RSF recently improved its manufacturing processes by replacing an ineffective piece of equipment with a Computer Numerical Control (CNC) profile cutting machine. CNC machines are electro-mechanical devices that manipulate machine shop tools using computer programming inputs. This new machine precisely and efficiently manufactures components that RSF supplies to industries such as energy and utilities, mining and minerals, paper and forest products, commercial construction, and heavy equipment and industrial manufacturing.

RSF machines and fabricates steel and aluminum components for local companies who use them to assemble their products. Those final assembled products are then sold and shipped all over the world.

The Halters grew up in Grand Rapids, Minnesota and after having their third child wanted to move back to the Iron Range from Orlando, Florida. They wanted to give their children the same experience they themselves had growing up in a small community and enjoying the outdoors.

The Halters purchased RSF in 2016 and moved their family to Hibbing. Jeff was a real estate developer, and Gina had a professional background in graphic design and marketing. Together they transferred their experience and knowledge of process and operations to managing a manufacturing business. Since 2016 RSF has grown from seven to 20 full-time and three part-time employees.

Iron Range Resources & Rehabilitation supported RSF with a bank participation loan to assist with the purchase of new equipment.

BUSINESS DEVELOPMENT: Zakobe

A love of family and the outdoors was the driving factor behind Zakobe, a successful family owned and operated metal stamping business in Bovey, Minnesota.

Wade & Teresa Karnes founded Zakobe in 2005, operating it out of Wade's father's garage. Twelve years later it is a thriving business that specializes in metal stamping, manufacturing and machining metal fabricated parts for a wide array of industries including fishing, cycling, farm equipment, battery, medical, military, electronics, radiator and computer hardware. Their products are distributed to companies throughout the United States.

Wade graduated from Central Lakes College in Staples as a machinist in 1993, then began his career in Park Rapids, Minnesota after marrying his high school sweetheart, Teresa. He and Teresa had two sons, and when the oldest son Zak turned five they returned home to northeastern Minnesota to raise their sons in the same northwoods where Wade loved to hunt deer when he was young.

The products made at Zakobe are used every day in homes and businesses. The small metal battery clasp in a TV remote control, or the metal eye hook on a fishing lure could have been tooled and shaped at Zakobe. The company designs and produces all of its tooling in-house, using a variety of metals and other materials such as nickel, aluminum, brass, pvc, bronze, copper, stainless steel and fiber board.


In 2016 the business took another stride when it bought the 6,500 square foot former KMDA facility in Bovey, adding additional press capacity. Zakobe further expanded when it recently purchased Cast & Color, a custom lead casting and painting company that makes fishing tackle. Jigs and lures are now made and painted at Zakobe.

Along with the Karnes' two sons, Zakobe has several full-time, part-time and telecommuting employees.

COMMUNITY DEVELOPMENT: Northern Twistars

Northern Twistars Gymnastics recently moved into a new location at the former Plaza Bowling Lanes building in Virginia. The 16,800 square foot building underwent a complete interior demolition to make way for a new gymnastics training facility used by 400 boys, girls and adults.

Twistars is owned and operated by Iron Range natives Gwyn Roos and Lisa Fix, both former Virginia High School gymnasts and coaches. Since 2008 when it was founded with 75 students, Twistars has operated in three other Virginia locations, each of which it outgrew due to increasing demand in the community.


Iron Range Resources & Rehabilitation provided a Commercial Redevelopment grant which helped pay for the internal demolition and enabled the transformation of the aging bowling facility into a modern gymnasium.

Twistars offers child and adult gymnastics classes, yoga classes, a boys Ninja program, a competitive team program and performance cheerleading. Students range in age from 18 months to 60 years old. In addition, the facility may be rented for kids' birthday parties.

Virginia resident Jacob Rosandich is a part-time Ninja instructor, and two of his four children are Twistars students. According to Rosandich, the facility gives his family and many others a healthy and fun option for building confidence and lifelong fitness through gymnastics.

Northern Twistars is an excellent example of economic partnership among the city of Virginia, Iron Range Resources & Rehabilitation and private sector business. Gwyn and Lisa developed a business that is meeting an important quality of life demand in Iron Range communities.

COMMUNITY DEVELOPMENT: Castle Danger Brewery

Castle Danger Brewery expanded production capacity by adding an 8,400 square foot packaging hall adjacent to its existing production facility and taproom. The expansion was made possible with a Development Infrastructure grant from Iron Range Resources & Rehabilitation to the city of Two Harbors.

The brewery has been on an upward trajectory since 2014 when it produced 1,500 barrels annually and ranked 14th among all Minnesota breweries in sales revenue and in-state shipments. In 2017 the company produced 14,000 barrels and ranked 6th in the state; in 2018 production of 19,000 plus barrels is expected. The expansion increased efficiencies, more than doubled capacity and has potential for long-term growth of up to 40,000 barrels per year.

The company employs 28 people in Two Harbors, of which six were added since the expansion. An additional six full-time and 35 part-time employees serve in sales capacities throughout the state.

Two Harbors native Clint MacFarlane was a home brewer for five years before founding Castle Danger in 2011 with a 700 square foot brewery. As Clint and his wife Jamie grew their business, they brought in family members Lon and Mandy Larson as business partners in 2014 to manage sales, financial and human resources.

Castle Danger beer is distributed in Minnesota and select border towns in North Dakota and Wisconsin, but the company's focus is to keep its story and roots local on Minnesota's North Shore and capitalize on Two Harbor's competitive advantages.


"Two Harbors has great competitive advantages for our business, the biggest one being Lake Superior as our water source," said Clint. "Lake Superior has exceptional water quality with very low mineral count so we don't have to spend a lot of time and money on filtering."

Another advantage is the organic sales growth the company has as a result of North Shore tourism. "People visit the North Shore, try Castle Danger beer during their vacation, and then return to their hometowns and buy it in their neighborhood stores," said Lon. "Another significant competitive advantage is the work ethic of the local workforce. The people and workers of Two Harbors are exceptional."

Iron Range Resources & Rehabilitation's workforce development program is designed to meet the workforce needs of local businesses

Through regional partnerships with colleges, businesses and school districts, Iron Range Resources & Rehabilitation provides leadership in the development and implementation of a comprehensive strategy designed to maintain an educated, well-trained workforce.

WORKFORCE DEVELOPMENT: Vermilion Community College Veterinary Technician Program

The 75-credit program is the only veterinary program north of the Twin Cities. The program trains students to become Certified Veterinary Technicians. In its first year, 2017, 24 students enrolled in the program. Enrollment is projected to rise to 75 students by the program's third year.

Vermilion Community College added a new Associate of Applied Science Veterinary Technician program, and according to college officials the enrollment response has been excellent.

The program features a United States Department of Agriculture certified kennel and laboratory facilities which allow students to learn surgical procedures, x-rays, dental work, physical exams, sample collection and other animal care. A grant from Iron Range Resources & Rehabilitation helped pay for the laboratory and learning equipment.

Equipment acquisition and program development is supported by the Iron Range Higher Education Account. The account funds higher education programs within the agency's service area.

WORKFORCE DEVELOPMENT: Certified Tourism Ambassador™ program will benefit Iron Range

The Iron Range is one of two regions in Minnesota (the other is Rochester)
taking part in the Certified Tourism Ambassador™ (CTA) program, an industryrecognized certification for frontline staff that is accredited through the
Tourism Ambassador Institute.

Curriculum specially customized to the Iron Range was developed and is open to all area businesses who are connected to the tourism industry including hotels, restaurants, retailers and attractions. Through classroom and online training modules the employees will earn their certification and join 12,000 other CTAs worldwide. Workers go through an annual renewal process to ensure their knowledge and skills are continually growing.

Coordinated by the Iron Range Tourism Bureau (IRTB), the program's goal is to drive visitor spending through in-depth knowledge of the region.

Certified workers within the tourism industry may see some great benefits. In other regions, certification has led to higher tips, career advancements and an additional qualification to add on a resume. Employers also benefit because better customer service can result in repeat business.

Iron Range Resources & Rehabilitation supported this project with a Workforce Development grant.

Giants Ridge.

On May 1, 2017, the agency finalized a contract under which Guest Services, Inc., in partnership with Billy Casper Golf, manages all Giants Ridge operations, including golf, ski, rental, retail, concessions and facilities.

Giants Ridge offers 35 downhill ski runs, over 60 kilometers of cross country ski trails, snow tubing, snowshoeing and two 18-hole award-winning championship golf courses.

Two new quad ski lifts went into operation in the winter of 2017 at Giants Ridge. A 2,186 foot-long high-speed detachable quad lift and a 1,825 footlong fixed quad lift highlight several new amenities of a multi-recreation investment in the facility by Iron Range Resources & Rehabilitation. The new lifts allow for easier and quicker transport to the top of the ski hill.

Construction of a climbing wall, two miles of single-track purpose built mountain bike trails and a children's playground rounded out improvements in late 2017 and early 2018.

A 2016 THK Associates, Inc. study shows Giants Ridge to have a \$43 million annual economic impact on the local economy.

Taconite Economic Development Fund

The Taconite Economic Development Fund was established by the 1992 Minnesota Legislature. Currently in years when total industry production exceeds 30 million tons, up to 25.1 cents-per-ton of the taconite production tax may be rebated to northeastern Minnesota iron ore mining operations. The rebate must be used for:

- workforce development and associated public facility improvement
- acquisition of plant and stationary mining equipment and facilities
- research and development in Minnesota on new mining or production technology

When the total industry production is below 30 million tons, distributions are limited to chips and fines credits. In FY17 mining companies received their entire TEDF rebate; however, in FY18, they were only eligible to receive a rebate based on chips and fines.
