Dear Senators and Representatives:

In 2012, the Legislature amended Minnesota Statutes, section 14.116 to require each agency to submit its rulemaking docket and official rulemaking records for rules completed during the preceding calendar year to the chairs and ranking minority members of the legislative policy and budget committees with jurisdiction over the subject matter of the proposed rule.

The DNR completed the following two permanent rules projects in 2017 under the Administrative Procedure Act, *Minnesota Statutes*, Chapter 14:

Expedited Permanent Game and Fish Rule: Northern Pike Regulation, Revisor's File No. [R-04408](#), effective 3/01/2018 (notice of adoption published 8/28/2017)

Exempt Permanent Game and Fish Rule: Vehicle Licenses for Minnow Retailers, Revisor's File No. [R-04492](#), effective 11/13/2017
