# Legislative Charge

In 2015, the Minnesota State Legislature passed House File no. 1, article 6, section 11, to address the growing skills gap within the state STEM and IT fields. Funds were allocated to the Minnesota Department of Education (MDE) to provide IT Certification programs to schools throughout the state in order to stimulate student interest in the STEM and IT fields.

## **Section 11. INFORMATION TECHNOLOGY CERTIFICATION PARTNERSHIP.**

**Subdivision 1. Request for proposals.** The commissioner of education shall issue a request for proposals no later than August 1, 2015, and award a contract no later than October 15, 2015, to a provider for the program under subdivision 3.

**Subdivision 2. Eligible schools.** A school district, intermediate district, or charter school is eligible to participate in the program under this section, as long as funds are available.

**Subdivision 3. Program description; provider duties.** (a) The provider must partner with eligible schools to make available a program to teach information technology skills and competencies that are essential for career and college readiness. By December 1, 2015, the provider must contact each eligible school and indicate how the school can access program services under this section.

(b) The provider shall recruit up to 200 schools to participate in the program as long as funds are available. The provider must engage schools on a first-come, first-served basis, except that no more than half of the total funds available may be used to deliver the program to schools located in the seven-county metropolitan area.

(c) The provider shall deliver to each participating school:

- (1) a research-based information technology curriculum;
- (2) online access to the curriculum;
- (3) instructional software for classroom and student use;
- (4) training for teachers who will be using the curriculum or instructional software;
- (5) industry-recognized certification of skills and competencies in a broad array of information technology-related skill areas; and
- (6) project management, deployment, and program support, including, but not limited to, integration with academic standards under Minnesota Statutes, section 120B.021 or 120B.022.

**Subdivision 4. Department support.** The Department of Education must make support available to the provider, including acting as the primary liaison between schools and the provider and providing direction and oversight, consistent with the purposes of this section.

**Subdivision 5. Report required.** By February 1, 2018, the provider and commissioner must jointly develop and deliver to the committees of the legislature with jurisdiction over kindergarten through grade 12 education, a summary report on program activities and outcomes, including a description of the number and location of participating schools and students, and the number and type of certifications earned by students.

# Executive Summary

Legislative action in 2015 aimed to address skill gaps in the fields of science, technology, engineering and math (STEM) and information technology (IT) fields. The Minnesota Department of Education (MDE) awarded a contract to Mouse Inc. to engage up to 200 schools in Minnesota with an educational program leading to skills certifications in the STEM and IT fields. Mouse began recruiting schools through its contract with MDE in January 2016. Active recruitment was suspended in January 2017 due to the upcoming end of the contract on June 30, 2017. In just over a year's time, Mouse trained 166 educators and reached an estimated 1,000 students who collectively earned 130 certifications and submitted sufficient evidence of completion for 2,957 modules.

Mouse is a national educational nonprofit that offers a variety of project-based activities in the STEAM model (STEM + Art: emphasizing creativity within science and technology), all delivered via step-by-step instructions on an online learning platform. These activities are integrated into a badging certification system shareable on the Common App, LinkedIn, and several other websites. An overview of Mouse's content and learning design philosophy can be found at [mouse.org/work](http://mouse.org/work). Member schools receive unlimited access to Mouse educational content, plus support and training from Mouse staff.

Minnesota high schools utilized Mouse's educational content in a variety of ways. Typically, educators integrated Mouse projects into existing classes, especially those covering business, computer science, engineering, and technology. However, some schools used Mouse as the content for an after-school, independent study, or club program. Some schools proceeded with broad implementation across multiple subject areas while others focused narrowly on one or two courses. "Coding," which teaches the fundamentals of programming languages, and "Tech Team," which facilitates the creation of a student-led school IT help desk, were especially popular.

The timeframe of the contract in relation to the school calendar presented challenges to the contractor as they recruited schools that would adopt and fully implement the program. Schools were understandably reluctant to initiate a program that they were uncertain they could continue to support once the term of the contract ended and the costs of running the program would fall on their budget.

Another finding of the project was that although students completed modules and submitted them for verification, teachers awarded far fewer credentials than expected. The contractor emphasized the role required of teachers in later trainings, but many badge-eligible submissions remained unverified at the end of the pilot. Mouse is still developing their badging platform and processes and this experience in Minnesota has been helpful in identifying gaps. Toward the end of the contract, Mouse and Best Buy were exploring pathways from content to credential to career.

# Introduction

This report describes the implementation process and findings from the Information Technology Certification Partnership as described in Chapter 3, article 6, section 11, 2015. The intention of the contract was to address skills gaps present in the Science, Technology, Engineering, and Mathematics (STEM) fields by engaging with a contractor providing skills-based instruction linked to certifications/credentials. The contract was awarded to Mouse Inc. to provide step-by-step, project-based activities via an online learning platform. Students become eligible for credentials (digital badges) as they complete activities and these badges can be used as evidence of students having information technology skills and competencies.

Mouse successfully recruited and trained 166 educators in 98 schools and reached an estimated 1,000 students. Contractual conditions stipulated that no more than half of the schools served be within the seven-county Twin Cities metropolitan area. As such, Mouse focused recruitment efforts on greater Minnesota. Of the 98 schools recruited, 38 are in the Twin Cities metropolitan and 60 are in greater Minnesota.

Students engaged with the Mouse activities in a variety of contexts such as being included in courses and during after school clubs. At the end of a module, students could submit evidence of their work for certification. Students collectively earned 130 certifications and submitted sufficient evidence of completion for 2,957 modules.

# Analysis

## Overview

According to the contract, which spans from January 2016 to June 2017, the contractor, who is not a state employee, will:

- A. Provide recruitment and onboarding for eligible schools and school districts: January 2016 through October 2016.
- B. Provide professional development and training to all teachers.
- C. Provide online access to curriculum and any instructional software needed for all enrolled schools.
- D. Online Certification: Contractor shall use its reasonable efforts to require site Coordinators to facilitate the Mouse Squad curriculum as required to complete the certification.
- E. Provide deployment and program support.
- F. Provide the state through reasonable efforts with requested data as needed.
- G. Certify students have met informational technology skills and competencies that are recognized by industry.
- H. Build sustainability for programs to continue beyond terms of the contract.
- I. Enter into a memorandum of understanding (MOU) with each school to formalize the membership of the program for each school district.
- J. Provide a final report on effectiveness of the contract no later than June 1, 2017, to allow for review and approval of MDE.

## Deliverables and Accomplishments

The following list highlights the efforts and accomplishments made by Mouse, Inc. to address the 10 areas that were laid out in the contract between MDE and Mouse, Inc. as the expected deliverables of the contractor. This section details the progress made towards these deliverables from January 2016 through June 2017.

### Deliverable A

#### *Contractor Duties:*

Provide recruitment and onboarding for eligible schools and school districts, January 2016 through October 2016

- 1. Includes access to mousesquad.org membership
- 2. Online professional development training: February 2016 through June 30, 2017
- 3. Mouse Program deployment: September 2016 through June 30, 2017
- 4. Evaluation of program effectiveness: May 2017 through June 30, 2017: Contractor shall support a formative evaluation of the Mouse Squads and shall continue to develop tools to provide participants with real-time evaluation data provided that each participating site is entered with full registration information on mousesquad.org.
- 5. Recruit up to 200 eligible schools with students in grades 9-12.

### *Actions/Activities:*

1. As of June 2017, 98 Minnesota schools are active Mouse member schools under the MDE contract and have been granted access to the curriculum and online platform.
2. Mouse has offered in-person sessions or video chat sessions for training/onboarding to all member schools on multiple occasions, but only some have taken advantage of the opportunity. Training was provided to 49 sites and 166 educators. Mouse Create also offers three online courses for coordinators.

5. Evaluative surveys were conducted in April and May of 2017. The results of this evaluation will be made available to MDE by August of 2017.

An email was sent out to all eligible schools in December of 2015 introducing the partnership between MDE and Mouse. The email explained Mouse's mission, the curriculum and online platform that schools would gain access to, the help desk, and what students would achieve through participating in the program. The emphasis was on helping students develop essential technology and professional skills that would better prepare them for a STEM career.
  - a. Another email went out in March of 2016, which emphasized Mouse's Green Tech content as a way to design a school Mouse Squad. Highlighted was the Mouse emphasis on projects for social change and student-led betterment of schools, communities, and the world.
  - b. Mouse conducted additional targeted recruitment from May 2016 to January 2017.
  - c. Total recruitment emails sent: 4,573
  - d. Total recruitment calls made: 177

## Deliverable B

### *Contractor Duties:*

Provide recruitment and onboarding for eligible schools and school districts, January 2016 through October 2016

1. Includes access to mousesquad.org membership
2. Online Professional Development Training: February 2016 through June 30, 2017
3. Mouse Program Deployment: September 2016 through June 30, 2017
4. Evaluation of program effectiveness: May 2017 through June 30, 2017: Contractor shall support a formative evaluation of the Mouse Squads and shall continue to develop tools to provide participants with real-time evaluation data provided that each participating Site is entered with full registration information on mousesquad.org.
5. Recruit up to 200 eligible schools with students in grades 9-12.
  - a. All eligible schools will be contacted by December 1, 2015.
  - b. No more than half the schools will come from the 7 county Twin Cities metro area. The Contractor shall provide MDE an interim report no later than January 31, 2016 regarding schools and districts recruited.

### Actions/Activities

1. 100 percent of Mouse Member Schools have received the Mouse Resource Kit (containing materials to run Mouse projects); 16 schools have additionally received the Green Tech Kit (specific materials for our Green Tech course).

3. Mouse offered in-person or video chat onboarding sessions for training/onboarding to all member schools. The offer was made to all current member schools on multiple occasions, but only some took advantage of the opportunity. By the end of the contract, 49 sites were trained/onboarded within the MDE contract.
4. Introductions and offers for support made: 776 primarily via email
5. On average, a total of 15-20 emails are exchanged with Minnesota member schools per week, which provides an opportunity to continue training educators as they begin using the content and platform.
6. With the launch of a new online learning platform, Mouse Create, training was introduced in the fall of 2016 to demo learning activities, provide pedagogical recommendations, and discusses possible methods of implementation for educators. To date, Mouse has trained 166 educators within the MDE contract.

8. Additional Professional Development Opportunities
  - a. Mouse Create Conference – October 28, 2016  
10 educators from Minnesota were given the opportunity to travel to New York City to attend the Mouse Create Conference for Educators, hosted at Teach for America. The event included:
    - Updates on the Mouse Create online learning platform.
    - Workshop sessions to explore Mouse Create content and recommendations for pedagogy and implementation.
    - Networking opportunities for educators.

- b. Mouse Minnesota Educators Conference – April 10, 2017
- 21 educators from Minnesota joined Mouse staff at Best Buy Corporate Headquarters. The event included:
- Training in the use of the Mouse Create online learning platform
  - Workshop sessions to explore Mouse Create content and recommendations for pedagogy and implementation.
  - Networking opportunities for educators.

## Deliverable C

### *Contractor Duties:*

Provide online access to curriculum and any instructional software needed for all enrolled schools.

### *Actions/Activities:*

Mouse Create launched in early September 2016. All member schools were given their access codes to begin creating accounts and forming student groups to begin work on the curriculum and badges.

## Deliverable D

### *Contractor Duties:*

Online Certification: Contractor shall use its reasonable efforts to require site coordinators to facilitate the Mouse Squad curriculum as required to complete the certification.

### *Actions/Activities:*

Under the launch of Mouse Create, students were able to complete courses in 24 STEM areas. Educators can select among the projects within each course to create custom playlists that meet their learning goals or choose from pre-created courses.

Within each course, students could earn digital certification badges recognized by employers, K-12 stakeholders, and universities. Mouse educators review student project submissions and determine demonstrable skills for students to earn each badge. Refer to the following table:

## Deliverable E

### *Contractor Duties:*

Provide deployment and program support including, but not limited to:

1. All accessibility requirements shall comply with Section 508 and Web Content Accessibility Guidelines (WCAG) 2.0 – Level AA with a check-in on October 31, 2016, December 15, 2016, and January 30, 2017.
2. Minimum of 20 monthly communications with enrolled schools.
3. Develop a calendar for following up with enrolled schools.
4. Call/email each school through regularly scheduled check-in times.
5. Handle 100 percent of issues, complaints and inquiries within a business day of receiving the response.
6. Maintain a log of all communication and program supports.
7. Support schools with integration with academic standards under Minnesota Statutes, section 120B.021 or 120B.022.

### *Actions/Activities:*

1. Throughout this contract, Mouse has worked to update its content to align with section 508 and WCAG standards.
2. On average, 60-80 check-in emails are sent to member schools per month. Most are focused on guiding schools through program implementation and the use of Mouse Create. Other subjects include educator feedback on projects, updates on student learning, and learning event coordination. Not all schools are communicative, but Mouse has made consistent efforts to ensure open lines of communication.
3. Following recruitment outreach, once a school expressed interest, Mouse proceeded as follows to enroll schools, onboard, and continue communication and support:
  - a. School participated in-person or remote info-session (ideally), or at least an exchange of information via email.
  - b. School signs up.
  - c. "Welcome to Mouse" email is sent with basic sign-up and navigation instructions: a basic "how-to guide"; resource kit is sent to school.
  - d. Personal offer to train educators at the school to use Mouse Create, either remotely or in-person. Note: some in-person training events have occurred in locations away from the metro area. All member schools in the region received personal invitations to attend in-person events.
  - e. Continual email support is provided. Some schools take advantage of this more than others, and for most schools support requests come in waves (i.e., a dozen emails from a school may be responded to in a two-day period, and then nothing for months).
4. Support emails\*: 1,200 (approximate)  
\*Category used to denote instances when member schools reach out to Mouse via e-mail with questions or problems. Educators also have 24-hour access to [help@mouse.org](mailto:help@mouse.org) that is directed to the national headquarters
5. See [Recruitment and Training Engagement](#)
6. The Mouse Learning Design Team has worked to align Mouse content with Minnesota state educational standards. When training Minnesota member schools, our Learning Network manager informed educators about available resources that mapped out adherence to these standards.

## Deliverable F

### *Contractor Duties:*

Provide state, through reasonable efforts, with requested data as needed including, but not limited to:

1. Schools enrolled.
2. Teachers trained.
3. Students enrolled.
4. Students passing competencies.
5. Communications with schools.

### *Actions/Activities:*

1. Current MDE Mouse member school enrollment: 98
2. 166 educators have been trained through Mouse training/onboarding sessions
3. Roughly 857 students have been enrolled so far. However, some schools have elected to use Mouse Create without formally enrolling students. The estimated number of students involved in Mouse in Minnesota should be closer to 1,000.
4. Total number of certifications earned: 130. Students submitted 2,957 pieces of evidence of module completion, making them eligible to earn badges. Teachers need to verify evidence submitted and award the badges to students.

## Deliverable G

### *Contractor Duties:*

Certify students have met informational technology skills and competencies that are recognized by industry.

### *Actions/Activities:*

Mouse badging certifications are recognized by employers, K-12 stakeholders, and universities. Students can earn digital badges for demonstrable skills across competencies learned.

Locally, Mouse has met with (among others) 3M, Advance IT Minnesota, Best Buy, the Minnesota Department of Labor and Industry, the Minnesota High Tech Association, Thompson Reuters, and the University of Minnesota in an effort to increase awareness of the value of Mouse badging certifications. Best Buy has been especially supportive and recognizes Mouse badges when evaluating potential employees.

## Deliverable H

### *Contractor Duties:*

Build sustainability for programs to continue beyond terms of the contract.

### *Actions/Activities:*

Mouse is committed to making meaningful connections with like-minded organizations in Minnesota in order to foster productive collaboration. See [Meetings with Minnesota Organizations](#).

## **Deliverable I**

### *Contractor Duties:*

Enter into a Memorandum of Understanding (MOU) with each school to formalize the membership of the program for each school district.

### *Actions/Activities:*

See the attached copy of the updated Memorandum of Understanding that has been given to all Mouse member schools.

## **Deliverable J**

### *Contractor Duties:*

Provide final report on effectiveness of the contract to MDE no later than June 1, 2017.

### *Actions/Activities:*

A draft of the final report was provided to MDE on May 12, 2017. Final data was not available from Mouse personnel until August 2017. The final update was provided to MDE on August 21, 2017.

# Conclusion

Mouse successfully executed the contract, providing evidence of their work on each stated deliverable. Due to delays in the RFP process, Mouse was awarded the contract in January 2016 which had an impact on their ability to recruit schools. Active recruitment was suspended in January 2017 due to the upcoming end of the contract on June 30, 2017. In just over a year's time, Mouse trained 166 educators and reached an estimated 1,000 students who collectively earned 130 certifications and submitted sufficient evidence of completion for 2,957 modules in STEAM areas.

The response from Minnesota educators using the Mouse online learning platform has been overwhelmingly positive with growing local excitement. That said, the timeframe of Mouse's contract with MDE presented significant challenges. Schools and educators plan curriculum well in advance of the school year, and it was difficult for many to implement Mouse's educational content on short notice. Schools have expressed that they need more time to fully integrate our projects into their classrooms. Many schools started in the 2016-17 school year, and some used access to Mouse's content to plan for implementation during the 2017-2018 school year.

A handful of schools stated they would be interested in using Mouse at a later date, but at the moment were either too overwhelmed or too understaffed. Others cited concerns over the short length and uncertainty of the current contract, and were hesitant to devote time and effort to educational materials they weren't sure would be available in future years. Beyond recruiting and implementation, one and a half years is not enough time to fully evaluate educational outcomes. For future educational initiatives, Mouse recommends a minimum five-year funding allocation: one year to establish a program and four years to carry out/evaluate said program.

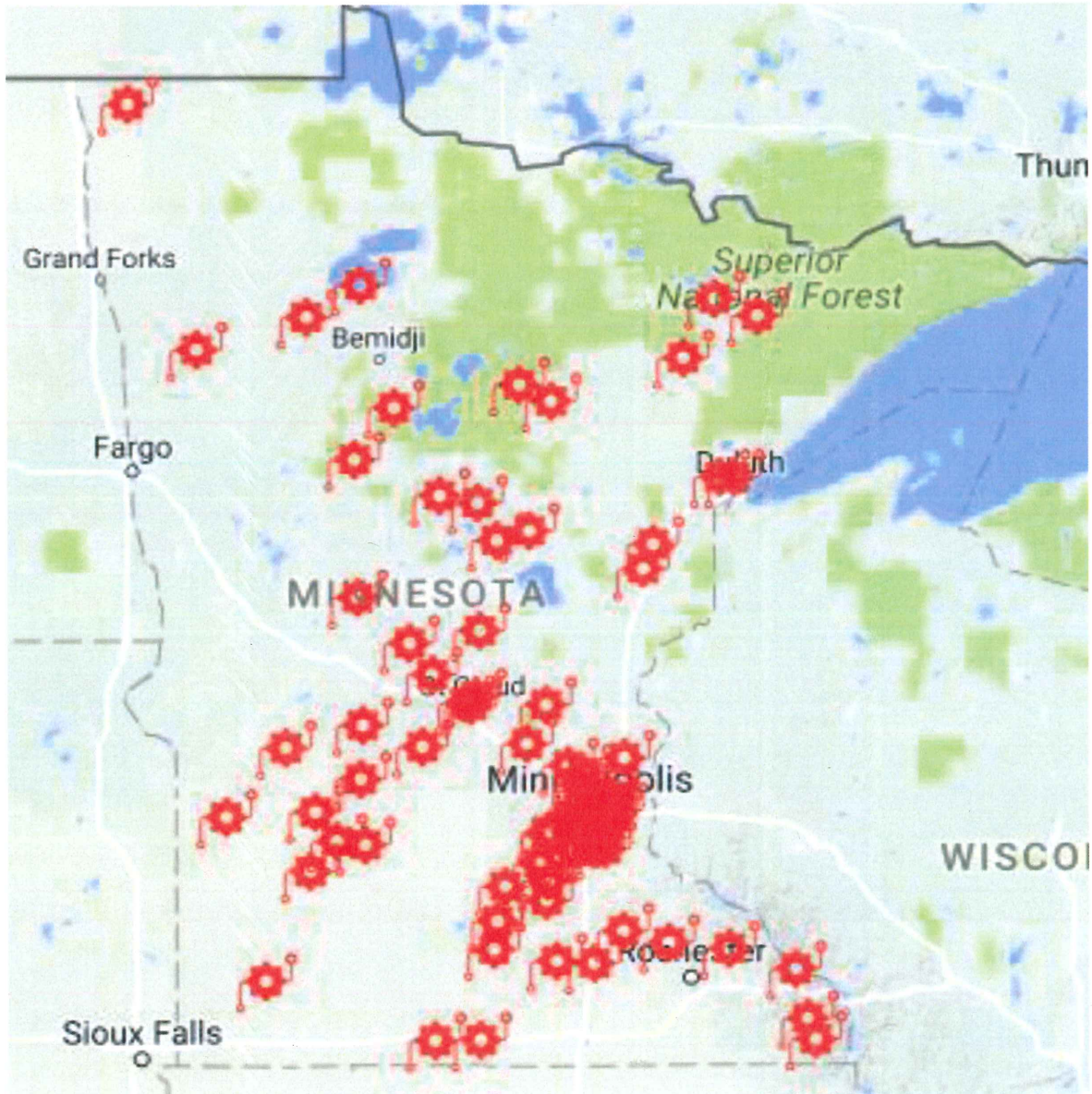
Mouse and its member schools were disappointed to hear that IT certification funding would not continue beyond 2017. Despite this outcome, Mouse remains committed to Minnesota educators and students. They have offered complimentary memberships to 50 Minnesota schools who have demonstrated high engagement and/or a pressing need for IT and STEM education. This model is not sustainable beyond the 2017-2018 school year, but Mouse hopes that complimentary memberships will bridge the gap between school funding cycles and allow administrators to include a Mouse membership in future budget planning.

Because many schools implemented the program without assigning individual student log-ins, the actual number of students participating and completing modules is unknown. Limitations were also found in the process for students to earn certifications via digital badges. Teacher action is required to verify the student's submissions before badges are awarded and many teachers did not take the steps necessary to verify the work and award the badges. Though work was underway to develop pathways to careers based on skills developed through the Mouse content, no pathways were in place for students to "stack" their badges, turning them into credentials which would allow them an expedited path into employment or postsecondary education. Opportunities like these for students remain underdeveloped and need longer-term support before they may be realized.

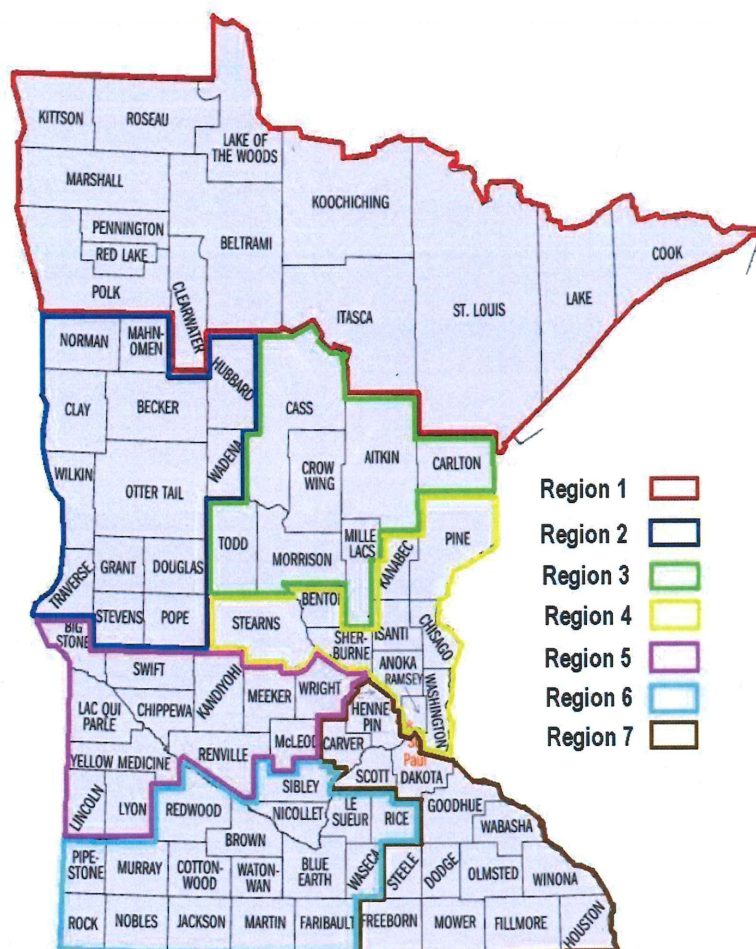
## Recruitment and Training Engagement

All schools received general email outreach providing information about the partnership between MDE and Mouse, what Mouse was and what it would provide to schools, and invitations were sent to attend Informational Sessions through the summer of 2016.

A new round of recruitment, beyond initial emails to all schools, began outreach to individual schools. During the spring of 2016, all schools received personal emails to appropriate representatives, in which the Mouse Minnesota Learning Network manager offered to come out to all schools throughout Greater Minnesota. Beginning in the fall of 2016, phone calls to school administrators were made, inviting schools in the metropolitan region to in-person informational meetings with our Minnesota-based Learning Network manager, or informational sessions for those in Greater Minnesota.

In addition, once schools became member schools, each was offered in-person training/onboarding sessions. All member schools were given multiple offers for onboarding/training sessions.
