A bill for an act

relating to workers' compensation; adopting recommendations of the Workers' Compensation Advisory Council; modifying workers' compensation provisions; modifying hospital outpatient fee schedules; modifying billing, payment, and dispute resolution; defining ambulatory surgical center payments; modifying covered benefits; amending Minnesota Statutes 2016, sections 175A.05; 176.011, subdivision 15; 176.101, subdivisions 2, 2a, 4; 176.102, subdivision 11; 176.136, subdivision 1b; 176.231, subdivision 9; 176.83, subdivision 5; Minnesota Statutes 2017 Supplement, section 15A.083, subdivision 7; Laws 2017, chapter 94, article 1, section 6; proposing coding for new law in Minnesota Statutes, chapter 176.

BE IT ENACTED BY THE LEGISLATURE OF THE STATE OF MINNESOTA:

ARTICLE 1

WORKERS' COMPENSATION GENERAL

Section 1. Minnesota Statutes 2017 Supplement, section 15A.083, subdivision 7, is amended to read:

Subd. 7. **Workers' Compensation Court of Appeals and compensation judges.**

Salaries of judges of the Workers' Compensation Court of Appeals are ~~98.52~~ 105 percent of the salary for ~~district court~~ workers' compensation judges of the Office of Administrative Hearings. The salary of the chief judge of the Workers' Compensation Court of Appeals is ~~98.52~~ 107 percent of the salary for ~~a chief district court judge~~ workers' compensation judges of the Office of Administrative Hearings. Salaries of compensation judges are 98.52 percent of the salary of district court judges.

EFFECTIVE DATE. This section is effective June 1, 2018.

2.1 Sec. 2. Minnesota Statutes 2016, section 175A.05, is amended to read:

2.2 **175A.05 QUORUM.**

2.3 Subdivision 1. **Judges' quorum.** A majority of the judges of the Workers' Compensation
2.4 Court of Appeals shall constitute a quorum for the exercise of the powers conferred and the
2.5 duties imposed on the Workers' Compensation Court of Appeals except that all appeals
2.6 shall be heard by no more than a panel of three of the five judges unless the case appealed
2.7 is determined to be of exceptional importance by the chief judge prior to assignment of the
2.8 case to a panel, or by a three-fifths vote of the judges prior to assignment of the case to a
2.9 panel or after the case has been considered by the panel but prior to the service and filing
2.10 of the decision.

2.11 Subd. 2. **Vacancy.** A vacancy shall not impair the ability of the remaining judges of the
2.12 Workers' Compensation Court of Appeals to exercise all the powers and perform all of the
2.13 duties of the Workers' Compensation Court of Appeals.

2.14 Subd. 3. **Retired judges.** Where the number of Workers' Compensation Court of Appeals
2.15 judges available to hear a case is insufficient to constitute a quorum, the chief judge of the
2.16 Workers' Compensation Court of Appeals may, with the retired judge's consent, assign a
2.17 judge who is retired from the Workers' Compensation Court of Appeals or the Office of
2.18 Administrative Hearings to hear any case properly assigned to a judge of the Workers'
2.19 Compensation Court of Appeals. The retired judge assigned to the case may act on it with
2.20 the full powers of the judge of the Workers' Compensation Court of Appeals. A retired
2.21 judge performing this service shall receive pay and expenses in the amount and manner
2.22 provided by law for judges serving on the court, less the amount of retirement pay the judge
2.23 is receiving under chapter 352 or 490.

2.24 **EFFECTIVE DATE.** This section is effective June 1, 2018.

2.25 Sec. 3. Minnesota Statutes 2016, section 176.231, subdivision 9, is amended to read:

2.26 Subd. 9. **Uses ~~which~~ that may be made of reports.** (a) Reports filed with the
2.27 commissioner under this section may be used in hearings held under this chapter, and for
2.28 the purpose of state investigations and for statistics. These reports are available to the
2.29 Department of Revenue for use in enforcing Minnesota income tax and property tax refund
2.30 laws, and the information shall be protected as provided in chapter 270B.

2.31 (b) The division or Office of Administrative Hearings or Workers' Compensation Court
2.32 of Appeals may permit the examination of its file by the employer, insurer, employee, or
2.33 dependent of a deceased employee or any person who furnishes ~~written~~ signed authorization

3.1 to do so from the employer, insurer, employee, or dependent of a deceased employee.
3.2 Reports filed under this section and other information the commissioner has regarding
3.3 injuries or deaths shall be made available to the Workers' Compensation Reinsurance
3.4 Association for use by the association in carrying out its responsibilities under chapter 79.

3.5 (c) The division may provide the worker identification number assigned under section
3.6 176.275, subdivision 1, without a signed authorization required under paragraph (b) to an:

3.7 (1) attorney who represents one of the persons described in paragraph (b);

3.8 (2) attorney who represents an intervenor or potential intervenor under section 176.361;

3.9 (3) intervenor; or

3.10 (4) employee's assigned qualified rehabilitation consultant under section 176.102.

3.11 **EFFECTIVE DATE.** This section is effective June 1, 2018.

3.12 Sec. 4. **[176.2611] COORDINATION OF THE OFFICE OF ADMINISTRATIVE**
3.13 **HEARINGS' CASE MANAGEMENT SYSTEM AND THE WORKERS'**
3.14 **COMPENSATION IMAGING SYSTEM.**

3.15 Subdivision 1. **Definitions.** (a) For purposes of this section, the definitions in this
3.16 subdivision apply unless otherwise specified.

3.17 (b) "Commissioner" means the commissioner of labor and industry.

3.18 (c) "Department" means the Department of Labor and Industry.

3.19 (d) "Document" includes all data, whether in electronic or paper format, that is filed
3.20 with or issued by the office or department related to a claim-specific dispute resolution
3.21 proceeding under this section.

3.22 (e) "Office" means the Office of Administrative Hearings.

3.23 Subd. 2. **Applicability.** This section governs filing requirements pending completion
3.24 of the workers' compensation modernization program and access to documents and data in
3.25 the office's case management system, the workers' compensation Informix imaging system,
3.26 and the system that will be developed as a result of the workers' compensation modernization
3.27 program. This section prevails over any conflicting provision in this chapter, Laws 1998,
3.28 chapter 366, or corresponding rules.

3.29 Subd. 3. **Documents that must be filed with the office.** Except as provided in
3.30 subdivision 4 and section 176.421, all documents that require action by the office under
3.31 this chapter must be filed, electronically or in paper format, with the office as required by

4.1 the chief administrative law judge. Filing a document that initiates or is filed in preparation
4.2 for a proceeding at the office satisfies any requirement under this chapter that the document
4.3 must be filed with the commissioner.

4.4 Subd. 4. Documents that must be filed with the commissioner. (a) The following
4.5 documents must be filed directly with the commissioner in the format and manner prescribed
4.6 by the commissioner:

4.7 (1) all requests for an administrative conference under section 176.106, regardless of
4.8 the amount in dispute;

4.9 (2) a motion to intervene in an administrative conference that is pending at the department;

4.10 (3) any other document related to an administrative conference that is pending at the
4.11 department;

4.12 (4) an objection to a penalty assessed by the commissioner or the department;

4.13 (5) requests for medical and rehabilitation dispute certification under section 176.081,
4.14 subdivision 1, paragraph (c), including related documents; and

4.15 (6) except as provided in this subdivision or subdivision 3, any other document required
4.16 to be filed with the commissioner.

4.17 (b) The filing requirement in paragraph (a), clause (1), makes no changes to the
4.18 jurisdictional provisions in section 176.106. A claim petition that contains only medical or
4.19 rehabilitation issues, unless primary liability is disputed, is considered to be a request for
4.20 an administrative conference and must be filed with the commissioner.

4.21 (c) The commissioner must refer a timely, unresolved objection to a penalty under
4.22 paragraph (a), clause (4), to the office within 60 calendar days.

4.23 Subd. 5. Form revision and access to documents and data. (a) The commissioner
4.24 must revise dispute resolution forms, in consultation with the chief administrative law judge,
4.25 to reflect the filing requirements in this section.

4.26 (b) For purposes of this subdivision, "complete, read-only electronic access" means the
4.27 ability to view all data and document contents, including scheduling information, related
4.28 to workers' compensation disputes, except for the following:

4.29 (1) a confidential mediation statement, including any documents submitted with the
4.30 statement for the mediator's review;

- 5.1 (2) work product of a compensation judge, mediator, or commissioner that is not issued.
5.2 Examples of work product include personal notes of hearings or conferences and draft
5.3 decisions;
- 5.4 (3) the department's Vocational Rehabilitation Unit's case management system data;
5.5 (4) the special compensation fund's case management system data; and
5.6 (5) audit trail information.
- 5.7 (c) The office must be provided with continued, complete, read-only electronic access
5.8 to the workers' compensation Informix imaging system.
- 5.9 (d) The department must be provided with read-only electronic access to the office's
5.10 case management system, including the ability to view all data, including scheduling
5.11 information, but excluding access into filed documents.
- 5.12 (e) The office must send the department all documents that are accepted for filing or
5.13 issued by the office. The office must send the documents to the department, electronically
5.14 or by courier, within two business days of when the documents are accepted for filing or
5.15 issued by the office.
- 5.16 (f) The department must place documents that the office sends to the department in the
5.17 appropriate imaged file for the employee.
- 5.18 (g) The department must send the office copies of the following documents, electronically
5.19 or by courier, within two business days of when the documents are filed with or issued by
5.20 the department:
- 5.21 (1) notices of discontinuance;
5.22 (2) decisions issued by the department; and
5.23 (3) mediated agreements.
- 5.24 (h) Upon integration of the office's case management system and the department's system
5.25 resulting from the workers' compensation modernization program, each agency will be
5.26 provided with complete, read-only electronic access to the other agency's system.
- 5.27 (i) Each agency's responsible authority pursuant to section 13.02, subdivision 16, is
5.28 responsible for its own employees' use and dissemination of the data and documents in the
5.29 workers' compensation Informix imaging system, the office's case management system, and
5.30 the system developed as a result of the workers' compensation modernization program.

6.1 Subd. 6. Data privacy. (a) All documents filed with or issued by the department or the
 6.2 office under this chapter are private data on individuals and nonpublic data pursuant to
 6.3 chapter 13, except that the documents are available to the following:

- 6.4 (1) the office;
- 6.5 (2) the department;
- 6.6 (3) the employer;
- 6.7 (4) the insurer;
- 6.8 (5) the employee;
- 6.9 (6) the dependent of a deceased employee;
- 6.10 (7) an intervenor in the dispute;
- 6.11 (8) the attorney to a party in the dispute;
- 6.12 (9) a person who furnishes written authorization from the employer, insurer, employee,
 6.13 or dependent of a deceased employee; and
- 6.14 (10) a person, agency, or other entity allowed access to the documents under this chapter
 6.15 or other law.

6.16 (b) The office and department may post notice of scheduled proceedings on the agencies'
 6.17 Web sites and at their principal places of business in any manner that protects the employee's
 6.18 identifying information.

6.19 Subd. 7. Workers' Compensation Court of Appeals. The Workers' Compensation
 6.20 Court of Appeals has authority to amend its rules of procedure to reflect electronic filing
 6.21 with the office under this section for purposes of section 176.421, subdivision 5, and to
 6.22 allow electronic filing with the court under section 176.285. The court may amend its rules
 6.23 using the procedure in section 14.389.

6.24 **EFFECTIVE DATE.** This section is effective June 1, 2018.

7.1 **ARTICLE 2**7.2 **HOSPITAL OUTPATIENT FEE SCHEDULE**7.3 Section 1. **[176.1364] WORKERS' COMPENSATION HOSPITAL OUTPATIENT**
7.4 **FEE SCHEDULE.**

7.5 Subdivision 1. **Definitions.** (a) For the purposes of this section, the terms defined in this
7.6 subdivision have the meanings given them.

7.7 (b) "Addendum A" means the addendum entitled "OPPS APCs for CY 2018," or its
7.8 successor, developed by the Centers for Medicare and Medicaid Services (Medicare) for
7.9 use in the Medicare Hospital Outpatient Prospective Payment System (OPPS) system under
7.10 Code of Federal Regulations, title 42, part 419, as may be amended from time to time.

7.11 (c) "Addendum B" means the addendum entitled "OPPS Payment by HCPCS Codes for
7.12 CY 2018," or its successor, developed by the Centers for Medicare and Medicaid Services
7.13 (Medicare) for use in the Medicare Hospital Outpatient Prospective Payment System (OPPS)
7.14 system under Code of Federal Regulations, title 42, part 419, as may be amended from time
7.15 to time.

7.16 (d) "HCPCS code" means a numeric or alphanumeric code included in the Centers for
7.17 Medicare and Medicaid Services' Healthcare Common Procedure Coding System. A HCPCS
7.18 code is used to identify a specific medical service.

7.19 (e) "Hospital" means a facility that is licensed by the Department of Health under section
7.20 144.50.

7.21 (f) "HOFS" means the workers' compensation hospital outpatient fee schedule established
7.22 under subdivision 3.

7.23 (g) "Insurer" includes workers' compensation insurers and self-insured employers.

7.24 (h) "Services" includes articles, supplies, procedures, and implantable devices provided
7.25 by the hospital with the service. Services are identified by a code described in subdivision
7.26 3.

7.27 Subd. 2. **Applicability.** (a) This section only applies to payment of charges for hospital
7.28 outpatient services if the charges include a service listed in the workers' compensation
7.29 hospital outpatient fee schedule established by the commissioner under subdivision 3. If
7.30 the charges do not include a service listed in the HOFS, payment shall be:

8.1 (1) the liability for each service that is included in the workers' compensation relative
8.2 value fee schedule as provided in section 176.136, subdivision 1a, and corresponding rules
8.3 adopted by the commissioner to implement the relative value fee schedule; or

8.4 (2) the liability as provided in section 176.136, subdivision 1b, paragraphs (b) and (c),
8.5 for each service that is not included in the workers' compensation relative value fee schedule.

8.6 (b) This section does not apply to outpatient services provided at a hospital that is certified
8.7 by Medicare as a critical access hospital. Outpatient services provided by these hospitals
8.8 shall be paid as provided in section 176.136, subdivision 1b, paragraph (a).

8.9 Subd. 3. **Hospital outpatient fee schedule (HOFS).** (a) Effective for hospital outpatient
8.10 services on or after October 1, 2018, the commissioner shall establish a workers'
8.11 compensation hospital outpatient fee schedule (HOFS) to establish the payment for hospital
8.12 bills with charges for services with a J1 or J2 status indicator as listed in the status indicator
8.13 (SI) column of Addendum B and the comprehensive observation services Ambulatory
8.14 Payment Classification (APC) 8011 with a J2 status indicator in Addendum A. The
8.15 commissioner shall publish a link to the HOFS in the State Register before October 1, 2018,
8.16 and shall maintain the current HOFS on the department's Web site.

8.17 (b) The amount listed for each of the procedures in the HOFS as described in paragraph
8.18 (a) shall be the relative weight for the procedure multiplied by a HOFS conversion factor
8.19 that results in the same overall payment for hospital outpatient services under this section
8.20 as the actual payments made in the most recent 12-month period available before the effective
8.21 date of this section. The commissioner must establish separate conversion factors to achieve
8.22 the same overall payment for noncritical access hospitals of 100 or fewer licensed beds and
8.23 hospitals with more than 100 licensed beds. The commissioner shall establish the two
8.24 conversion factors according to the requirements in clauses (1) to (4) in consultation with
8.25 insurer and hospital representatives.

8.26 (1) The commissioner shall obtain a suitable sample of de-identified data for Minnesota
8.27 workers' compensation outpatient cases at Minnesota hospitals for the most recently available
8.28 12-month period. The commissioner may obtain de-identified data from any reliable source,
8.29 including Minnesota hospitals and insurers, or their representatives. Any data provided to
8.30 the commissioner by a hospital, insurer, or their representative under this subdivision is
8.31 nonpublic data under section 13.02, subdivision 9.

8.32 (2) The sample must be divided into a data set for hospitals over 100 licensed beds, and
8.33 100 or fewer licensed beds, excluding critical access hospitals.

8.34 (3) For each data set the commissioner shall:

9.1 (i) calculate the total amount of the actual payments made in the most recent 12-month
9.2 period available before the effective date of this section, adjusted for inflation to July 2018;
9.3 and

9.4 (ii) apply all of the payment provisions in this section to each claim including, as
9.5 applicable, payment under the relative value fee schedule or 85 percent of the hospital's
9.6 usual and customary charge under section 176.136, subdivisions 1a and 1b, to determine
9.7 the total payment amount using the Medicare conversion factor in effect for the OPPS in
9.8 effect on July 1, 2018.

9.9 (4) The commissioner shall calculate the Minnesota conversion factor to equal the
9.10 Medicare conversion factor multiplied by the ratio of total payments under clause (3), item
9.11 (i), divided by the total payments under clause (3), item (ii).

9.12 (c) For purposes of this section:

9.13 (1) the relative weight is the amount in the "relative weight" column in Addendum B
9.14 and Addendum A for comprehensive observation services.

9.15 (2) references to J1, J2, and H status indicators; Addenda A and B; APC 8011; and
9.16 HCPCS code G0378 includes any successor status indicators, addenda, APC, or HCPCS
9.17 code established by the Centers for Medicare and Medicaid Services.

9.18 (d) On October 1 of each year, the commissioner shall adjust the HOFS conversion
9.19 factors based on the market basket index for inpatient hospital services calculated by
9.20 Medicare and published on its Web site. The adjustment on each October 1 shall be a
9.21 percentage equal to the value of that index averaged over the four quarters of the most recent
9.22 calendar year divided by the value of that index over the four quarters of the prior calendar
9.23 year.

9.24 (e) No later than October 1, 2021, and at least once every three years thereafter, the
9.25 commissioner shall update the HOFS established under this subdivision by incorporating
9.26 services with a J1 or J2 status indicator, and the corresponding relative weights, listed in
9.27 the Addenda A and B most recently available on Medicare's Web site as of the preceding
9.28 July 1. If Addenda A and B are not available on Medicare's Web site on the preceding July
9.29 1, the HOFS most recently published on the department's Web site remains in effect.

9.30 (1) Each time the HOFS is updated under this paragraph, the commissioner shall adjust
9.31 the conversion factors so that there is no difference between the overall payment under the
9.32 new HOFS and the overall payment under the HOFS most recently in effect, for services
9.33 in both HOFSs.

10.1 (2) The conversion factor adjustments under this paragraph shall be made separately for
10.2 each hospital category in paragraph (b).

10.3 (3) The conversion factor adjustments under this paragraph must be made before making
10.4 any additional adjustment under paragraph (d).

10.5 (f) The commissioner shall give notice in the State Register of the adjusted conversion
10.6 factor in paragraph (d) no later than October 1 annually. The commissioner shall give notice
10.7 in the State Register of an updated HOFS under paragraph (e) no later than October 1 of
10.8 the year in which the HOFS becomes effective. The notice must include a link to the HOFS
10.9 published on the department's Web site. The notices, the updated fee schedules, and the
10.10 adjusted conversion factors are not rules subject to chapter 14, but have the force and effect
10.11 of law as of the effective date published in the State Register.

10.12 Subd. 4. **Payment under the hospital outpatient fee schedule.** (a) Services in the
10.13 HOFS, and other hospital outpatient services provided with or as part of service in the
10.14 HOFS, are paid according to paragraphs (b) and (c).

10.15 (b) If a hospital bill includes a charge for one or more services with a J1 status indicator,
10.16 payment shall be as provided in this paragraph.

10.17 (1) If the bill includes a charge for only one service with only a J1 status indicator,
10.18 payment shall be the amount listed in the HOFS for that service, regardless of the amount
10.19 charged by the hospital.

10.20 (2) If the bill includes charges for more than one service with a J1 status indicator, the
10.21 service with the highest listed fee in the HOFS shall be paid at 100 percent of the listed fee.
10.22 Each additional service listed in the hospital outpatient fee shall be paid at 50 percent of
10.23 the listed fee. Payment under this clause shall be based on the applicable percentage of the
10.24 listed fee, regardless of the amount charged by the hospital.

10.25 (3) If the bill includes an additional charge for a service that does not have a J1 status
10.26 indicator listed in the HOFS, no separate payment is made for the additional service. Payment
10.27 for the additional service, including any service with a J2 status indicator, is packaged into
10.28 and is not paid separately from the payment amount listed in the HOFS for the service with
10.29 the J1 status indicator. Implantable devices are paid separately only as provided in subdivision
10.30 5.

10.31 (4) The insurer must not deny payment for any additional service packaged into payment
10.32 for a service listed in the HOFS on the basis that the additional service was not reasonably
10.33 required or causally related to an admitted work injury.

11.1 (c) If a hospital bill includes one or more charges for services with a J2 status indicator,
11.2 and does not include any charges for services with a J1 status indicator, payment shall be
11.3 as provided in this paragraph.

11.4 (1) Except for services packaged into an observation service as provided in clause (4),
11.5 payment for each service with a J2 status indicator shall be the amount listed in the HOFS,
11.6 regardless of the amount charged by the hospital.

11.7 (2) If a service without a HCPCS code is billed with a service with a J2 status indicator,
11.8 payment is packaged into the payment for the J2 service.

11.9 (3) Payment for drugs with a HCPCS code is separate from payment for the service with
11.10 the J2 code as provided in this clause.

11.11 (i) If the drug is delivered by injection or infusion, payment for the drug is packaged
11.12 into payment for the injection or infusion service.

11.13 (ii) If the drug is not delivered by injection or infusion, payment for the drug is paid at
11.14 the Medicare Average Sales Price (ASP) of the drug on the day the drug is dispensed. No
11.15 later than October 1, 2018, and October 1 of each subsequent year, the commissioner must
11.16 publish on the department's Web site a link to the ASP most recently available as of the
11.17 preceding July 1. If no ASP is available, the most recently posted ASP linked on the
11.18 department's Web site remains in effect.

11.19 (4) If a bill includes eight or more units of service with the HCPCS code G0378
11.20 (observation services, per hour), and there is a physician's or dentist's order for observation,
11.21 payment shall be the amount listed in the HOFS for the comprehensive observation services
11.22 Ambulatory Payment Classification 8011, regardless of the amount charged by the hospital.
11.23 All other services billed by the hospital, including other services with a J2 status indicator,
11.24 are packaged into the payment amount and are not paid separately from the payment amount
11.25 listed in the fee schedule for HCPCS code G0378.

11.26 (5) For any other service on the same bill as the service with a J2 status indicator, payment
11.27 shall be as provided in subdivision 2, paragraph (a).

11.28 Subd. 5. **Implantable devices.** The maximum fee for any service in the HOFS includes
11.29 payment for all implantable devices, even if the Medicare OPSS would otherwise allow
11.30 separate payment for the implantable device. However, separate payment in the amount of
11.31 85 percent of the hospital's usual and customary charge for an implantable device is allowed
11.32 if the implantable device:

11.33 (1) has an H status indicator in Addendum B;

12.1 (2) is properly charged on a bill with a service with a J1 status indicator in the HOFS;
12.2 and

12.3 (3) is properly billed with another HCPCS code, if required by Medicare's OPPS system.

12.4 The commissioner shall update the HOFS each October 1 to include any HCPCS codes that

12.31 be unreasonably excessive.

13.1 (b) The liability of the employer for the treatment, articles, and supplies that are not
13.2 limited by paragraph (a), subdivision 1a, or 1c, or section 176.1362, 176.1363, or 176.1364,
13.3 shall be limited to 85 percent of the provider's usual and customary charge, or 85 percent
13.4 of the prevailing charges for similar treatment, articles, and supplies furnished to an injured
13.5 person when paid for by the injured person, whichever is lower, except as provided in
13.6 paragraph (e). On this basis, the commissioner or compensation judge may determine the
13.7 reasonable value of all treatment, services, and supplies, and the liability of the employer
13.8 is limited to that amount. The commissioner may by rule establish the reasonable value of
13.9 a service, article, or supply in lieu of the 85 percent limitation in this paragraph. A prevailing

13.23 (f) For purposes of this chapter, "inpatient" means a patient that has been admitted to a
13.24 hospital by an order from a physician or dentist. If there is no inpatient admission order,
13.25 the patient is deemed an outpatient. The hospital must provide documentation of an inpatient
13.26 order upon the request of the employer.

13.27 **EFFECTIVE DATE.** This section is effective for treatment, articles, and supplies
13.28 provided on or after October 1, 2018.

13.29 **Sec. 2. [176.1365] OUTPATIENT BILLING, PAYMENT, AND DISPUTE**
13.30 **RESOLUTION.**

13.31 Subdivision 1. **Scope.** This section applies to billing, payment, and dispute resolution
13.32 for services provided by an ambulatory surgical center (ASC) under section 176.1363 and

14.1 hospital outpatient services under section 176.1364. For purposes of this section, "insurer"
14.2 includes self-insured employer and "services" is as defined in section 176.1364.

14.3 Subd. 2. **Outpatient billing, coding, and prior notification.** (a) Ambulatory surgical
14.4 centers and hospitals must bill workers' compensation insurers for services governed by
14.5 sections 176.1363 and 176.1364 using the same codes, formats, and details that are required
14.6 for billing the Medicare program, including coding consistent with the American Medical
14.7 Association Current Procedural Terminology coding system and Medicare's Ambulatory
14.8 Surgical Center Payment System, Outpatient Prospective Payment System, Outpatient Code
14.9 Editor, Healthcare Current Procedural Terminology Coding System, and the National Correct
14.10 Coding Initiative Policy Manual for Medicare Services and associated Web page and tables.

14.11 (b) All charges for ASC or hospital outpatient fee schedule services governed by sections
14.12 176.1363 and 176.1364 must be submitted to the insurer on the appropriate electronic
14.13 transaction required by section 176.135, subdivisions 7 and 7a. ASCs must submit charges
14.14 on the electronic 837P form. ASCs must not separately bill for the services and items
14.15 included in the ASC facility fee under Code of Federal Regulations, title 42, section
14.16 416.164(a). Minnesota Rules, part 5221.4033, subpart 1a, does not apply to ASCs under
14.17 this section, but does apply to hospital outpatient facility fees to the extent they are not
14.18 covered by the hospital outpatient fee schedule under section 176.1364.

14.19 (c) Hospitals, ASCs, and insurers must comply with the prior notification and approval
14.20 or authorization requirements specified in Minnesota Rules, part 5221.6050, subpart 9. Prior

14.27 and 7a. Copies of any records or reports relating to the items for which payment is sought

14.29 Subd. 3. **ASC or hospital request for reconsideration; insurer response; time frames.**
14.30 (a) Following receipt of the insurer's explanation of review (EOR) or explanation of benefits
14.31 (EOB), the ASC or hospital may request reconsideration of a payment denial or reduction.
14.32 The ASC or hospital must submit its request for reconsideration in writing to the insurer
14.33 within one year of the date of the EOR or EOB.

15.1 (b) The insurer must issue a written response to the ASC or hospital's request for
15.2 reconsideration within 30 days, as provided in section 176.135, subdivision 6. The written
15.3 response must address the issues raised by the request for reconsideration and not simply
15.4 reiterate the information on the EOR or EOB.

15.5 Subd. 4. **Insurer request for reimbursement of overpayment; time frame.** If the
15.6 payer determines it has overpaid an ASC or hospital's charges based on workers'
15.7 compensation statutes and rules, the payer must submit its request for reimbursement in
15.8 writing to the ASC or hospital within one year of the date of the payment.

15.9 Subd. 5. **Medical requests for administrative conference; time frame to file.** (a) An
15.10 ASC, hospital, or insurer must notify the provider or payer, as applicable, of its intent to
15.11 file a medical request for an administrative conference under section 176.106 at least 20

16.8 (b) "Ambulatory surgical center" or "ASC" means a facility that is: (1) certified as an
16.9 ASC by the Centers for Medicare and Medicaid Services; or (2) licensed by the Department
16.10 of Health as a freestanding outpatient surgical center and not owned by a hospital.

16.11 (c) "Conversion factor" means the Medicare ambulatory surgical center payment system
16.12 (ASCPS) conversion factor used for ASCs that meet the Medicare quality reporting
16.13 requirements, whether or not the ASC submitting the bill has met the quality reporting
16.14 requirements.

16.15 (d) "Covered surgical procedures and ancillary services" means the procedures listed in
16.16 ASCPS, addendum AA, and the ancillary services integral to covered surgical procedures
16.17 listed in ASCPS, addendum BB.

16.18 (e) "Insurer" includes workers' compensation insurers and self-insured employers.

16.19 (f) "Ambulatory surgical center payment system" or "ASCPS" means the system
16.20 developed by the Centers for Medicare and Medicaid Services for payment of surgical
16.21 services provided by federally certified ASCs as specified in:

16.22 (1) Code of Federal Regulations, title 42, part 416, including without limitation the
16.23 geographic adjustment for the ASC and the multiple surgical procedure reduction rule;

16.24 (2) annual revisions to Code of Federal Regulations, title 42, part 416, as published in
16.25 the Federal Register;

16.26 (3) the corresponding addendum AA (final ASC covered surgical procedures), addendum
16.27 BB (final covered ancillary services integral to covered surgical procedures), addendum
16.28 DD1 (final ASC payment indicators), and any successor or replacement addenda; and

16.29 (4) the Medicare claims processing manual.

17.1 (g) "Medicare ASCPS payment" means the Medicare ASCPS payment used for ASCs
17.2 that meet the Medicare quality reporting requirements, whether or not the ASC submitting
17.3 the bill has met the Medicare quality reporting requirements.

17.4 Subd. 2. Payment for covered surgical procedures and ancillary services based on
17.5 Medicare ASCPS. (a) Except as provided in subdivisions 3 and 4, the payment to the ASC
17.6 for covered surgical procedures and ancillary services shall be the lesser of:

17.7 (1) the ASC's usual and customary charge for all services, supplies, and implantable
17.8 devices provided; or

17.9 (2) the Medicare ASCPS payment, times a multiplier of 320 percent.

17.10 (i) The amount payable under this clause includes payment for all implantable devices,
17.11 even if the Medicare ASCPS would otherwise allow separate payment for the implantable

17.13 (ii) The 320 percent described in this clause must be adjusted if, on July 1, 2019, or any
17.14 subsequent July 1, the conversion factor is less than 98 percent of the conversion factor in
17.15 effect on the previous July 1. When this occurs, the multiplier must be 320 percent times
17.16 98 percent divided by the percentage that the current Medicare conversion factor bears to
17.17 the Medicare conversion factor in effect on the prior July 1. In subsequent years, the
17.18 multiplier is 320 percent, unless the Medicare ASCPS conversion factor declines by more

17.20 (b) Payment under this section is effective for covered surgical procedures and ancillary

17.22 shall be based on the addenda AA, BB, and DD1 most recently available on the Centers for

17.25 (1) Payment for covered surgical procedures and ancillary services provided by an ASC
17.26 on or after each subsequent October 1 shall be based on the addenda AA, BB, and DD1
17.27 most recently available on the Centers for Medicare and Medicaid Services Web site as of
17.28 the preceding July 1 and the corresponding rules and Medicare claims processing manual.

17.29 (2) If the Centers for Medicare and Medicaid Services has not updated addendum AA,
17.30 BB, or DD1 on its Web site since the commissioner's previous notice under paragraph (c),
17.31 the addenda identified in the notice published by the commissioner in paragraph (c) and the
17.32 corresponding rules and Medicare claims processing manual shall remain in effect.

18.1 (3) Addenda AA, BB, and DD1 under this subdivision includes successor or replacement
18.2 addenda.

18.3 (c) The commissioner shall annually give notice in the State Register of any adjustment
18.4 to the multiplier under paragraph (a), clause (2), and of the applicable addenda in paragraph
18.5 (b) no later than October 1. The notice must identify and include a link to the applicable
18.6 addenda. The notices and any adjustment to the multiplier are not rules subject to chapter
18.7 14, but have the force and effect of law as of the effective date published in the State Register.

18.8 Subd. 3. **Payment for compensable surgical services not covered under ASCPS.** (a)
18.9 If a surgical procedure provided by an ASC is compensable under this chapter but is not

18.17 (2) the payment indicator provides it is contractor priced; or (3) a payment rate is not
18.18 otherwise provided.

18.19 Subd. 4. **Study.** The commissioner shall conduct a study analyzing the impact of the
18.20 reforms, including timeliness and accuracy of payment under this section, and recommend
18.21 further changes if needed. The commissioner must report the results of the study to the
18.22 Workers' Compensation Advisory Council and the chairs and ranking minority members
18.23 of the legislative committees with jurisdiction over workers' compensation by January 15,

18.25 Subd. 5. **Rulemaking.** The commissioner may adopt or amend rules using the authority

18.29 **EFFECTIVE DATE.** This section is effective for procedures and services provided by

19.3 Section 1. Minnesota Statutes 2016, section 176.011, subdivision 15, is amended to read:

19.4 Subd. 15. **Occupational disease.** (a) "Occupational disease" means a mental impairment
19.5 as defined in paragraph (d) or physical disease arising out of and in the course of employment
19.6 peculiar to the occupation in which the employee is engaged and due to causes in excess of
19.7 the hazards ordinary of employment and shall include undulant fever. Physical stimulus
19.8 resulting in mental injury and mental stimulus resulting in physical injury shall remain
19.9 compensable. Mental impairment is not considered a disease if it results from a disciplinary
19.10 action, work evaluation, job transfer, layoff, demotion, promotion, termination, retirement,
19.11 or similar action taken in good faith by the employer. Ordinary diseases of life to which the
19.12 general public is equally exposed outside of employment are not compensable, except where
19.13 the diseases follow as an incident of an occupational disease, or where the exposure peculiar
19.14 to the occupation makes the disease an occupational disease hazard. A disease arises out of
19.15 the employment only if there be a direct causal connection between the conditions under
19.16 which the work is performed and if the occupational disease follows as a natural incident
19.17 of the work as a result of the exposure occasioned by the nature of the employment. An
19.18 employer is not liable for compensation for any occupational disease which cannot be traced
19.19 to the employment as a direct and proximate cause and is not recognized as a hazard
19.20 characteristic of and peculiar to the trade, occupation, process, or employment or which
19.21 results from a hazard to which the worker would have been equally exposed outside of the
19.22 employment.

19.23 (b) If immediately preceding the date of disablement or death, an employee was employed
19.24 on active duty with an organized fire or police department of any municipality, as a member
19.25 of the Minnesota State Patrol, conservation officer service, state crime bureau, as a forest
19.26 officer by the Department of Natural Resources, state correctional officer, or sheriff or
19.27 full-time deputy sheriff of any county, and the disease is that of myocarditis, coronary
19.28 sclerosis, pneumonia or its sequel, and at the time of employment such employee was given
19.29 a thorough physical examination by a licensed doctor of medicine, and a written report
19.30 thereof has been made and filed with such organized fire or police department, with the
19.31 Minnesota State Patrol, conservation officer service, state crime bureau, Department of
19.32 Natural Resources, Department of Corrections, or sheriff's department of any county, which
19.33 examination and report negated any evidence of myocarditis, coronary sclerosis, pneumonia
19.34 or its sequel, the disease is presumptively an occupational disease and shall be presumed
19.35 to have been due to the nature of employment. If immediately preceding the date of

20.1 disablement or death, any individual who by nature of their position provides emergency
20.2 medical care, or an employee who was employed as a licensed police officer under section
20.3 626.84, subdivision 1; firefighter; paramedic; state correctional officer; emergency medical
20.4 technician; or licensed nurse providing emergency medical care; and who contracts an
20.5 infectious or communicable disease to which the employee was exposed in the course of
20.6 employment outside of a hospital, then the disease is presumptively an occupational disease
20.7 and shall be presumed to have been due to the nature of employment and the presumption
20.8 may be rebutted by substantial factors brought by the employer or insurer. Any substantial
20.9 factors which shall be used to rebut this presumption and which are known to the employer
20.10 or insurer at the time of the denial of liability shall be communicated to the employee on
20.11 the denial of liability.

20.12 (c) A firefighter on active duty with an organized fire department who is unable to
20.13 perform duties in the department by reason of a disabling cancer of a type caused by exposure
20.14 to heat, radiation, or a known or suspected carcinogen, as defined by the International
20.15 Agency for Research on Cancer, and the carcinogen is reasonably linked to the disabling
20.16 cancer, is presumed to have an occupational disease under paragraph (a). If a firefighter
20.17 who enters the service after August 1, 1988, is examined by a physician prior to being hired
20.18 and the examination discloses the existence of a cancer of a type described in this paragraph,
20.19 the firefighter is not entitled to the presumption unless a subsequent medical determination
20.20 is made that the firefighter no longer has the cancer.

20.21 (d) For the purposes of this chapter, "mental impairment" means a diagnosis of
20.22 post-traumatic stress disorder by a licensed psychiatrist or psychologist. For the purposes
20.23 of this chapter, "post-traumatic stress disorder" means the condition as described in the most
20.24 recently published edition of the Diagnostic and Statistical Manual of Mental Disorders by
20.25 the American Psychiatric Association. For purposes of section 79.34, subdivision 2, one or
20.26 more compensable mental impairment claims arising out of a single event or occurrence

20.28 (e) If, preceding the date of disablement or death, an employee who was employed on

20.31 medical facility; a public safety dispatcher; an officer employed by the state or a political
20.32 subdivision at a corrections, detention, or secure treatment facility; a sheriff or full-time
20.33 deputy sheriff of any county; or a member of the Minnesota State Patrol is diagnosed with
20.34 a mental impairment as defined in paragraph (d), and had not been diagnosed with the mental

21.11 Subd. 2. **Temporary partial disability.** (a) In all cases of temporary partial disability
21.12 the compensation shall be 66-2/3 percent of the difference between the weekly wage of the
21.13 employee at the time of injury and the wage the employee is able to earn in the employee's
21.14 partially disabled condition. This compensation shall be paid during the period of disability
21.15 except as provided in this section, payment to be made at the intervals when the wage was
21.16 payable, as nearly as may be, and subject to the maximum rate for temporary total
21.17 compensation.

21.18 (b) Temporary partial compensation may be paid only while the employee is employed,
21.19 earning less than the employee's weekly wage at the time of the injury, and the reduced
21.20 wage the employee is able to earn in the employee's partially disabled condition is due to
21.21 the injury. Except as provided in section 176.102, subdivision 11, paragraphs (b) and (c),

21.29 Subd. 2a. **Permanent partial disability.** (a) Compensation for permanent partial disability
