Dear Senators and Representatives:

Minnesota Statutes section 14.116(a) requires each agency to submit by January 15 each year its rulemaking docket maintained under section 14.366, and the official rulemaking record required under section 14.365 for any rule adopted during the preceding calendar year, to the chairs and ranking minority members of the legislative policy and budget committees with jurisdiction over the subject matter of the proposed rule.
