# **Bonding Bill Comparisons**

#### Understanding the Local Impacts of Public Works Legislation Being Considered by the Minnesota Legislature

On January 4, 2017, Governor Mark Dayton released his public works or "bonding" proposal. <u>Governor Dayton's Jobs Bill</u> would build more than 240 urgently-needed infrastructure projects in communities across Minnesota, creating an estimated 22,950 jobs. Two weeks later, on January 19, 2017, the Senate Republican Majority <u>released its proposed</u> <u>bonding bill</u>, and has successfully passed their proposal through an open and transparent committee process.

However, the Republican Majority in the Minnesota House of Representatives has not yet proposed a bonding bill, and has not indicated when they plan to do so. This is similar to what happened last year. During the 2016 Legislative Session, the House Republican Majority did not release its bonding bill until just 5 days before the end of the session (123 days after Governor Dayton had released his). As a result of that delay, there was no opportunity for public testimony or debate on the proposal, and there were numerous mistakes in the bill, including missing projects. Ultimately, the Legislature ran out of time to pass a bonding bill in 2016. Last minute preparation, drafting mistakes, and a lack of public testimony led to only the second time in 30 years that a bonding bill has not been enacted in Minnesota (2016 and 2007).

The following charts demonstrate, by county, which projects are included in Governor Dayton's proposal, the Senate proposal, and the House proposal. It is important to note that there are a number of earmarked transportation projects included in the Senate's bonding proposal. Governor Dayton's proposal does not include many of those earmarks, because he believes transportation projects should be funded with a comprehensive, long-term transportation strategy with dedicated revenues. Filling the bonding bill with transportation projects would crowd out numerous other essential infrastructure improvements that can only be funded through bonding. Therefore, the Governor has proposed a comprehensive transportation solution for roads, bridges, and transit.
