Minnesota School Threats Since Parkland, Florida

Following the school shooting that killed 17 people at Marjory Stoneman Douglas High School in Parkland on February 14, 2018, the number of threats called into schools across the country have surged. In Minnesota, there have been <u>at least 27 threats</u> investigated at schools since February 14. Those threats are outlined below.

ADRIAN PUBLIC SCHOOLS

February 17, 2018

- Adrian Public Schools District reported that a possible nonspecific threat made Feb. 17 on social media prompted immediate local and county law enforcement action.
- According to Adrian Police Chief Shawn Langseth, the threat made by an Adrian student did not specifically identify the school district.

ORONO HIGH SCHOOL

- Police were notified at 10:57 a.m. Wednesday the 21st of threats on Twitter and Facebook that a shooting would happen at noon, Police Chief Correy Farniok said.
- Police determined that both threats originated from inside the high school, which prompted a several-hour school lockdown.
- The suspect was identified and found inside a classroom, as was the student sought for questioning. Neither was armed and no guns were found.
- Authorities on Thursday the 22nd charged an Orono student with threatening on social media to shoot up his school.

CRETIN DERHAM-HALL HIGH SCHOOL

 have a gun, to do harm to other students."
- The school immediately called the police, who opened an investigation. No arrests were made, no immediate threat found, and the school remained open the next morning. The school is handling the matter internally.

- Police and school officials immediately investigated, and a 14-year-old student was arrested and has been kept in custody, pending a court appearance.
- The high school stayed open, all students remained safe.

HILL CITY SCHOOL

- Threats related to an incident that took place the previous week involving a student. The anonymous source or sources of the messages said they were going to come to the school Thursday the 22nd and shoot specific students.
- The district closed the school on Thursday the 22nd, and no official arrests have been made. All students are safe. The incident in Hill City is under investigation by the Aitkin County Sheriff's Office, Hill City police and the Minnesota Bureau of Criminal Apprehension.

- An apparent shooting threat made toward "bhs students" via Snapchat spread rapidly among Brainerd High School students late Thursday the 22nd evening.
- The Brainerd Police Chief called the threat not credible in a 9:30 p.m. news release Thursday night. The Chief said through investigation, law enforcement learned an identical post was received in other areas of the country with schools sporting the same "BHS" initials.
- A student from New Mexico ultimately took responsibility. Brainerd High School remained open the next day. No arrests were made, and all students remained safe. There was an increased presence of police at the school on Friday the 23rd.

- On Friday, February 23rd, St. Francis Area Schools closed all their buildings for the day. It was unclear whether this was a response to the previous week's investigation.
- No violence occurred, and all students stayed home. On Thursday afternoon of the 22nd, the Aitkin County Sheriff's Department arrested two teenage girls in connection to the incident.

- All students remained safe, and school stayed in session. The Chief did not know Friday afternoon if charges would be brought against the juveniles.

- Two juveniles were arrested and charged.

- No students were harmed, and schools remained open on Monday the 26th.
