Fiscal Year 2018 Executive Summary

The Minnesota State Forest Nursery, located ten miles south of Akeley in the Badoura State Forest, sold 3.47 million tree and shrub seedlings in Fiscal Year 2018. This is an increase of approximately 275,000 seedlings from FY2017. Planting on public lands—which include state, county, and federal—accounted for 62.5 percent of total sales, or 2,170,750 seedlings. Private and industrial landowners comprised the remaining 37.5 percent of sales, or 1,306,470 seedlings.

The Nursery performed additional testing following a 2016 *Diploida* outbreak and provided healthy red pine seedlings for sale in FY2018. *Diploida* is a naturally occurring fungus that causes shoot blight and mortality in conifers, especially pines with bunches of needles in twos and threes (ex. red pine).

In FY2018, Nursery receipts totaled \$1,583,790.20 and expenditures totaled \$1,522,103.69 (Appendices 1 and 2). Accounts receivable as of June 30, 2018 totaled \$53,990.35 (Appendix 3). Expenditures were reduced by more than \$400,000 from FY2017 (Appendix 4) by closely monitoring purchases and staffing levels in addition to making cost-effective operational changes. The Nursery will continue reviewing staffing needs and implementing cost saving measures to ensure operational efficiencies.

The Nursery implemented price increases on both seed and seedlings in FY2018. Increases varied by species and quantity ordered. Price changes ranged from one cent (3.5 percent) to 32 cents (33 percent) per seedling. Seed prices for all species except white cedar were increased by 25 percent per pound. In addition, per ounce rates were introduced for small quantities of seed. No price increases are anticipated in FY2019.

In FY2018, the Nursery implemented a new technique for extracting seed from cones and began a significant staff reorganization to reduce costs and fill skill gaps. In FY2019, the Nursery will continue to make changes in operations to increase effectiveness as well as improve energy efficiency.

The FY2018 year-end balance forward in the State Forest Nursery Account is \$1,523,366.68 (Appendix 5). This amount is anticipated to be adequate to maintain the self-sufficiency of the Nursery program in FY2019.

Introduction – State Forest Nursery Program, Division of Forestry

The Minnesota State Forest Nursery program began producing conservation-grade seedlings for reforestation in the early 1930s, with more than one billion seedlings produced and planted by 2009. Through 2018, public land managers and private landowners have purchased and planted more than 1.047 billion seedlings.

Minnesota Statutes, section 89.36, subd.1, requires the Nursery to limit its production to not more than 10 million seedlings each year. In addition to producing seedlings, the Nursery has purchased between 100,000 and one million seedlings each year from private producers for resale. Seedlings purchased from the Nursery must be used to establish or reforest wood lots, windbreaks, and shelterbelts or for erosion control, soil and water conservation, environmental education, or permanent food and cover for wildlife.

State Forest Nursery Mission Statement

Sales and Production Summary, Fiscal Year 2018

In Fiscal Year 2018, the State Forest Nursery shipped 3,477,220 trees and shrubs. Of that number, the Nursery produced 3,297,170 seedlings; 180,050 originated from licensed private producers or trades with other state or federal governments. Tables 1 through 4 and figures 1 through 3 provide detailed information on the Nursery production and sales.



Figure 2: Seedling Distribution



Figure 3: Seedling Types



Basis of Accounting

The State Forest Nursery program is fiscally self-sufficient so that, over time, revenues cover expenditures. The Nursery incurs costs in each year of seedling production. Production can take up to five years for some seedlings, with 70 percent of total production cost incurred in the final year for lifting, packing, and shipping. Fiscal-year sales are defined as the revenues from seedlings *delivered* to customers between July 1 and June 30. Reported fiscal-year costs are the production costs for all of the seedlings in inventory, not just for seedlings that were sold. Additionally, the Nursery purchases a limited number of seedlings for resale from outside sources to create unique wildlife habitat packages or meet demand. A surplus or deficit may occur in a given year but, over time, revenues and expenditures must balance.

The amount of cash receipts in the state accounting system (SWIFT) does not equal sales for the fiscal year. This is because the Nursery does not receive all payments for seedlings sold in the spring by the close of the fiscal year on June 30. Therefore, the Nursery carries a receivables balance into the new fiscal year.

As indicated in state statute, up to \$250,000 per year from the State Forest Nursery Account is available for forestry education and technical assistance.

In FY2018, the State Forest Nursery Account did not expend any monies for forestry education or technical assistance.

Statutory guidance and authority for the Nursery is found in *Minnesota Statutes*, sections 89.35-89.37.


