## Veterans Report to the Legislature

## **Veteran Applicants to Graduate Programs**

The 2013 Legislature adopted the following language which can be found in 2013 Minn. Laws Chap. 99 Art. 2 Sec. 23 Subd. 2a (b):

Minnesota State Colleges and Universities must adopt a policy recognizing for applicants who are veterans, the applicant's veteran status as a positive factor in determining whether to grant admission to a graduate or professional academic degree program. The Board of Trustees must report to the chairs and ranking minority members of the legislative committees and divisions with jurisdiction over higher education policy and finance annually by February 15 on the number of veterans who apply for a graduate or professional academic degree program and the number accepted.

The majority of veterans that apply for admission to graduate programs at the state universities are accepted. There were 118 completed veteran applications to graduate degree programs in fiscal year 2018 and 107 of these were accepted, as shown in Table 1 below. In addition, 25 of 26 veteran applicants to graduate certificate programs were accepted. Veterans also completed applications with the educational intent of completing graduate courses, but not a graduate degree or certificate. All 33 of these applicants were accepted.

Minnesota State Colleges and Universities (Minnesota State) served over 9,200 veterans through instructional programs, veteran-friendly policies and support services during fiscal year 2018. This number represents a 34 percent increase from the 6,900 veterans that were served in fiscal year 2008.

Minnesota State provides veteran-oriented and service member-oriented information, interactive military-to-college tools, and access to military-friendly services and assistance. These resources are made possible by partnerships between Minnesota State and the Minnesota Department of Veterans Affairs Higher Education Veterans Program, the Minnesota National Guard, other branches of the armed services and state and federal agencies. Minnesota State is a Yellow Ribbon company. In addition, 17 state colleges and universities are also designated as Yellow Ribbon companies.
