Subject: Annual Report on Pregnant Female Restraint Reporting as Required by Minnesota Statutes, Section 241.88, Subdivision 3

Dear Governor Walz, Senator Limmer, Representative Mariana, Director Hubinger and Revisor Inman:

Minnesota Statutes, section 241.88, subdivision 3, directs the Minnesota Department of Corrections to report to you by February 15 of each year at local county jails use of restraints on pregnant women, women in labor, and women who have given birth in the preceding three days. The use of restraints does not include use of handcuffs on the front of the body of a pregnant woman.

The Minnesota Department of Corrections reported one (1) occasion where restraints were used on pregnant females.

- 1) Pregnant female turned herself in on warrants. A Detention Deputy (DD) trainee in the independent work portion of the Field Training Officers (FTO) process went to process the female into the jail. The DD in error placed the female into cuffs. Upon entering the jail, her FTO noticed the cuffs and had them removed immediately. Tim in cuffs, about 90 seconds. The issue was addressed as part of the training process.
