## RE: Semi-annual Appointment Report, July 1 – December 31, 2018

The attached semi-annual Appointment Report (required under Minnesota Statutes 43A.04, Subd. 7) shows that there were 5,816 appointments across all job categories July 1 – December 31, 2018. This number represents a 4% increase from the same reporting period last year. The biggest increase in appointments were in Competitive Open with an 10% increase from the prior year. This report only includes appointment types required under Minnesota Statues 43A.04, Sub.7.

An appointment is a count of jobs, not people. This report does not reflect the actual number of new employees hired because one person may have several different types of appointments throughout the reporting period.

The following summarizes the number of appointments filled in the last three years:
