Re: Appropriation transfers report – Fiscal Year 2019

Dear Senators and Representatives:

In accordance with Minnesota Statutes section 15.0395, I am submitting this report to the chairs and ranking minority members of the legislative committees with jurisdiction over state government finance of any appropriation transfers and statutory authority:

- The Campaign Finance and Public Disclosure Board transferred the biennial \$1,020,000 appropriation (Approp ID G9J1ISM) to the state election general fund account (G9J1GEN). The authority for the transfer is Minnesota Statutes section 10A.31, subdivision 4 (b). The funds are used for the general account portion of the public subsidy payment made to eligible state candidates.
- The Board also transferred funds derived from the tax form checkoffs (Approp ID G9J1REV) to the following accounts in amounts over \$100,000. The authority for the transfers is Minnesota Statutes section 10A.31, subdivision 4 (a).
 - \$795,933 to the state election DFL party account (G9J1DFL) for use in public subsidy payments to eligible candidates and to the DFL state central committee.
 - \$358,652 to the state election RPM party account (G9J1RPM) for use in public subsidy payments to eligible candidates and the RPM state central committee.
 - \$163,760 to the state election general fund account (G9J1GEN) for use in public subsidy payments to eligible state candidates.
