## Background

As required by M.L. 2011, First Special Session, Chapter 2, Article 3, Section 2, Subdivision 19 and subsequent appropriations, the Minnesota Land Trust must report annually on the performance of its Stewardship and Enforcement Fund to the Legislative and Citizens Commission on Minnesota Resources.
