Dear Senators and Representatives:

Each year by January 15, Minnesota Statute §14.116 requires the Board to submit its rulemaking docket maintained under section 14.366 and the official rulemaking record required under section 14.365 for any rule adopted during the preceding calendar year, to the chairs and ranking minority members of the legislative policy and budget committees with jurisdiction over the subject matter of the proposed rule.

Our current rulemaking docket is attached and can also be found on the Board's website mn.gov/aelslagid/rulemaking.html. During calendar year 2019, the Board adopted two rule packages.

- Revisor's ID #R-04547 updated a variety of rules in Chapter 1800 regarding direct registration for examinations. The rules were effective on May 13, 2019.
- Revisor's ID #R-04449 updated Chapter 1805: Rules of Professional Conduct. The rules were effective October 21, 2019.

The Board is currently engaged in one rulemaking project with an expected completion date in early 2020.
