Online programs offered

MacPhail's Online School Partnerships (OSP) Program works with schools across Minnesota to offer supplemental music education resources. The partnerships expand and enhance, rather than replace, music learning opportunities provided by public schools, while offering professional development and collegial support to music educators. Programming takes the form of individual lessons, group lessons, master classes, clinics and early childhood music education, depending on the needs identified through each partnership. Having partnered with 15 different organizations throughout Greater MN during the 2019-20 school year, OSP is an innovative, cost-effective response to the needs of communities where instrument or music genre specialists are inaccessible due to geography or location, and the instruction offered by the program is especially well-suited to fill remote education needs caused by COVID-19.

OSP offers exceptional ensemble and individual lessons experiences to engage students over an extended period to increase their proficiency in and understanding of music. MacPhail's 210 teaching artists specializing in 35 instruments and voice are available to online school partners. The roster includes highly credentialed individuals who provide in-depth instruction in flute and clarinet, low brass, double-reed, percussion, voice and jazz styles that would not otherwise be available to residents in the communities served through this grant funding. MacPhail has studied online programs nationwide with leaders in the field, including Manhattan School of Music, New World Symphony, Cleveland Institute of Music and Cowles Center for Dance. We are the only community music school in the country to offer live, sequential online music learning experiences.

Program outcomes

Tools developed in consultation with our partners at Wilder Research continue to be administered by MacPhail teaching artists to set a baseline against which student skills can be evaluated. 68 students have been evaluated through these surveys during the 2019-20 school year, and the survey is specifically designed to measure each student's musical skills, ability to focus, confidence, intonation, technique, rhythm, musical expression, tone quality, and other aspects related to their progress throughout the program. The results of this evaluation will be released sometime in the fall and will be documented in the winter interim report to MDE. Evaluation efforts have been expanded to include our Sing Play Learn early childhood music education in addition to students who were enrolled in OSP through their high school, as well as incorporation of more feedback from music educators at each of the schools.

Students served

OSP served 553 total students throughout Year One of the grant term, having delivered 1,335 hours of total instruction to participants throughout Greater MN. 1,204 of these hours were devoted to high school students via 11 separate partnerships, and 131 of these hours were instruction to Sing Play Learn students (K-5) through 4 separate partnerships. Under the initial application, we predicted outreach to 30 total schools and 1,750 hours of programming during the entire two-year grant term, which we are well on track to exceed.

An estimate of the unmet need for music education

Schools in Greater Minnesota often employ only one music teacher for the entire school—or in some cases, the whole district—which gives neither instructors nor students the flexibility to receive individual and small group lessons. Even in cases where music teachers have enough time and resources to pursue individual and small group instruction, their expertise may vary across multiple instruments. It is under this kind of scarcity that we expect the need for distance learning to remain consistent over the next 12 months of the grant agreement.

However, the aftereffects of COVID-19 have been challenging to partner organizations and OSP alike. State testing data has not been available for many of our partners, and it has been difficult to maintain contact with students throughout Greater MN during school closures, as many families do not have reliable internet access outside of their children's schools. MacPhail had also scheduled teachers to make visits to Kerkhoven-Murdock-Sunburg (KMS) High School and Maynard-Clara City-Raymond (MACCRAY) High School in Greater MN, but those visits had to be canceled due to the pandemic. Additionally, two new school partners secured during the school year were only able to receive 2 hours of instruction each prior to their respective closures. Other partners declined to continue with OSP due to construction at their sites, staff turnover or other reasons. Between the 2018-19 and 2019-20 school years, four SPL partners were unable to sustain partnerships. Despite this, two of our OSP partners are continuing with instruction over the summer, which is not typical and a sign that organizations might see our eLearning expertise as more essential as the pandemic evolves.

Detailed list of expenditures

MacPhail's Administration and Supervision costs remained at \$6,955 throughout each of all four quarters of Year One, as predicted at the outset of the grant. Expenditures for Non-Licensed Classroom Personnel increased in response to the beginning of the school year in early September, growing from \$1,712 in Q1 to \$21,517 in Q2 before decreasing to \$15,885 in Q3 and \$3,821 in Q4. MacPhail instructors categorized under Non-Licensed Classroom Personnel were compensated at an average of approximately \$52 an hour, having completed a total of approximately 820 student contact hours. A further detailed breakdown of hours and wages paid to individual teachers can be provided to the Dept. of Education upon request.

Related changes can be noted in FICA/Medicare costs (\$534 in Q1, \$1,646 in Q2, \$2,408 in Q3 and \$824 in Q4), Health Insurance (\$724 in Q1, \$2,533 in Q2, \$2,412 in Q3 and \$362 in Q4), Tax-Sheltered Annuities/MN Deferred Compensation (\$35 in Q1, \$108 in Q2, \$157 in Q3 and \$54 in Q4), Worker's Compensation (\$35 in Q1, \$108 in Q2, \$157 in Q3 and \$54 in Q4) and Unemployment Compensation (\$14 in Q1, \$43 in Q2, \$63 in Q3 and \$22 in Q4).

Consulting fees of \$10,000 were paid to our partners at Wilder Research during the year for their annual evaluation of Online School Partnership student outcomes. \$840 was attributed to repairs for computers and technology, \$3,350 was allocated to Online School Partnership network fees under the Communication Services line item, and \$1,200 in Supplies & Materials was allocated to instruments, supplies, music and other items for early childhood students. Annual Dues and Memberships totaled \$300 for Year One, and in the Miscellaneous Expenses line item, we attributed \$1,262 to Marketing and Communications, as well as related cultivation costs toward efforts to recruit partners.
