



# Proposed COVID-19 to cities with a population of 500 or more-Corrected

May 28, 2020

Run: aid-HF4673

## Summary

The attached run shows the distribution of \$238,932,175 in COVID aid to cities in Pay 2020 under the HF 4673. The House is proposing sharing a little more than \$667 million of its Federal COVID-19 aid with local governments. The \$667 million is distributed as follows:

- Roughly 15% or \$100 million of the total is reserved for grants to individual local governments based on applications
- The remaining \$567 million is distributed via formula, with 45% of this amount (\$255 million) to cities and towns with a 2018 population of 500 or more; and 55% going to counties that do not qualify for individual federal aid ( all counties except Hennepin and Ramsey\_counties).

Aid to towns with a population of 500 or more is \$25 per capita. The remaining city/town amount is distributed to cities with a population of 500 or more. These cities each get \$51.99 per capita in aid.

The attached run only includes cities with a population of 500 or more and the results are shown on a county by county basis.
