Role of Legislative Fiscal Staff



SENATE COUNSEL, RESEARCH, AND FISCAL ANALYSIS

- Analyze spending and revenue proposals, including modeling of many proposed education and tax law changes.
- Assist committees and members in developing and analyzing budget options.
- Request and interpret Fiscal Notes and Revenue Analysis; interface with state agencies to ascertain information in support of the policy process.
- Draft budgetary legislation.
- Track budget proposals and policy decisions.
- Support legislative oversight of enacted budgets.
- Review federal funds and ITA requests submitted to the Legislative Advisory Commission.
- Respond to requests from individual members needing analysis or information on state budget issues and government finances.
- Fiscal staff organized by legislative jurisdiction




