### **AT A GLANCE**

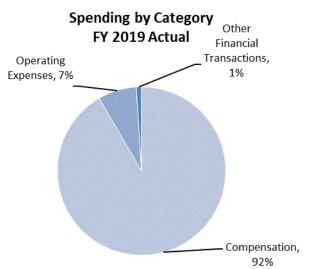
- The Minnesota Board of Private Detective and Protective Agents (MNPDB) currently regulates 352
  individual and corporate Private Detective and Protective Agent licensees
- There are approximately 11,600 security personnel in the State of Minnesota
- The agency's current budget is \$277,000 annually, which allows for 3 FTE's: the Executive Director, an Investigative Analyst, and an Administrative Assistant
- MNPDB certifies 1,472 training courses and 201 instructors
- MNPDB's shareholders include legislators, law enforcement, other state agencies, associations, media, license holders, and the general public

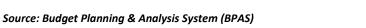
### **PURPOSE**

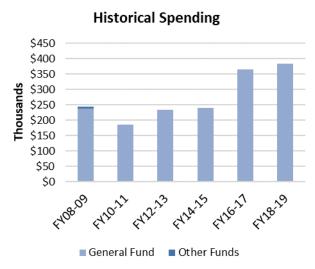
The mission of the Private Detective and Protective Agent Board (MNPDB) is to ensure investigative and security service license holders meet and maintain statutory qualifications and standards. This includes, but is not limited to, meeting criteria in criminal background checks, educational requirements, proof of financial responsibility, and ensuring license holders are acting responsibly and in the best interest of their clients.

With public safety and consumer protection as MNPDB's main guidelines, the agency investigates complaints against license holders, violations of statutes, provides support to law enforcement and the courts in regard to unlicensed activity, police impersonation, and works towards increasing the quality of the industry.

### **STRATEGIES**

The objectives of the Private Detective and Protective Agent Board is to ensure investigative and security service license holders meet and maintain statutory qualifications and ensuring license holders are acting responsibly and for the best interest of their clients. With public safety and consumer protection as our main guidelines the Board achieves these objectives by:

### Regulation

- Collaborating with multiple state and national associations to compare and improve the effectiveness and efficiency of industry standards and the processes by which they are regulated
- Evaluating applications to ensure that those entering a professional practice have the required experience, and have successfully completed a BCA and FBI criminal background check and a thorough open source investigation
- Evaluating license renewals every two years to ensure those already in the professional practice have upheld the industry standards and continue to abide by the Board's statutes and rules
- Evaluating training instructors and course applications to ensure they meet the guidelines and requirements put forth in the Board's statutes and rules, as well as regular audits to ensure continued compliance

#### **Enforcement**

- Investigating complaints and taking action against licensees and unlicensed individuals who violate the Board's statutes and rules which reflect the minimum standards to protect the public
- Removing individuals from practice and issuing penalties when necessary
- Providing public access to license status, discipline history, and the complaint process

### Communication

 Listening to all stakeholders within the industry to formulate language for statutes and rules to ensure they are up-to-date, easily understood by all industry professionals, and remove any unnecessary barriers to licensure

### **Equity**

• The Board's processes provide equitable opportunities for all applicants, trainers and license holders, and constant review of statutes, rules and procedures are part of the Boards internal controls that ensure all are involved in a standardized consistent process

### **Recommendation:**

The Governor recommends additional funding of \$5,000 in FY 2022 and \$11,000 in each subsequent year from the general fund to maintain the current level of service delivery at the Board of Private Detectives and Protective Agents.

This represents a 2.9% increase over the Board's FY 2022-23 general fund base budget of \$544,000.

### Rationale/Background:

The operating increases recommended in FY 2022 and FY 2023 fund a portion of the projected cost increases in the upcoming biennium. Each year, the cost of doing business rises—including growing costs for employer-paid health care contributions and other salary and compensation-related costs. Other operating costs, like rent and lease, fuel and utilities, IT and legal services also grow. This cost growth puts pressure on agency operating budgets that remain flat from year to year without enacted increases.

### **Proposal:**

The Governor recommends increasing agency operating budgets to support the delivery of current services. This funding will cover anticipated employee compensation growth.

#### **Results:**

This proposal is intended to allow the Board of Private Detectives and Protective Agents to continue to provide current levels of service and information to the public.
