





The Fiscal Year 2020 auditors report expresses an unqualified opinion on the General Purpose Financial Statements of the Mid-Minnesota Development Commission.



## **Economic Development**

The MMDC collaborates with regional partners to accomplish goals outlined in our region's Economic Development Administration-approved Comprehensive Economic Development Strategy (CEDS). This can include pursuing funds for infrastructure projects and working to reduce underlying barriers to workforce participation and economic wellbeing (e.g., housing, childcare, and broadband shortages). The MMDC also provides technical assistance and financing to businesses throughout the MMDC Region to preserve and create jobs while supporting the local economy.





#### **Initiatives**

## **Regional Resillence:**

To respond to the COVID-19 Pandemic and to help our region cover from the economic injuries that resulted from it, the U.S. Economic Development Administration (EDA) invited the MMDC to apply for a two-year, \$400,000 grant. We were awarded funds in July and used this new resource to triple the size of our Economic Development Team. Our two new Economic Development Professionals, Rick Bonlender and Michelle Marotzke, are working with businesses, organizations, and communities across our region to improve resilience and make sure our region bounces – not just back, but forward! Since coming aboard they have written successful grant proposals, helped businesses connect with relief opportunities, dug in to improve underlying barriers to regional success (e.g., broadband and childcare gaps) and joined forces with communities to address local concerns. Les Nelson is guiding the department, while also managing the MMDC's two revolving loan funds, including a new \$870,000 fund capitalized as part of the EDA CARES Act. ## **Community Development:**

The MMDC helps communities improve quality of life for their current and future residents. We can partner with our stakeholders in a variety of ways to achieve this on both a local and regional level. We enjoy assisting stakeholders with their development through comprehensive planning, ordinance development, and other traditional means. However, we also love collaborating with those who share our aspiration to address shortfalls, overcome shared barriers, ensure inclusiveness, and encourage growth. We don't think of communities as places, but as people.

## **Transportation Planning**

The MMDC works with communities to address multiple facets of transportation planning to ensure safety and promote healthy living. This includes partnering with school districts and their municipalities to develop Safe-Routes-to-School plans, working with communities to develop trail plans, and collaborating with other local stakeholders to improve walkability/bike-ability. We also provide technical assistance whenever our local communities require guidance or direction on a transportation-related project.

Additionally, the MMDC participates in the Minnesota Department of Transportation's District 8 Area Transportation Partnership (ATP). The work of this group guides the prioritization of construction projects that incorporate the use of federal aid highway, state trunk highway, and federal transit funding. When combined, ATIPs from each of the State's districts create the Statewide Transportation Improvement Program (STIP).



# Mid-Minnesota Regional Transportation Coordination

It is essential that our residents with transportation barriers maintain the ability to fully-participate in education activities, employment, and community life. The MMDC receives funding and guidance from the Minnesota Department of Transportation (MnDOT) and the Minnesota Council on Transportation Access (MCOTA) to work toward improved coordination of transportation services throughout our four-county region. We know that our four counties are fortunate to have numerous, high-quality service providers. However, we also know that these providers are resource-limited and that no one provider or provider type can deliver every needed ride, particularly during the evening, on weekends, or in our more rural areas.

While our Mid-Minnesota Regional Transportation Coordination Council (MMRTCC) program did suffer a setback in 2020, both due to the COVID-19 pandemic and unfortunate staff departures, we did have the good fortune to hire long-time regional resident Terry Smith in late-December. Terry is helping us to get back on track. He is available to meet with individuals or groups, in person or via phonetechnology, to help them navigate public and private transportation options. He is also focused on related activities, such as volunteer driver recruitment and the development and maintenance of a regional Transportation Resource Guide, which will help us increase transportation availability for our non-driving residents so they may continue to live in their own homes or in their other preferred settings.

#### Other 2020 MMDC Project Highlights:

#### **Rural Child Care Innovation Program (RCCIP) Participation:**

Made available through First Children's Finance and funded by the MN Department of Human Services, the RCCIP is an innovative community engagement process designed to address childcare challenges and support rural communities as they develop solutions to increase the supply of high-quality, affordable childcare. MMDC has been an active RCCIP participant in both Kandiyohi and Meeker Counties and, in the fall of 2020, was happy to contribute by bringing the RCCIP program to Renville County as well.





#### **Atwater and Watkins Ordinance Projects:**

In 2020 the MMDC helped the Cities of Atwater and Watkins modernize their respective Codes of Ordinances to address nuisance issues, provide a foundation for more effective code enforcement, and ensure a high standard of living for their residents. We also provided technical assistance to other communities and organizations on specific ordinance and zoning-related issues.

#### **ACGC Safe-Routes-to-School Planning:**

To improve the ability of students and their parents to walk and bike to school, the MMDC partnered with the Atwater-Cosmos-Grove City district, and key leaders from each community to develop a Safe-Routes-to-School Plan. This plan will be used to direct educational activities and guide/prioritize infrastructure improvements for years to come. Funding for this progect was provided by the Minnesota Department of Transportation.



#### Other 2020 MMDC Project Highlights:



#### **Two-Phased Willmar Comprehensive Plan:**

Comprehensive planning is a process that determines community goals and aspirations in terms of community development. The result is a plan designed to express and regulate local policies on transportation, utilities, land use, recreation, and housing. In 2020, the MMDC worked with the City of Willmar's Planning Department to complete Phase 1 (data collection) and begin Phase 2 (plan development) of their new comprehensive plan. While the MMDC's plans are always tailored to meet the needs of each community, we are proud to take part in this ambitious planning project for our region's largest municipality.

#### **Halal-Certified Meat:**

While the MMDC region is home to people from many different cultures, ethnicities, and religions, 2020 provided an opportunity for us to learn that many of our Muslim residents have faced great difficulty when trying to purchase Halal-compliant goat meat. We discovered that most of this cultural staple is imported from Australia, which means that it has often been frozen for six months by the time a family can purchase it. The MMDC is working with local goat producers and processors to address this issue and create a local supply chain for this product. We expect locally-sourced goat to be available for purchase in area stores in 2021.





#### **Hwy 23 Coalition Involvement:**

This coalition was formed to promote highway improvements along the MN State Highway 23 corridor. The MMDC serves as the fiscal agent for the Hwy 23 Coalition and provides staff assistance, via the MnDOT Transportation Planning grant, to support safety and commerce-promoting improvements along Minnesota's second-longest state route.
