

Children screened, diagnosed and treated for autism spectrum disorder

These data, published in compliance with Minn. Stat. 256B.69, Subd. 32a (https://www.revisor.mn.gov/statutes/?id=256b.69#stat.256B.69.32a), show the number of children aged 1 to 6 who received a diagnostic assessment for autism spectrum disorder, the total number of children aged 1 to 6 with a diagnosis of autism spectrum disorder who received treatments and the types of treatments provided to children who were enrolled in a managed-care organization (MCO).

The statute also requires MCOs to report to DHS annually any barriers they encounter in the delivery of these services. Read the calendar year 2019 responses in the <u>2020 Report on barriers</u>, <u>strategies and effectiveness of practices in the identification of children between the ages of 1-3 with symptoms of autism spectrum disorder (PDF) (https://edocs.dhs.state.mn.us/lfserver/Public/DHS-7797B-ENG).</u>

- (a) The commissioner shall require managed care plans and county-based purchasing plans, as a condition of contract, to implement strategies that facilitate access for young children between the ages of one and three years to periodic developmental and social-emotional screenings, as recommended by the Minnesota Interagency Developmental Screening Task Force, and that those children who do not meet milestones are provided access to appropriate evaluation and assessment, including treatment recommendations, expected to improve the child's functioning, with the goal of meeting milestones by age five.

Initiatives to improve early screening, diagnosis, and treatment of children with autism spectrum disorder and other developmental conditions.

- (a) The commissioner shall require managed care plans and county-based purchasing plans, as a condition of contract, to implement strategies that facilitate access for young children between the ages of one and three years to periodic developmental and social-emotional screenings, as recommended by the Minnesota Interagency Developmental Screening Task Force, and that those children who do not meet milestones are provided access to appropriate evaluation and assessment, including treatment recommendations, expected to improve the child's functioning, with the goal of meeting milestones by age five.
- (b) The following information from encounter data provided to the commissioner shall be reported on the department's public Web site for each managed care plan and county-based purchasing plan annually by July 31 of each year beginning in 2014:
 - (1) the number of children who received a diagnostic assessment;
 - (2) the total number of children ages one to six with a diagnosis of autism spectrum disorder who received treatments;
 - (3) the number of children identified under clause (2) reported by each 12-month age group beginning with age one and ending with age six; and
 - (4) the types of treatments provided to children identified under clause (2) listed by billing code, including the number of units billed for each child.

- Treatments for children with a diagnosis of ASD were identified with claims having a procedure code beginning with 908 or equal to H0031, H2012, H2014, H2015, H2019, 99499 (CTSS and other mental health services); having a procedure code of T1013 or T1018 (IEP services); having a procedure code of 0359T, 0362T-0369T, T1024, T1027, H0032 (EIDBI services); or having category of service of 051 (Physical Therapy), 053 (Speech Therapy), or 054 (Occupational Therapy). The service count is the sum of all the unique services for all the children in each respective MCO. These counts were deduplicated using standard DHS procedures.
- All treatment claims were deduplicated using standard operating procedures.

Initiatives to improve early screening, diagnosis, and treatment of children with autism spectrum disorder and other developmental conditions.

- (a) The commissioner shall require managed care plans and county-based purchasing plans, as a condition of contract, to implement strategies that facilitate access for young children between the ages of one and three years to periodic developmental and social-emotional screenings, as recommended by the Minnesota Interagency Developmental Screening Task Force, and that those children who do not meet milestones are provided access to appropriate evaluation and assessment, including treatment recommendations, expected to improve the child's functioning, with the goal of meeting milestones by age five.
- (b) The following information from encounter data provided to the commissioner shall be reported on the department's public Web site for each managed care plan and county-based purchasing plan annually by July 31 of each year beginning in 2014:
 - (1) the number of children who received a diagnostic assessment;
 - (2) the total number of children ages one to six with a diagnosis of autism spectrum disorder who received treatments;
 - (3) the number of children identified under clause (2) reported by each 12-month age group beginning with age one and ending with age six; and
 - (4) the types of treatments provided to children identified under clause (2) listed by billing code, including the number of units billed for each child.

Initiatives to improve early screening, diagnosis, and treatment of children with autism spectrum disorder and other developmental conditions.

- (a) The commissioner shall require managed care plans and county-based purchasing plans, as a condition of contract, to implement strategies that facilitate access for young children between the ages of one and three years to periodic developmental and social-emotional screenings, as recommended by the Minnesota Interagency Developmental Screening Task Force, and that those children who do not meet milestones are provided access to appropriate evaluation and assessment, including treatment recommendations, expected to improve the child's functioning, with the goal of meeting milestones by age five.
- (b) The following information from encounter data provided to the commissioner shall be reported on the department's public Web site for each managed care plan and county-based purchasing plan annually by July 31 of each year beginning in 2014:
- (1) the number of children who received a diagnostic assessment;
- (2) the total number of children ages one to six with a diagnosis of autism spectrum disorder who received treatments;
- (3) the number of children identified under clause (2) reported by each 12-month age group beginning with age one and ending with age six; and
- (4) the types of treatments provided to children identified under clause (2) listed by billing code, including the number of units billed for each child.

- (a) The commissioner shall require managed care plans and county-based purchasing plans, as a condition of contract, to implement strategies that facilitate access for young children between the ages of one and three years to periodic developmental and social-emotional screenings, as recommended by the Minnesota Interagency Developmental Screening Task Force, and that those children who do not meet milestones are provided access to appropriate evaluation and assessment, including treatment recommendations, expected to improve the child's functioning, with the goal of meeting milestones by age five.
- (b) The following information from encounter data provided to the commissioner shall be reported on the department's public Web site for each managed care plan and county-based purchasing plan annually by July 31 of each year beginning in 2014:

Initiatives to improve early screening, diagnosis, and treatment of children with autism spectrum disorder and other developmental conditions.

- (a) The commissioner shall require managed care plans and county-based purchasing plans, as a condition of contract, to implement strategies that facilitate access for young children between the ages of one and three years to periodic developmental and social-emotional screenings, as recommended by the Minnesota Interagency Developmental Screening Task Force, and that those children who do not meet milestones are provided access to appropriate evaluation and assessment, including treatment recommendations, expected to improve the child's functioning, with the goal of meeting milestones by age five.
- (b) The following information from encounter data provided to the commissioner shall be reported on the department's public Web site for each managed care plan and county-based purchasing plan annually by July 31 of each year beginning in 2014:
- (1) the number of children who received a diagnostic assessment;
- (2) the total number of children ages one to six with a diagnosis of autism spectrum disorder who received treatments;
- (3) the number of children identified under clause (2) reported by each 12-month age group beginning with age one and ending with age six; and
- (4) the types of treatments provided to children identified under clause (2) listed by billing code, including the number of units billed for each child.
