Application Evaluation Report

Minn. Stat. §116J.395, subd. 8 requires the Office of Broadband Development to publish an application evaluation report by June 30 of each year. The report is to contain a list of all Border to Border Broadband Development Grant applications received during the previous year and, for each application, the results of any quantitative weighting scheme or scoring system used to award the grants or to rank the applications, the grant amount requested, and the grant amount awarded, if any. The report is to be published on the Department of Employment and Economic Development's website and provided to the chairs and ranking minority members of the senate and house committees with primary jurisdiction over broadband. This report covers the projects funded with the FY21 appropriation.

The information below is provided in compliance with Minn. Stat. §116J.395, subd. 8. In addition to the total score as a factor in determining which projects were funded, those projects which were found to be credibly challenged were not funded (Charter Lake Jessie, Lakeshore, Ridgeview/So. Lake Victoria and Spicer; CTC Franconia and Chisago Lakes Townships; Mediacom Wykoff; Midco Wright County; and SkyNet Co. Rd. 15/Bridgeview) or only partially funded (Arvig Hawley; CTC Borden and Ross Lake; Garden Valley Thief River Falls and Euclid; and Wikstrom Tel. Co. NW MN). Other factors that may have resulted in a higher scoring project not being funded was the recent conclusion of the FCC Rural Digital Opportunity Fund (RDOF) Auction 904 announcing a winner bidder to deploy gigabit speed service in the same or overlapping area; the requirement that the grants be awarded to all areas of the state [Minn. Stat. 116J.395, subd. 6.(c)]; another project for the same or overlapping area was funded instead; or there was insufficient funding available to award to a project so the next smaller project(s) were funded.
