



## YEAR IN REVIEW

### An Extraordinary Year

The work of the Minnesota State Arts Board and Minnesota's regional arts councils—and the individuals, organizations, and communities they serve throughout the state—faced unprecedented disruption during fiscal year 2021 due to the global coronavirus pandemic. The challenges during this time were severe. Extraordinary times called for extraordinary measures, and the Arts Board took bold action to redirect its grantmaking in ways that could best sustain the arts programming and activities that are so vital to the social fabric and economy of our state.

The COVID-19 pandemic arrived quickly in Minnesota, as it did in other states across the nation. The severity of the situation unfolded daily, with individuals and families, businesses and institutions, and communities large and small taking unprecedented steps to protect the health and safety of Minnesotans. COVID caused isolation throughout the state, often making it impossible for arts and other community organizations to serve their functions as connectors, bringing people together to share a common experience. For a time, their creativity and expression were silenced.

For those who work in the arts, as in so many other professions, the financial impacts were immediate. Jobs were lost for both full- and part-time artists, craftspeople, and administrators. With the immediate future uncertain, incomes became uncertain. Families and livelihoods were disrupted, and historic changes played out from day to day. Public agencies were called upon to provide unprecedented support and relief.

With the knowledge that the arts contribute immensely to cities, towns, and communities large and small across our state—both in dollar impacts and in connections between people—the Arts Board adjusted quickly. It shifted project grant dollars into flexible grant programs to help individuals and organizations adapt and sustain what they do and how they do it.

Arts organizations, communities, and individuals also stepped up with their vast creativity, adaptability, and resilience. With the hope that such a test does not arrive again any time soon, it was remarkable to see new ways of doing things, new ways of connecting and touching lives, and new ways of finding hope amid unprecedented challenge.

This report contains highlights and stories of how funds were used to enhance the lives of Minnesota residents and contribute to the health and vitality of their communities. It also includes stories of resilience

that highlight only a few of the ways that grantees used their creativity to keep bringing the arts into the lives of Minnesota residents and communities, at a time when resilience, inspiration, and joy were so deeply needed.

### Grant making

The State of Minnesota appropriated \$40,691,000 to the Minnesota State Arts Board for fiscal year 2021. Of that amount, \$7,541,000 came from the state's general fund and \$33,150,000 came from the state's arts and cultural heritage fund. Due to the uncertainties in the state economy, fourteen percent of the appropriated dollars from the arts and cultural heritage fund (approximately \$4.6 million) was held back and not released to the board until May 2021.

The Arts Board offered four grant programs during fiscal year 2021—its existing Operating Support grant program, two new Creative Support programs to help individuals and organizations adapt and find ways to continue to reach and serve Minnesota audiences and participants despite COVID restrictions, and a special program offered thanks to federal CARES Act funding. In its fiscal year 2021 grant cycle, the board received and reviewed more than 1,480 grant applications and awarded more than 1,200 grants, totaling more than \$36.7 million.

### Creative Support for Individuals

The COVID-19 pandemic brought about profound changes in the ways that Minnesota artists and culture bearers could make work and stay connected to their communities. The purpose of this fiscal year 2021 grant program was to help them adapt to the changing

### The Minnesota Discovery Center

**The Minnesota Discovery Center** (Chislm) developed a series of online videos highlighting regional artists' work, culture, and heritage through virtual art education. The three videos focus on the traditions, history, and techniques of beading, blacksmithing, and weaving. Emmy nominated local filmmaker Matthew Koshmrl filmed the production.

environment in which they work. Grantees were able to use funds to sustain their practice and to stay relevant and connected to their audiences, participants, students, and communities.

Grantees worked in a variety of art forms, including visual and performance mediums, and the work ranged from traditional to contemporary. The following are examples of how fiscal year 2021 funds have been invested through Creative Support for Individuals.

- **Elizabeth J. Belz** of Grand Marais received \$5,992 to explore ways of engaging northern Minnesota communities in the metal arts through the production and distribution of live streams, prerecorded classes, tutorials, and the documentation of student and personal work.
- **Nancy Cook** of Maplewood received \$5,995 to collect poems, messages and writing prompts to send to congregate living residents; provide poetry postcards and cards for residents' use; organize "poetry serenades"; and compile an anthology of works by residents and local poets.

- **Dawn Z. Erickson** of Red Wing received \$6,000 to exhibit "Archive of Observations: Looking Local," a completely new and original collection inspired by Red Wing's historic and natural surroundings. These works exhibited in the windows of the Red Wing Public Library.
- **Timothy C. Takach** of Big Lake received \$5,040 to provide Minnesota schools with music composition distance learning content. He presented online lectures to school-age students throughout Minnesota and provided materials and posted lecture assessments for further engagement.
- **Andrew C. Hellmund** of Saint Peter received \$6,000 for the "Southern Minnesota Sculpture" project, which sought to brighten local communities with sculpture in public spaces that are colorful and vibrant and allow the viewer to ponder, away from the turbulence of the world.
- Composer **James G. Everest** of Minneapolis received \$6,000 to present two free, outdoor public "Sound Garden" installation events combining music, dance, poetry, and visual art into immersive self-guided experiences.
- **Catherine L. Colsrud** of Sandstone received \$5,981 to explore ways of presenting her painting sessions of folk art in an online medium.

- **Saymoukda D. Vongsay** of Saint Paul received \$6,000 to interview Southeast Asiamericans who identify as “motherland orphans” and to work with a dramaturg to develop a new full-length play, culminating in a public online conversation and table reading with Southeast Asian actors.
- **Samuel J. Zimmerman** of Duluth received \$6,000. In collaboration with a native owned publisher, Zimmerman published a bilingual book featuring 60 paintings accompanied with Ojibwe stories in order to preserve and share oral histories of Minnesota north shore communities.
- **Eric L. Altenberg** a Minneapolis artist who is living with Parkinson’s disease, received \$5,952 to continue pushing the limits of his photography and create awareness of the disease. He used grant funds to develop new ways of sharing his work through virtual mediums, as well as creating new work to keep his art alive.
- **Agnes N. Alsgaard Lien** of Rushmore used her \$6,000 grant to prepare at home art kits and art lessons for children in Rushmore, giving students the opportunity to enhance their academic learning through creative projects.

## Creative Support for Organizations

The COVID-19 pandemic brought about profound changes in fiscal year 2021 in the way Minnesota arts organizations operated and served their communities. The purpose of this grant program was to help organizations adapt to this changing environment. The grants provided flexible support so that grantees were able to determine how best to use these funds to stay relevant and connected to their audiences, participants, students, or communities. By leveraging their creativity and community connection, this grant program was intended to assist Minnesota arts organizations in maintaining financial stability and long-term viability. The following are examples of how fiscal year 2021 funds have been invested through Creative Support for Organizations.

- **DalekoArts** of New Prague received \$15,000 to offer Daleko Home Invasion, a full 2020-21 season of virtual theater subscription boxes for audiences to engage with online.
- **Alive & Kickin** of Minneapolis received \$15,000 to deliver virtual programming to help 4,000 older Minnesotans ages 60-99+ combat isolation and loneliness through music participation and social connection.

- **Ely Folk School** of Ely received \$15,000 to develop expanded programming through live, online classes and events combined with safe on-site classes and events to continue to provide arts education to Minnesota residents and communities.
- **The Bach Society of Minnesota** of Saint Paul received \$15,000 to present The Vagabond Series, bringing classical music into people's neighborhoods, living rooms, and local community venues.
- **The Yes Network** of Saint Cloud received \$15,000 to create art experiences for children in low-income neighborhoods to nurture creativity, strengthen social emotional skills, and create a sense of place.
- **Hmong Museum** of Saint Paul received \$15,000 to develop a series of Hmong paj ntaub flower cloth lessons in video format available for download and viewing.
- **Kaddatz Gallery** of Fergus Falls received \$15,000 to expand its reach and maintain connection with community members by developing online and virtual arts education and appreciation, and in person options when it is safe and feasible to do so.
- **Walker Methodist** of Minneapolis received \$15,000 to collaborate with COMPAS to continue professional teaching artist led art residencies, either in person or virtually, for older adults living in six Walker Methodist communities who had been isolated due to COVID-19.
- **Caponi Art Park and Learning Center** of Eagan received \$15,000 to upgrade its website with a multilingual interactive map and guidebook to enhance safe, on-site visitor experiences.
- **Good Samaritan Society-Westview Acres** of Waconia received \$15,000 to deliver artistic programming to elderly and disabled residents in long-term care facilities.

### A Center for the Arts

**A Center for the Arts** (Fergus Falls) wasn't able to work inside in June to do a summer youth theater production. Instead, ACFA went outside to the Fergus Falls YMCA and produced the rehearsed song medley *Showstoppers Review*. This program ran four weeks, and more than 200 youths participated.



- **Twin Cities Jazz Festival** of Saint Paul received \$15,000 to produce a series of weekly livestreaming and community concerts featuring Minnesota based and nationally known artists at Minnesota venues throughout the spring and summer.
- **Heartland Symphony Orchestra** of Little Falls received \$14,268 to continue its mission of providing quality musical experiences to its community, developing a virtual program using previous concerts and new performances that occurred this summer and fall.
- **Matchbox Children’s Theatre** of Austin received \$5,065 to broadcast and livestream four radio entertainment shows in January, February, and March 2021 in coordination with the Hormel Historic Home.
- **Valley Friendship Club** of Stillwater received \$11,690 to give kids, teens, and young adults with disabilities the opportunity to stay connected to the arts through weekly virtual art projects and “The Silent Film Project,” in partnership with The Zephyr Theatre.
- **Mankato and North Mankato ACT on Alzheimer’s** of Mankato received \$15,000. The Singing Hills Chorus brings together people living with Alzheimer’s and other associated dementias, their care partners, and volunteer singers to participate in a choral experience that fosters joy, well-being, purpose, and community understanding.

### Operating Support

These grants provided bedrock support to help many of Minnesota’s finest arts organizations weather the economic turbulence that the pandemic caused.

### Northern Spark

**Northern Spark** (Minneapolis/Saint Paul), the late-night art festival that lights up the Twin Cities, reimaged itself and took new forms in 2021. Northern Spark 2021 invited people to come together in safe, creative, and unconventional ways by engaging with artistic and creative projects online, through the mail, and at smaller in person events in Saint Paul over a span of two weeks from June 12 to 27.

Arts Board support helped numerous organizations retain jobs, adapt their mission driven activities, and maintain some connection to their audiences and participants. This support was especially timely and vital because of the profound uncertainties that COVID caused. This impact included: small organizations such as A Center for the Arts, Fergus Falls, Central Square Cultural and Civic Center, Glenwood, Fairmont Opera House, Fairmont, Giving Voice Initiative, Bloomington, Great River Arts, Little Falls, Honors Choirs of Southeast Minnesota, Rochester, KAIROS ALIVE!, Minneapolis, Rain Taxi Review of Books, Minneapolis, Theatre L'Homme Dieu, Alexandria, Zorongo Flamenco Dance Theatre and School, Minneapolis; midsized organizations such as American Swedish Institute, Minneapolis, Austin Area Arts, Austin, Commonweal Theatre Company, Lanesboro, Great River Shakespeare Festival, Winona, Juxtaposition Arts, Minneapolis, North House Folk School, Grand Marais, TU Dance, Saint Paul, White Bear Center for the Arts, White Bear Lake; and Minnesota's largest institutions including Children's Theatre Company, Minneapolis, Hennepin Theatre Trust, Minneapolis, The Minneapolis Institute of Arts, Minneapolis, and The Saint Paul Chamber Orchestra, Saint Paul.

### MN CARES Act Grants

In March 2020, the U. S. Congress passed the Coronavirus Aid, Relief, and Economic Security Act (CARES Act). The Arts Board received \$464,400 of these federal funds that could be used to support employee salaries, contractor fees, or facilities costs during the pandemic. The following are examples of how fiscal year 2021 funds were invested through MN CARES Act Grants.

- **Pipestone Performing Arts Center** of Pipestone received \$5,000 to engage a passion for the arts in all age groups; strive to make the arts affordable to all; provide opportunities to participate in the arts; and provide a venue for the performance of the arts.

### St. Francis Music Center

**St. Francis Music Center** (Little Falls) was forced to cancel its usual 5 to 6 major concerts, 15 recitals, and other performances. Instead, it held an outdoor concert in May of 2021 including the St. Francis Preparatory and Concert Orchestras, the St. Francis Percussion Ensembles, and the URock bands. The concert took place on the lawn of Linden Hill Historical Estate, and was a welcome celebration of music and community.

## YEAR IN REVIEW

- **Indian Music Society** of Minnesota, in Minneapolis, received \$5,000 to present and promote Indian classical music in Twin Cities, to foster an understanding and appreciation of the rich and ancient cultural heritage of India, and to further fellowship among nations and cultures through music.
- **Bemidji Community Theater** of Bemidji received \$5,000 to provide theater education and an opportunity for people to pursue their interests in theater through acting, directing, and stagecraft support activities in productions by and for community members.
- **Teatro del Pueblo** of Saint Paul received \$5,000 to give voice to the Latinx community through the creation and presentation of performing arts. It supports Latin American work and artists while providing educational opportunities to experience and engage in cross-cultural dialogue.
- **Prairie Renaissance Cultural Alliance** of Morris received \$5,000 to connect its community by creating spaces and opportunities to experience the arts in the Stevens County area.
- **Upstream Arts, Inc.** of Minneapolis received \$5,000 to use the power of the creative arts to activate and amplify the voice and choice of individuals with disabilities.
- **Mankato Children's Chorus** of Mankato received \$5,000 to provide an opportunity for youth to experience the joy of singing while developing healthy vocal techniques. This year, a virtual choir will allow youth to maintain a connection to one another and to choral music.
- **Black Storytellers Alliance** of Minneapolis received \$5,000 to perpetuate, promote, and preserve the art of Black storytelling as an oral tradition and a primary tool for transmitting culture. BSA uses interactive storytelling to educate community members in this art form.

- **Willmar Area Arts Council** of Willmar received \$5,000 to promote and support the arts in west central Minnesota.
- **Northfield Arts Guild** of Northfield received \$5,000 to inspire its community by developing, supporting, and providing quality inclusive artistic opportunities.


### Minnesota's regional arts councils

Together, the Arts Board and Minnesota's eleven regional arts councils ensure that state dollars reach and serve all 87 Minnesota counties. <http://www.arts.state.mn.us/racs/index.htm>

As directed by statutes, the Minnesota State Arts Board makes block grants to regional councils as well as acting as their fiscal agent. During fiscal year 2021, \$11,636,475 was awarded in the form of block grants to the eleven regional arts councils. With these funds, the councils together awarded 1,411 grants and provided services and support tailored to the needs of their geographic regions. Due to COVID-19, councils also shifted some of their grant making to help individuals and organizations adapt to the uncertainty, the isolation, and the financial hardships that artists and arts organizations were experiencing.

A list of the eleven councils, the geographic areas they serve by county, and the amount of their block grants for the fiscal year can be found in "Fiscal Year 2021 Block Grants to Regional Arts Councils" section of this report. The section "Regional Arts Councils Fiscal Year 2021 Summary of Requests and Grants" presents the number of applications received and grants awarded, as well as the total dollars requested and granted, by the regional arts councils in fiscal year 2021.

### Pillsbury House Theater

**Pillsbury House Theater** (Minneapolis) produced its professional actor/youth performer series *The Chicago Avenue Project*, but the 12-play project couldn't be put together in person due to COVID-19. Instead, this community participation project was videotaped against green screens and edited together. The theater is considering using techniques it learned in 2021 moving forward.

### Partnerships | Service | Professional development

The Minnesota State Arts Board expands its capacity and extends its reach by working in collaboration with other agencies and organizations that share similar goals. The pandemic made it very difficult to develop new partnerships, and even to sustain existing ones, however the board remained committed to the following key partnerships during fiscal year 2021.

### Percent for Art in Public Places

Minnesota's art in state buildings statute allows that up to one percent of the total budget appropriated for construction of new or renovated state buildings may be used to purchase or commission works of art. The Percent for Art in Public Places program enacts the legislation established by the Minnesota Legislature in 1984. It operates under the auspices of the Minnesota Department of Administration and is managed by the Minnesota State Arts Board.

### Poetry Out Loud

Poetry Out Loud is a national poetry recitation project cosponsored by the National Endowment for the Arts and The Poetry Foundation. Through Poetry Out Loud, high school students learn about great poetry through memorization, recitation, performance, and competition. Fiscal year 2021 was the sixteenth year that Minnesota has participated in the program.

The Arts Board selected South Central Service Cooperative (SCSC) of North Mankato to manage the Minnesota competition in FY 2021. SCSC is one of nine regional service cooperative agencies in the state. One of its key functions is to engage students and lifelong learners in academic pursuits. SCSC plans and facilitates many student academic enrichment events both regionally and statewide, reaching thousands of students annually. SCSC is well versed in competition procedures that result in fair play, organized and efficient delivery of services, and comprehensive communication to participants.

### Minnesota Conservatory for the Arts

**Minnesota Conservatory for the Arts** (Winona) focused on adaptation and invention. MCA held tap classes outdoors at Levee Park (partnering with the city of Winona, which allowed MCA to use space and sound equipment at no fee). Students' homes were converted into art and dance studios with virtual connections and dance classes indoors were socially distanced and masked.

## YEAR IN REVIEW

With SCSC's leadership and extensive statewide network, emphasis was placed on making the program accessible to students throughout the state despite limitations that existed due to the coronavirus pandemic. Students in forty-four schools participated in the program during the 2020-2021 academic year. Five regional competitions, based on the geographic location of the schools, were held virtually. These were grouped by northern, central, southern, and two metro area regions.

Two students from each region advanced to the state competition which also was held virtually on March 11, 2021. Sophie Kuether, a student at Columbia Heights High School (Columbia Heights), was named Minnesota's Poetry Out Loud champion. Ebba Nordstrom, Washburn High School (Minneapolis), took second place; and Loralai Lewis, Connections Academy (Rochester), and Hanna Olson, Eastview High School (Apple Valley), tied for third place.


Because of the COVID-19 pandemic, the national finals were held virtually in May 2021. Sophie Kuether represented Minnesota in the Poetry Out Loud national finals, competing against state champions from all fifty states, the District of Columbia, Puerto Rico, and the Virgin Islands.

### Improving access for persons with disabilities

The Arts Board continued to provide staff time and resources to support the Minnesota Access Alliance ([www.mnaccess.org](http://www.mnaccess.org)). The Alliance provides information, resources, and professional development opportunities to arts and cultural organizations that seek to learn about and/or expand their own efforts to make the arts more accessible to people of all abilities.

### Statewide arts information

The Minnesota State Arts Board continues to utilize its Web site ([www.arts.state.mn.us](http://www.arts.state.mn.us)) as its primary communications vehicle. The site is designed to be a comprehensive source of information about the Arts Board and about the arts in general.

### Minnesota Opera

**Minnesota Opera** (Minneapolis) adapted by creating *MNiatures* to reach new audiences through digital technology. It took submissions through early November 2020 and debuted the following February. Participants featured composers, lyricists, librettists, songwriters, and others, from those with traditional opera training to those with experience outside the classical artform. Creators worked in teams of two or more to develop an 8- to 10-minute composition.

## A TWENTY-FIVE-YEAR ARTS LEGACY FOR MINNESOTA

### Vision

*In twenty-five years, Minnesotans will have made a significant investment in the arts. As a result ...*

In Minnesota, the arts define who we are. This is a place where people are transformed by high quality arts experiences, and see the arts as essential to their communities. The arts are integrated into all aspects of our lives, connecting people of all ages and cultures, fostering understanding and respect. Arts are broadly understood to mean the products of creative expression produced by professional artists, arts organizations, and the creative expression practiced every day by Minnesotans of all ages, backgrounds, and vocations.

Arts and culture are central to Minnesota's educational system and lifelong learning opportunities. The arts develop creative minds that maximize new opportunities and find solutions to life's challenges.

In Minnesota, the arts industry is an integral part of the economy. Because of the arts, Minnesota communities are successful, dynamic, attractive places to live and work.

Minnesota is a recognized national arts leader. It attracts, nurtures, and sustains creative people and organizations and recognizes them as assets. It is a magnet for arts enthusiasts and a destination for tourists. Residents and visitors are assured a world-class, quality arts experience.

Every Minnesotan appreciates, creates, attends, participates, and invests in the arts. Minnesota's effective, innovative, vibrant, public-private support for the arts is the strongest in the country. Universal support and appreciation for the arts help ensure the state's exceptional quality of life.

## Guiding Principles

Decisions that the Minnesota State Arts Board and the regional arts councils make about how best to use funds will be grounded in the following guiding principles:

- **STATEWIDE APPROACH** – The needs and interests of the entire state will be considered when determining how best to allocate funds.
- **DEMOGRAPHIC AND GEOGRAPHIC FAIRNESS** – Minnesotans of all types, in rural areas and communities of all sizes, will recognize and experience the tangible results of the arts and cultural heritage fund. Special attention will be given to underserved areas or underrepresented groups.
- **COMPREHENSIVE** – A broad, inclusive, evolving definition of art will be used—from indigenous to emerging forms. The full spectrum of arts providers and arts disciplines will be considered when determining how best to serve Minnesotans with these funds.
- **SUSTAINABLE** – Some arts activities are meant to be one-time or short term; others are meant to exist and thrive over time. All are valuable and will be eligible for support. In the latter case, funds will be allocated strategically so that the activity or organization funded can be successful into the future, beyond the life of the arts and cultural heritage fund. Funds also will be used to create a sustainable climate in which artists can live and work.
- **ANTICIPATORY AND FLEXIBLE** – Decisions about how best to allocate funds will be reassessed on a regular basis and will adapt as needs and opportunities change.
- **TRANSPARENCY AND PUBLIC INVOLVEMENT** – Broad public input and engagement in decision making will be vital to produce the outcomes that Minnesotans' expect.
- **ACCOUNTABILITY AND STEWARDSHIP** – Public funds belong to Minnesotans. The Arts Board and regional arts councils will use them in the most effective manner possible and will routinely report the outcomes achieved through the uses of the funds. The board and councils will act with integrity, ensuring that all constituents are treated in an ethical, fair, and consistent manner.

## RULES CHANGES

The Minnesota State Arts Board began a rulemaking process during fiscal year 2021 to amend its existing administrative rules (Minnesota Rules, chapter 1900). The rule amendments are intended to address existing practices and will not substantially change how the board operates.

- The board is considering the adoption of rules to make the Community Arts Education Support pilot grant program permanent, in accordance with the Arts Board's existing rules.
- It is considering adding new definitions or clarifying definitions that would impact eligibility in some of its grant programs. Minnesota Rules, chapter 1900, sections 1900.0110 to 1900.2260.
- The board is considering amendments to rules that govern the board's statutory role as fiscal agent for regional arts councils. The board will use this rulemaking to better align existing rule language with Minnesota Statutes, revise membership in its liaison committee, and change the timeline and requirements that relate to the councils' biennial plans. Minnesota Rules, chapter 1900, sections 1900.2310 to 1900.4110.
- In addition, because rulemaking is conducted only as needed at the Arts Board, the board will use this rulemaking as an opportunity to make other minor changes as needed to clarify existing rules and further the board's mission to stimulate and encourage the creation, performance, and appreciation of the arts in the state.

The board published a request for comments on November 30, 2020. The comment period remained open at the end of fiscal year 2021. The rulemaking process will continue in fiscal year 2022.

## COMPLAINTS / CONCERNS

The Arts Board's received no grant program appeals during fiscal year 2021.


