In the Matter of a Commission Evaluation of Changes to Natural Gas Utility Regulatory and Policy Structures to Meet State Greenhouse Gas Reduction Goals

PUC Docket Number: G-999/CI-21-565

Issue: Initiation of a Commission proceeding to evaluate changes to natural gas utility regulatory and policy structures needed to meet or exceed Minnesota's greenhouse gas emissions reductions goals.

Background:

On June 26, 2021, the Governor signed Minnesota Laws 2021 1st Special Session, Chapter 4, which contains commerce, climate, and energy finance and policy provisions. Article 8, Sections 20, 21, and 27 are sometimes referred to collectively as the Natural Gas Innovation Act (NGIA). Article 8, Section 27, directs the Commission, by August 1, 2021, to initiate a proceeding to evaluate changes to natural gas utility regulatory and policy structures needed to meet or exceed Minnesota's greenhouse gas emissions reductions goals. The Commission has established the docket noted above to carry out this requirement. The Commission will establish the scope and procedures for this matter at a future date.

On Tuesday, August 3, 2021, the Commission will hold a planning meeting to hear a presentation on a July 2021 report: *Decarbonizing Minnesota's Natural Gas End Uses; Stakeholder Process Summary and Consensus Recommendations*, by the Great Plains Institute (GPI) and the Center for Energy and Environment (CEE).
