#### **Executive Summary**

On June 25, 2020, Governor Tim Walz and Lieutenant Governor Peggy Flanagan announced a plan, which was largely based on a previous legislative proposal, to distribute \$841 million of Minnesota's federal Coronavirus Relief Fund (CRF) allotment to local governments to support COVID-19 relief efforts. The Minnesota Department of Revenue received and approved local government certification forms for 85 counties and 1,530 cities and townships. Because they have more than 500,000 residents, Hennepin and Ramsey counties received their CRF distributions directly from the federal government. Twelve cities and 261 towns did not request distributions. Allotted funds were distributed on an ongoing basis starting within two weeks of the plan announcement.

The State of Minnesota distributed \$837,728,966, or 99.5%, of the original allotment to local governments between July 6 and October 16, 2020. The remaining 0.5%, or \$3,735,034, was not requested by local governments and was re-purposed to aid the state's COVID-19 relief efforts.

According to <u>federal guidance</u>, CRF funds may only be used to cover costs that:

- 1. Are necessary expenditures incurred due to the public health emergency with respect to the Coronavirus Disease 2019 (COVID-19)
- 2. Were not accounted for in the budget most recently approved as of March 27, 2020 (the date of enactement of the CARES Act) for the State or government
- 3. Occur during the covered period

Any CRF distribution remaining unexpended on November 15, 2020, by an eligible city or town whose home county is an eligible county, was required to be sent to the city or town's home county by November 20, 2020. Cities and towns within Hennepin or Ramsey counties were required to grant unspent funds to a hospital in their respective county. Any amount remaining unexpended by an eligible county on December 1, 2020, was required to be returned to the State by December 10, 2020. Any unspent funds received by counties on or after December 10, 2020, must also be returned to the State. All returned funds must be used to offset general fund costs of the COVID-19 response as required by 5th Special Session Law Chapter 3, Article 9, Section 12.

#### Status of distributed funds

- As of January 31, 2021, local governments have reported spending a total of \$834,449,280, or 99.6%, of the allocated funds. As of January 31, 2021, 127 local governments have not submitted an accepted final spending report.
- As of January 31, 2021, cities and towns have reported returning \$10,154,562 to counties and \$317,553 to hospitals in Hennepin and Ramsey counties. Counties have returned \$1,137,202 to the State.
- The three largest expenditure categories for local governments are: Payroll for Public Health and Safety Employees, Small Business Assistance, and Budgeted Personnel and Services Diverted to a Substantially Different Use. The total amount spent on these three categories is \$557,029,960, or 67%, of the total spent through the end of the covered period.

#### **Reporting requirements**

- Local governments that received CRF assistance through the State of Minnesota signed a certification
  form agreeing to report their expenses and repay any funds used in a manner contrary to federal or
  state guidance. Local governments were required to submit monthly reports to MMB that included the
  local government's identifying information as well as descriptions of expenses, which were assigned by
  the local government to one of the 18 categories provided by the U.S. Treasury.
- The MMB COVID-19 Response Accountability Office conducted intensive outreach and training to guide
  local governments through the spending and reporting processes. The office provided ten trainings for
  local governments on the reporting process, answered questions related to eligibility, and continues to
  provide ongoing outreach and assistance in complying with the reporting requirements. Reports with
  missing information or errors are returned to the submitting local government for correction and
  resubmission.
- As of January 31, 2021, 92% of the 1,615 local governments that received funds have submitted an
  accepted final spending report to MMB. Appendix B lists all 127 local governments that have not
  complied with reporting requirements.
- The COVID-19 Response Accountability Office targeted direct outreach to those units of local
  government that have not submitted an approved final spending report. On December 17, 2020, there
  were 202 reports missing; on January 31, 2021, there were 127. The COVID-19 Response Accountability
  Office will continue the work to obtain reports from all local governments that received CRF assistance
  from the State of Minnesota.
- Per federal law, any local government that spends \$750,000 or more of federal money within its fiscal year is required to obtain a federal single audit. In Minnesota, these audits are done by the Office of the State Auditor or a CPA firm. The audits are due no later than nine months after the end of the entity's fiscal year. All local governments are subject to a review or audit by the U.S. Treasury Office of the Inspector General. The COVID-19 Response Accountability Office is targeting outreach to all affected local governments to ensure they are aware of and comply with this requirement.

### **Local Government Spending**

The following is aggregate spending data for the 1,488 counties, cities, and towns that submitted an accepted final spending report as of January 31, 2021, as well as 21 local governments that submitted interim reports. Questions about a specific local government's expenditures should be directed to that local government.
