This publication provides a history of how regents have been elected to the Board of Regents of the University of Minnesota since 1989.

The Regent Candidate Advisory Council (RCAC) was established in law in 1988 to assist with the recruitment, screening, and recommendation of candidates to the legislature for the election of regents to the Board of Regents of the University of Minnesota. In 2005, the recommendation process was changed in law to require the RCAC to make recommendations to the governor, who then recommended candidates to the legislature. The governor's role was eliminated by a law change in 2007.

This document summarizes the recommendations of the RCAC, the Joint Legislative Committee, the legislature, and the governor back to 1989, the first year of recommendations by the RCAC.<sup>1</sup>

Four vacancies arose in 2021 due to regular term expirations for Randy Simonson (first district; elected to a partial term 2018), Richard Beeson (fourth district; elected 2009, 2015), Michael Hsu (sixth district; elected 2015), and Thomas Anderson (seventh district; elected 2015). The RCAC began recruiting for the four vacancies in October 2020 and received 20 regent applications by its December 9, 2020, application deadline. The RCAC determined to interview all 20 candidates. One candidate withdrew prior to the interview process, so 19 candidates were interviewed from January 4 to 7, 2021. On January 8, RCAC voted to recommend three candidates for each vacancy (12 candidates total) to the Joint Legislative Committee.

The Joint Committee met on February 23, 2021, to select candidates to recommend to the Joint Legislative Convention. For each seat, the Joint Committee was able to narrow the field to two candidates, but neither was ultimately able to receive majority votes from both the House and the Senate, as Minnesota Statutes, section 137.0246, subdivision 2, paragraph (c) requires. Rules adopted by the Joint Committee anticipated this kind of impasse, and provided that—if deadlocked—the Joint Committee could forward both remaining candidates to the Joint Convention. Accordingly, the Joint Committee forwarded two names for each vacancy.

The Joint Convention convened March 8, 2021. James Farnsworth was nominated on the floor for the fourth district seat. The legislature voted to elect Johnson, Farnsworth, Verhalen, and Huebsch.

On May 13, 2021—in the final weeks of the regular legislative session—Regent Kao Ly ("Ilean") Her died. The legislature did not act to fill the vacancy during the regular or first special legislative sessions. On August 24, Governor Walz appointed Bo Thao-Urabe to fill the vacancy in Regent Her's at-large seat.

Four vacancies arose in 2019 due to regular term expirations for Abdul Omari (student; elected 2013), Linda Cohen (at-large; elected 2007, 2013), Dean Johnson (at-large; elected 2007, 2013), and Peggy Lucas (fifth district; elected 2013). The RCAC began recruiting for the four vacancies in October 2018 and received 47 regent applications by its December 7, 2018, application deadline. The RCAC interviewed 23 candidates over January 7 to 10, 2019, and on January 11, voted to recommend 16 candidates to the Joint Legislative Committee. Kelly Doran withdrew from consideration after being recommended by RCAC, but before the Joint Committee meeting.

The Joint Committee met on February 18, 2019, to select candidates to recommend to the Joint Legislative Convention. At that meeting, the fifth district's legislative delegation recommended incumbent regent Lucas to the fifth district seat. Incumbent student regent Abdul Omari (who had sought election for a non-student seat, but was not recommended by the RCAC) was nominated at the Joint Committee meeting for both the at-large and fifth district vacancies. The Joint Committee voted to recommend Mike Kenyanya for the student seat, Janie Mayron for the fifth district seat, and Mary Davenport for the first at-large seat. For the second at-large seat, the Joint Committee deadlocked between Ilean Her and Sandy Wiese, neither of whom was able to attain the requisite votes. Accordingly, the Joint Committee suspended its rules and voted to forward both candidates to the Joint Convention.

The Joint Convention convened May 9, 2019. Abdul Omari was nominated on the floor for the fifth district seat. For the at-large vacancies, Bill Luther, Dean Johnson, and Peggy Lucas were all nominated on the floor. The legislature voted to elect Mayron, Davenport, Her, and Kenyanya.

### 2018 Notes:

One vacancy arose in 2018 due to the resignation of Patricia Simmons (first district; elected 2003, 2009, 2015). RCAC was not involved in this election. Instead, the Legislative Coordinating Commission collected applications for the vacancy, all of which were forwarded directly to the Joint Committee. The Joint Committee met on May 7, 2018. At that meeting, the Joint Committee deadlocked between Mary Davenport and Brooks Edwards, neither of whom was able to attain the requisite votes. Accordingly, the Joint Committee suspended its rules and voted to forward both candidates to the Joint Convention.

The Joint Convention convened May 10, 2018. Randy Simonson was the only additional nomination on the floor. The legislature voted to elect Simonson to fill out the remainder of Simmons' term, which expires 2021.

Four vacancies arose in 2017 due to regular term expirations for Laura Brod (at-large; elected 2011), Tom Devine (second district; elected 2012), Darrin Rosha (third district; elected 2015), and David McMillan (eighth district; elected 2011). The RCAC began recruiting activities in September 2016, and received 35 regent applications by its December 5, 2016, application deadline, plus one belated application for the eighth district that was accepted because only one other application had been received for that vacancy. The RCAC interviewed 17 candidates from January 4 to 6, 2017, and on January 6, voted to recommend 14 candidates to the Joint Legislative Committee.

The Joint Committee met on February 7, 2017, to select candidates to recommend to the Joint Legislative Convention. The Joint Committee approved new nominations of Steve Sviggum for the second district seat, Becky Hall for the eighth district seat, and Tammy Lee Stanoch for the at-large seat. The Joint Committee voted to recommend Sviggum for the second district seat, Darrin Rosha for the third district seat, David McMillan for the eighth district seat, and Tom Devine for the at-large seat.

The Joint Convention convened February 22, 2017. On the floor, Sandra Krebsbach was nominated for the second district seat, Tom Devine was nominated for the third district seat, and Kendall Powell, Tim Pawlenty, Kent Molde, D'Ann Wilbur, and Arne Carlson were all nominated for the at-large seat. The legislature voted to elect Sviggum, Rosha, McMillan, and Powell.

Five vacancies arose in 2015. One due to the death of David Larson (third district; elected 2005, 2011), and four due to regular term expirations for Patricia Simmons (first district; elected 2003, 2009), Richard Beeson (fourth district; elected 2009); John Frobenius (sixth district; elected 2003, 2009), and Clyde Allen, Jr (seventh district; elected 2003, 2009). The RCAC received 34 regent applications, interviewed 19 candidates, and voted to recommend ten candidates to the Joint Legislative Committee.

The Joint Committee met on February 10, 2015, to select candidates to recommend to the Joint Legislative Convention. Reports were received from the third, fourth, and sixth congressional district caucuses, recommending Darrin Rosha, Richard Beeson, and Michael Hsu, respectively. The Joint Committee approved new nominations of Patricia Simmons and Randy Demmer for the first district seat, and Darrin Rosha and Bill Luther for the third district seat. Becky Hall for the eighth district seat, and Tammy Lee Stanoch for the at-large seat. The Joint Committee voted to recommend Sviggum for the second district seat, Darrin Rosha for the third district seat. Beat, Darrin Rosha for the eighth district seat.

The Joint Convention convened March 4, 2015. On the floor, Darrin Rosha and Bill Luther were nominated for the third district seat, Steve Laraway was nominated for the sixth district seat, and Michael Yost was nominated for the seventh district seat. The legislature voted to elect Simmons, Rosha, Beeson, Hsu, and Anderson.
